A bitter fight has been raging over the community property as Bettis is a wealthy man. Not long ago police officers learned that Mrs. Bettis was in consultation with a suspected crook from the east. They contrived to secrete themselves in the presence of the conspirators and learn their plans. The man agreed to murder Mr. Bettis, and was to be paid five thousand dollars; was to be paid five thousand dollars; two hundred and fifty dollars cash, seven hundred and fifty in ten days, and the remainder to be sent to him on the Isthmus of Panama.
