Deady Allows Immoral Women to Land.

PORTLAND, Or. May 26.—The nine Japanese women who came over on the steamship Pemptos and who were not allowed to land at San Francisco on the ground that they were brought to this country for immoral purposes, were brought before United States Judge Deady today at noon on a writ of habeas corpus.

Arrested for Appearing in Citizen's Clothes.

SAN FRANCISCO, May 26.—Capt. E. L. Zalinski, of the Fifth United States Artillery, stationed at the presidio and the inventor of the Zalinski dynamite gun, has been ordered under arrest for appearing upon the reservation in civilian dress.

Could May Build to Helena.

HELENA, Mont., May 26.—It is reported here that Jay Gould during his coming visit here will look into the matter of extending the Union Pacific system so as to give it direct entrance into Helena over its own lines by way of a new road and the Utah Northern to Poentello.

A Prize Fighter Knocked out to Stay.

LYNN, Mass., May 26.—James Barles, who was knocked out in a battle with Harry Tracy, at Cambridge Monday evening, died this morning. The knock-out blow broke a blood vessel in his brain. Tracy has been arrested on a charge of manslaughter.

Beheaded for Piracy.

SAN FRANCISCO, May 26.—Advices from China state that nineteen Chinese were beheaded by order of the authorities at Knowlan City, April 17th and that nine of them were known to have participated in the Nanca piracy tragedy.

The Governor Won't Have It.

LANSING, Mich., May 26.—The governor has vetoed the bill appropriating \$30,000 for the entertainment of the G. A. R. at Detroit next August.

PRESBYTERIAN ASSEMBLY.

The Reports Show an Increase in Members and Churches.

DETROIT, May 26.—At the morning session of the Presbyterian general assembly the report of the committee on board of home missions was read. The report shows the total receipts for the year to be over \$958,000. One hundred and thirty-five churches were built during the year at a cost of \$425,000 and the church debt paid amounted to \$144,000.

Baptist Missionary Union.

CINCINNATI, May 26.—At this morning's session of the American Baptist Missionary union, work in different missionary fields was discussed. The committee on place and preacher reported in favor of Philadelphia for the next year and Rev. W. W. Boyd of New Jersey as preacher.

He Called the Turn.

TALLAHASSEE, Fla., May 26.—Fifty four votes were cast in joint session of the legislature today for United States Senator. Call received thirty and was declared elected.

O'Shea Gets an Absolute Divorce.

LONDON, May 26.—The decree of divorce obtained by Captain O'Shea from his wife, on account of alleged adultery with Farnell, was today made absolute.

Illinois Goes a Million on the World's Fair.

SPRINGFIELD, Ill., May 26.—The World's fair bill this morning passed the senate with a million dollars appropriation.

A Lively Blaze.

MARTINEZ, Calif., May 26.—An incendiary fire at Crockett, Calif., last night destroyed property to the value of \$50,000. Insurance, \$20,000.

THE GAME WAS STOPPED.

The Police Prevent Sunday Ball Playing in Cincinnati.

CINCINNATI, Ohio, May 23.—Over 2000 people paid admission to the Association ball grounds today. Each one on entering received a ticket, containing an order for a refund of their admission fee if the game was prevented by police interference.

Forced to Run to Save Their Lives.

CHICAGO, May 24.—Between four and five thousand excursionists from this city, who went to Calumet heights in a special train their intention to look at suburban lakes, were compelled to run for their lives before a prairie fire, which formed a sheet of flame half a mile wide. Men, women and children jostled each other in their wild flight.

Peddled Without a License.

DUBUQUE, Ia., May 24.—In the district court yesterday Judge Linehan made an important decision under the interstate commerce law. Fred Baker was selling goods by samples to deliver the same from Minneapolis. He was arrested, fined and imprisoned for peddling goods without a license, as provided by the city ordinance.

Because of a Wife's Infidelity.

CALEBA, Ala., May 24.—Last night Sam Ingram and Joe Allen, prominent farmers, met in the road and opened fire on each other. Allen was soon joined by his brother, Bob, and Ingram by his father and three brothers. In the battle with knives and pistols which followed, Fred Ingram, Henry Alexander, Joe Allen and Bob Allen were fatally wounded. The trouble grew out of intimacy between Sam Ingram and Joe Allen's wife.

Stanford the Standard-Bearer.

NEW YORK, May 24.—A special from Washington to the Recorder says: "The leaders of the third-party movement here profess to have direct assurance that Senator Stanford, of California, is ready to put himself at the head of their movement, with all that is therein implied, and that he will be the standard-bearer of the alliance of people's party in 1892. Some of the alliance leaders claim to be authorized to make public the alleged fact that Senator Stanford considers he holds the great fortune simply as 'steward for these people.'"

OTHER CRIMINAL NEWS.

Because She Deserted Him He Killed Her.

RIO GRANDE CITY, May 24.—Decrato Medina killed his wife yesterday and escaped to Mexico. He swam the river amid a shower of bullets. Two weeks ago his wife deserted him, and a soldier at the barracks was supposed to be the cause of it. Yesterday Medina walked into the house and found his wife arranging a basket of flowers, and reproaching her, began to play with her hair, when suddenly he drew a dirk, reached over her shoulder and stabbed her to the heart. She had two children and was a beautiful woman of the Spanish style.

A New Question in Indiana.

INDIANAPOLIS, Ind., May 24.—By the unanimous opinion of the full bench of the superior courts yesterday, all the suits against S. J. Brown on the ground of the falling of his building, in which thirteen firemen lost their lives, were thrown out of court. The court holds that the owner of the building could not be held responsible for the accident, and that there was no cause for action on the part of the sufferers against him. The question is a question is a new one in this state and will likely go to the supreme court.

Cannot Discuss the Question.

ST. PAUL, Minn., May 24.—Sidney M. Owen, the Minnesota alliance candidate for governor, although an enthusiastic third party man, said last night that he could not endorse the Cincinnati platform. He said: "I am in favor of government ownership and operation of the railroads. I am also a believer in a bi-metallic currency, but I don't believe in fiat money or the sub-treasury scheme."

Declared in Favor of Dr. Briggs.

CHICAGO, May 24.—The Rev. Dr. John H. Barrows, of this city, decided today for Professor Briggs. Dr. Barrows, who is one of the best-known Presbyterian divines of the West, said if the Presbyterian confession of faith is too narrow to receive the great controversialist, it ought to be broadened. The statement was made by Dr. Barrows in the First Presbyterian church before a large congregation, and attracted marked attention.

A Cruiser to Be Built for Japan.

SAN FRANCISCO, May 24.—The Call says representatives of the Japanese government have been negotiating with the Union Iron Works, of this city, for the construction of a torpedo cruiser, and have just sailed for home for the purpose of getting final instructions before making the award. Henry T. Scott, of the Union Iron Works, said no contract had been let, but he refused to discuss the matter further.

Wire Finer Than Hair.

We are at work just now on some pretty small wire. It is 1-500th of an inch in diameter—finer than the hair on your head, a great deal. Ordinary fine wire is drawn through steel plates, but that wouldn't do for this work, because the hole would wear away ever so little it would spoil the job. Instead, it is drawn through what is practically a hole in a diamond, to which there is, of course, no wear. These diamond plates are made by a woman in New York, who has a monopoly of the art in this country.
