Contents of the Hopewell Mounds. The report of the exploration of the Ohio mounds by the World's Columbian expedition survey, under the direction of Professor F. W. Putnam, the field work being in charge of Warren K. Moorehead, says there were 26 mounds in the group, of which 15 were explored. There were found 7,232 flint disks, a 16-pound ax, 1 Pacific coast stone bowl, 7 platform pipes, 27300 sheets of mica, 7 by 8 to 12 by 15 inches; 50 copper spoon shaped objects, 5,000 beads, 900 pearls; 10 altars, some of which were taken out entire; 500 wolf, bear and panther tracks and 120 human skeletons, besides a vast number of miscellaneous objects. -American Antiquarian.
