**Big End Foremost.**

Why is a fish larger at the front end than at the rear end of its body? There is probably more than one cause for this peculiarity of structure, but a possible special reason has been suggested by photographic study of the motion of liquids disturbed by obstacles of various shapes. It has been found in this way that when water flows past an obstacle shaped like a fish, no eddies are formed when the blunt end of the object meets the current, while the water is greatly disturbed when the acute end is presented toward the stream. So it would seem that the fish has at least one good reason for being born with its head on the blunt end of its body.—Youth's Companion.
