THE DALLES OREGON

A Queer Legal Document.

One of the most remarkable legal papers on file in the archives of the world is one now in the national museum of Paris labeled "Sentence on a hog, executed by justice, in the copyhold of Clarmont-Avin, and strangled upon a gibbet at that place." It is sealed with red wax, kept under a glass case, bears date June 14, 1491, and reads as follows: "We, the jury, in detestation and horror of this crime, and in order to make an example and so satisfy justice, have declared, judged, sentenced, pronounced and appointed that the said hog, now detained in the abbey as a prisoner, shall by the executioner be hung and strangled on a gibbet, near the gallows which stands within the jurisdiction of the monks whose names are hereto appended, being near the copyhold of Avin. In witness of which we have sealed this present with our seals." Following the above are the signatures of the jurors and the prefect of the department de l'Ainse.

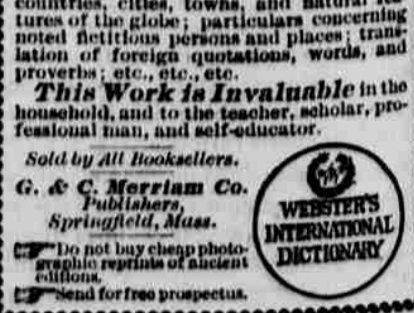
