Fight of Railroads.

OMAHA, Jan. 2.—There is going to be an all-round fight for the Oregon Short Line and Utah, Northern, the receivers of the Union Pacific having about made up their minds to contest the applications of the American Loan and Trust Company for a separate receiver. There will be a meeting of the receivers in New York next Tuesday, at which time a plan of action will be decided upon. General Solicitor Thurston will probably go on to New York in order to attend the meeting, and will possibly represent the receivers when the application is taken up before Judge Gilbert on January 15. It is also thought that the attorney general will intervene on the ground that the loss of the Short Line to the Union Pacific would depreciate the second mortgage the government holds on the overland property.

With the filing of the application on the part of the consolidated mortgage bondholders for a separate receiver, five distinct suits have been commenced by the mortgage interests in the Short Line property. Four of these interests have been satisfied with the appointment of the present receivers of the Union Pacific, and it is not likely that the American Loan and Trust Company, which is thought to be hostile to the present management, will be able to change existing conditions. For a time it looked as if the Short Line would be allowed to drift away without a struggle, but now, however, the line of battle is forming and the American Loan and Trust Company will have a good sized fight on its hands.
