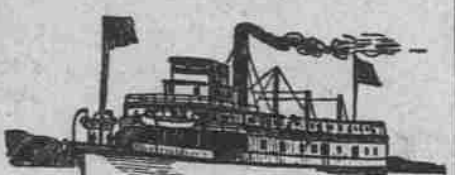
In the Circuit Court of the State of Oregon for Wasco County: Caleb Brooks, Plaintiff, vs. Georgiana A. Brooks, Defendant.
