It is remarkable because it is the only case in the history of this country, where capital and labor have clashed, and that has been brought before the United States courts for abjudication, but that the courts have found some loop-hole for the corporations to erawl through, and some meshes in the legal net, small enough to catch every laborer. It was so in Chicago, where Debs and all his side were prosecuted and the railroad managers let go unscathed and unquestioned.

Judge Gaynor, in a few brief sentences, lavs down more law and common sense at the same time than is often yoked together. The railroad companies appeal to the court, and allege that they cannot run their cars, because their employes are demanding exorbitant wages. The judge tells them that he is not on the bench for the purpose of fixing a men; that the question of wages is between the companies and the men, and each has a right to do as well as they can, and make the most of the situation ; his duty is simply to enforce the law, and either compel the companies to run fourteen hours a day, for \$2. The com- \$1.00. panies want them for less, and as they can't get them, undertook to rob the men of their wages by docking them for every moment they were not on the rails. This would have saved the companies \$180,000 a year. In trying to get this amount they have already cost the city and the state over \$1,000,000, and in the loss by the paralysis of business and indirectly the cost has probably been three times that sum. As is usually the case, the companies looked only at their side of the case in this fight and ignored the rights of the men, and what was equally as bad, the rights of the marble. public.


