This is a peculiar reason for a criminal act. Of course we are not informed as to the Oregon City congregation alluded to, but if the only thing left to do when one cannot get into the pulpit of that church is to rob a bank, it doesn't speak well for the high moral pinnacle upon which that church rests. Of couse the congregation aforesaid are not responsible for their former pastor's shortcoming, and the charitable view of the situation is that instead of being but a lesser degree of crime to rob a bank than to preach in Oregon City, which Rev. Reed's statement would imply, the truth is that instead of descending but a step, that Mr. Reed went to the opposite extreme.

The planning of the robbery and the attempted execution of it do not mark Mr. Reed as a knave. His actions in leaving for the East a few years ago. coupled with his bank-robbing experience, have not a criminal brand. Indeed they are not brands at all, but sim ply ear-marks, and the ear-marks identify him as an ass.
