

The Canal Commissioners.

New York, May 6.—The commission appointed some time ago by the president to examine the plans and route of the Nicaragua canal left for Mobile, Ala., last night.

There were in the party the commissioners, Colonel Ludlow, U. S. A., Commodore Endicott, of the navy, and Alfred Noble, and Assistant Engineers Davis, Wood, Stamford and Parke, of the navy, who will verify the surveys.

A stenographer and a cook accompany the party, and Naval Surgeon Stitt went along to look after the health of everybody connected with the expedition.

Mr. Noble said it was expected that the Montgomery would land the commission at their destination by May 12, and that fully two months would be required to do the proposed work.

The party will reach Mobile on Tuesday and will at once go aboard the cruiser Montgomery and proceed to Greytown.
