## ROBBERS CAPTURED

Two Men Suspected of the Southern Hold up.

BOTH HAVE BAD RECORDS

The Story of Bismarck's Illness Denied  
—A Chicago Building Fired Three Times.

ROSEBURG, Or., July 5.—George K. Quine, of Riddle, who has been in pursuit of the robbers who looted the Oregon express in Cow Creek canyon Monday night, last night arrested, about 10 miles above Canyonville and brought to Riddle and placed under charge of Deputy Sheriff Shambrook two men named Pool and John Case, alias McDorrell, under suspicion of robbing the train.

Case, alias McDowell, was convicted here two years ago for burglary, and returned from the penitentiary a short time since.

Pool has served three times in the penitentiary. He was convicted in Idaho for horse-stealing, and was afterwards brought here and tried for the murder of McNiel, of Elk Creek, this county. He was convicted of manslaughter and served time in the penitentiary until the supreme court reversed the decision. The next grand jury failed to find a true bill on account of the death of important witnesses. He was again convicted of obtaining money under false pretenses, and served his time. The third time he was sent up for cattle-stealing. A warrant is now in the hands of the sheriff for Pool's arrest for cattle-stealing. Three of the same family are under indictment for the latter offense, one of whom is Albert Pool, who was brought from Riddle and lodged in jail here last night. Pool and Case are first cousins.

District Attorney G. M. Brown will proceed to Riddle today to hold the preliminary examination. Mr. Brown prosecuted and convicted both Case and Pool formerly. Two United States detectives arrived in Riddle on last night's northbound overland.

### ATTEMPTED ARSON.

A Chicago Building Fired Three Times in Three Hours.

CHICAGO, July 5.—Three unsuccessful efforts have been made within three hours to burn the Mecca apartment buildings, the big flats occupying the entire block at Thirty-fourth and State streets. The greatest excitement prevailed among occupants of the building and crowds of people gathered in the street to watch the firemen.

The first fire was in the basement, but promptly worked by the department prevented further damage than was caused by smoke.

The firemen had only just returned to their houses when another alarm came in from same quarter. The second fire was found in the basement also. Men, women and children ran through the halls and into the street terror-stricken, but the quick work of the firemen reassured them, and they returned to their abodes. After the first attempt the police were summoned, and it was while they were being assigned to their places that the second fire broke out.

Two hours later another alarm was sent in. This time the fire was on the north end of the building. The firemen, however, were at the building in a jiffy and the blaze was extinguished. A search disclosed the fact that inflammable material has been placed in several parts of the building, and the attempt at arson was so plain that Lieutenant Bonfield sent a large detail of police to guard the building all day. The affair will be investigated.

### Bismarck Denies It.

New York, July 5.—The Herald this morning says: A gentleman in New

York, who is a personal friend of Count Herbert Bismarck, cabled an inquiry as to the truth of the rumors respecting Bismarck's health. To this inquiry Count Herbert replied as follows:

"FRIEDRICHSTADT, July 4.—Reports are false. The prince's health is better than usual. BISMARCK."

### The Fourth in Mexico.

CITY OF MEXICO, July 5.—The anniversary of American independence was observed here by the American colony. The celebration was held in Trivoli del Eliseo, and the net proceeds were \$1000, which will be given to the support of the American hospital. A fine dinner was served. In the afternoon the large ballroom was filled with dancers, and a well-attended ball was held in the evening. The government furnished the military band, out of compliment to the occasion, and an orchestra was also in attendance.

The Kimball Company may regard such methods as fair and honorable, but they are open to the severest criticism in attempting to destroy the piano trade in Washington after many years of honorable work to promote it.

This whole scheme is perpetrated to give the Kimball pianos a position to which their merits do not entitle them. Although the Kimball advertisement declares these are not Kimball pianos which are to be slaughtered it does not enhance the value of their own instruments.
