THE PICKLER PENSION BILL.

The Pickler pension bill, says the Globe-Democrat, passed by the house, contains some objectionable provisions, but as a whole it will not fail to receive the approval of the country. Its general purpose is to undo as far as possible the evil results of the Democratic pension policy and to protect the soldiers against further wrongs in the adjustment of their claims under the laws enacted for their benefit. The fact is well known that the present administration has persistently conducted the pension system in an unfriendly spirit toward those who fought the battles that saved the union. Instead of striving to promote the rapid and helpful distribution of pension funds to those having just and fair rights in that relation, it has used every expedient to delay and defeat such payments, thus preventing the money from reaching those to whom it belonged and who stood in sore need of assistance. Thousands of names have been dropped from the pension rolls in an arbitrary and surreptitious way; and thousands of applicants have been rejected on frivolous pretexts and with offensive insinuations of dishonesty on the part of the applicants.

It is the principal object of the Pickler bill to put a stop to this sys-

tematic betrayal of a great and sacred trust. The interests of the soldiers represent a sentiment of national gratitude and generosity which should not be hindered in its appointed and practical operation by political prejudice and animosity. It is the desire of the people that disabled and dependent veterans shall have reasonable succor, and that the process of obtaining the money appropriated for this purpose shall be made as easy and expeditious as possible, consistent with the necessity of guarding against mistake and deception. The Pickler bill is not intended to dispense with any proper precaution in the investigation of claims or the interpretation of the laws, but only to remove obstructions in the form of abuses of authority that serve to cheat the soldiers out of their rights. It provides in a general way for the simplification of pension office methods, and for the restriction of official discretion in the rejection of claims for frivolous and insufficient reasons. Such legislation is demanded for the legitimate enforcement of the will of the people with regard to the debt which they owe to the men whose preserved the government; and it is to be hoped, therefore, that the senate will pass the Pickler bill at an early date.

The statement is being made in some localities that Walter Moore, the Republican candidate for joint senator, was opposed to the building of the Rattlesnake road.
