**SILVER OR GOLD.**

Unless conditions change greatly between now and the day of meeting, the St. Louis convention will nominate McKinley for president and declare unequivocally for the maintenance of the present gold standard. The talk of the silver men, which but a few days ago was blustering and heavy with threats of a bolt in case silver was not endorsed, has simmered down to a moderately-expressed hope that the convention will not refuse to recognize the claim of the silver states and mine-owners. The leaders of the party—the men who have maintained Republican principles with the greatest consistency and success—are determined that the convention shall not stultify itself on the coinage question. The silver craze is the result of ceaseless agitation among people such as mine-owners and the debtor class, who have material interests which would temporarily be benefitted by the free coinage of silver and among people whose prejudices when appealed to are easily excited.

The United States government is able to carry a circulation of \$500,000,000 in silver dollars. This is done because the government thus far has been able to promise that the silver would, if necessary, be redeemed in gold. If, however, the mints were compelled to coin all the silver bullion brought to it, the excess of silver would be so great that its purchasing price would immediately drop to its commercial value, and the silver dollar of today would be worth but fifty cents, or whatever its bullion value would be. The phrase free silver is a catchy one, but it takes but little study and thought to foresee what dangers would result to the business interests of the country if such a course were adopted.

Events have proved that the Republican party has been right on all national issues. A great opportunity is presented to it now to be still the party of progress, of honor, pledged to the maintenance of the national credit and to the advancement of the material interests of the country.

The people are eager for a return to the protective policy of the Harrison administration. This they will obtain through the agency of the Republican party. But the St. Louis convention will betray the trust confided to it if the result of its deliberations is not a declaration against the free and unlimited coinage of silver and an honest expression in favor of the gold standard.

The ticket nominated at the citizens' meeting Thursday night is worthy the support of all good citizens. The nominations of Mayor Menefee and Treasurer Crandall were achieved fairly, and if the convention stands for anything it means that this ticket should be supported. If otherwise, what is the use of holding the convention? The record made by the present city government is one we can look to with pride. A few more years such as the last one, and a great inroad will be made into the city debt. There can be no valid

argument raised against the election of either Mr. Menefee or Mr. Crandall. Their characters and records are above question.

Today's dispatches mention the death of Judge Isaac H. Maynard of New York. The only claim this man had to reputation was that through his unprincipled devotion to David B. Hill he was rewarded with a judgeship. When election came around the people of New York revolted and buried Maynard under a plurality for his opponent of over 100,000 votes. Since that time Hill has been losing ground politically in the state of which he was once the absolute boss.

Walla Walla has raised \$800 for a Fourth of July celebration. Pendleton business men are contributing liberally for a like celebration in that city. The Dalles has yet made no move towards keeping up with her sister towns in a display of patriotism. It is not because we are lacking in love of country or financial ability, but simply through lack of some one to set the ball rolling. There is yet time to arrange for a successful celebration.

Since Manley's break at St. Louis when he said that McKinley would be nominated, Reed can sympathize with the man who wished to be "protected from his friends."
