Letter From Neal Dow.

AMESBURY, Mass., Aug. 28 .- A letter from General Neal Dow, the noted prohibitionist, and former candidate for the presidency, in which he gives his views on the money question, is made public by the general's correspondence. The letter savs:

"The proposition of the Populists and other silver men is this: That congress enact a bill making 53 cents .in silver equal in value to 100 cents in gold; that the 53 cents be compulsorily received as full payment for 100 cents in gold. A Mother's Awful Crime.

KANSAS CITY, Mo., Aug. 28.-Neighoors who broke into the home of C. W. Green, a traveling passenger agent for the Big Four railway, this forenoon, found three children (two boys, aged respectively 13 and 6, and a girl aged 9,) lying dead in bed. They had been shot and instantly killed as they slept. In another part of the house Mrs. Green lay dead upon the floor. It is supposed the woman, while temporarily insane, killed the children, then dispatched herself, using a revolver.


