Republican headquarters look gay with flags flooating high, bunting everywhere, portraits of the candidates and political posters. Mr. Donnell's drug store contains the flag that was used in the ratification meeting when Grant and Colfax were elected in 1868. It, is faded and worn, but the occasion is not too important to raise the old silken banner. Mrs. Donnell was one of a number of ladies who made it in that year. Saltmarshe exhibits a frayed sheep hide with short wool and an old broom, with a Bryan motto pinned to the hide. The flags do not exactly indicate the political complexion of those who display them, though the Republicans have been by far the most liberal.
