#### AN IDEAL LAUNDRY.

Fixtures Which Are Necessary and Convenient.

The laundry in the great majority of houses is combined with the kitchen. Where it is not necessary to economize space, there is no reason for this arrangement. It is exceedingly desirable to have the room where a weekly washing and ironing can be done apart from the rest of the house. It is beginning chell three times a week. to be the fashion to finish off a room in the cellar for this purpose. When the foundation of the house is high enough to allow for windows of proper size, this is an excellent plan. It is always practicable to do so when the house is built on a slope or hillside and the ground is considerably higher in front than it is at the back. Though it adds considerably to the expense of building to make arrangements for a laundry apart from the rest of the house, it is one of those expenditures that pay. It costs little over \$25 or \$30 to attach a special hot water boiler to the laundry
