

Brigham Young was the first governor Utah, and was appointed by Presi-ent Filmore, taking the oath of office ebruary 3, 1851, and held the office un-Il 1857, being succeeded by Alfred Cumning of Missouri. Col. Edward Steptoe ras appointed governor and sent to Utah with a battalion of soldiers in 54, but arriving in Utah was afraid of he Mormons and did not qualify.
