SPAIN WILL BE THE SUFFERER

England's Proposal to Declare Coal Contraband of War Suits Us.

WE WILL NOT BE INCONVENIENCED

Seffer-Efforts Making to Pursuade Other Powers to Take Action Simitar to That of England.

New York, April 18 .- In directing her colonies to regard coal as contraband of war in the event of hostilities between the United States and Spain, Great Britain has taken action, American officials say, in line with the wishes of the president and naval officials, says the Washington correspondent of the Her-

Pressure will be exerted upon France, Havti and San Domingo to accomplish the same result, and some attention is being given by the state department to South American countries, with a view of securing a contraband character of cosl, as well as an announced determination on their part not to sell either to Spanish or American men-of-war a supply of fuel greater than necessary to enable the belligerent vessel to steam to the next home port.

So far as the Danish West Indies are concerned, the authorities have purchased in their reports all the coal that it is possible to secure. With coal a declared contraband of war, administration officials and naval experts sav it will be impossible for Spanish vessels to operate in the West Indies or the Pacific and as a result the chances of success for American arms would be immeasurably enhanced.

If the tortifications of the Philippines should stand off the American fleet for any time, the operations of the vessels would be greatly embarrassed, for by England's declaration, her colonists will be only allowed to sell to either belligerents a supply only sufficient to take him to his home port.


