Mrs. Wm. Stewart, of Portland, came up from Hood River last evening, and will be the guest of Mrs. W. S. Myers during the remainder of the week.

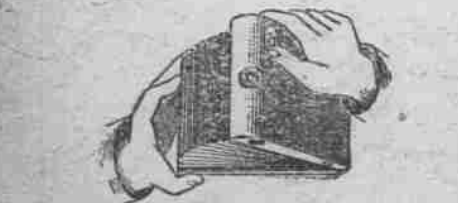

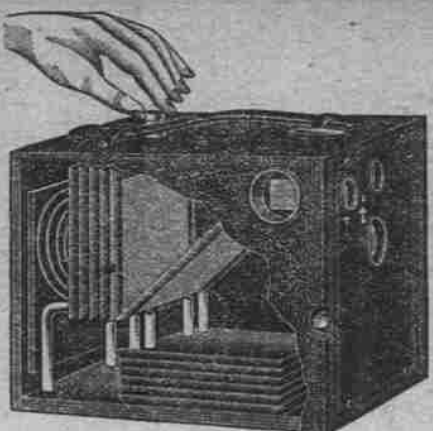

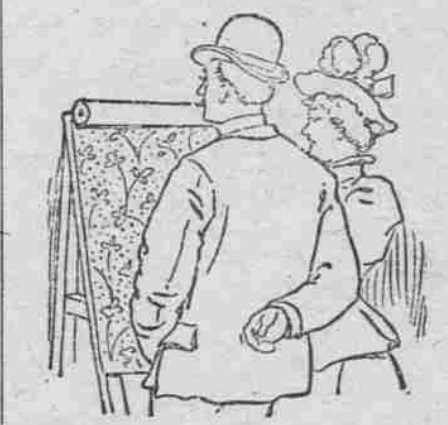
