New York, July 25.—The fall meeting of the Coney Island Jockey Club promises to furnish excellent racing. The secretary has just announced the number of entries in each stake. There are 682 entries in 18 stakes. All the stars of the Eastern turf are in. The particular races are the Twin City handicap and the Autumn cup. One is to be run September 6 and the other on September 9. Ornament and Hamburg are entered in both.

In both these races Ornament will meet Tillo, and in one Ogden. The game little Sir Walter bobs up again in the Twin City, while the great Western Plaudit may start in each race. As high a class will be found in the other stakes.

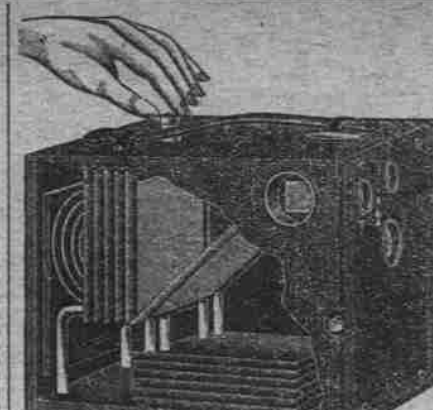
