DEPARTMENT OF THE INTERIOR, United States Land Office. The Dalles, Oregon, August 19, 1898. Notice is hereby given that the order of the President of January 31, 1898, permanently reserving the following described tracts or parcels of land, for the use of a boatrailway between The Dalles and Celilo, on the south side of the Columbia river, has been revoked. Said tracts described as follows: One tract situated in the NW½ of Sec. 31, T. 2 N., R. 14 E., containing about four and one-half acres (no other description). The other tract in the NW½, Sec. 21, T. 2 N., R. 15 E., containing about one half of an acre, particularly described as follows: Beginning at the northwest corner of said section 21, and running thence in a southerly direction along the west boundary line of said section 21, one hundred and seventy (170) feet to a point on said boundary line; thence in a straight line to a point on the north boundary line of said section 21, distant two hundred and sixty (260) feet in an casterly direction from the point of beginning; and thence in a westerly direction along the north boundary line of said section 21 to the point of beginning. 

C., April 29, 1898. In accordance with the provisions of the Act of June 4, 1897 (39 Stat., 59, upon the recommendation of the Secretary of the Interior, the west half of Township one South, of Range ten East, willamette Meridian, Oregon, within the limits of the Cascade Range Forest Reserve, is hereby ordered restored to the public domain, after sixty days notice hereof, by publication, as required by law, it appearing that said tract is better adapted to agricultural than forest purposes. Notice to Delinquent Taxpayers.

The delingent taxes of Wasco county, as shown on the rolls now in the hands of the sheriff are \$60,000, an amount almost equal to the indebtedness of the county. Every citizen will doubtless admit that this state of affairs should not exist, and that all taxes should be collected. On account of hard times in the past the county court Las shown leniency to taxpayers, but that leniency has reached the limit, and the court cannot wait longer on delinquents to make settlements. For this reason a warrant has been attached to each delinquent roll commanding the sheriff to collect all taxes by seizure and sale of property. With a bountiful crop now in sight, there can no longer be any reasonable excuse for the non-payment of taxes. The sheriff is bound by oath to comply with the terms of the warrants attached to the tax rolls for the collection thereof, and has no option in the matter. Delinquent taxpayers can save the cost of seizure and sale of property by settling their taxes at once.


