It is provided that "no other salary, compensation, fees, percentage or com- mortgage-tax law. missions shall be allowed to or be rcin this act, whose salaries are hereby in joint session. established."

In the section pertaining to the salaany board or commission, as now required or as may be required by law, or monstrances. may hereafter devolve upon either of them. Present fees shall continue to be treasury monthly.

By the terms of the bill the governor, secretary of state and treasurer shall constitute a board to determine the number of deputies or assistants which shall be allowed to each of the officers named in the act, and to fix the compensation of each such subordinate.


