VAST ARMY IS NEEDED AT MANILA

Lawton Says 100,000 Troops Will Be Required to Pacify Philippines.

HIS FORCES

AT MANILA

All the Towns and Territory They Captured Abandoned to the Intion to Manila.

NEW YORK, April 17 .- A dispatch to the World from Manila says: Major-General Lawton, at Paite, today suthorized the World correspondent to make this statement:

"The present prospect is that 100,000 troops will be necessary to pacify the Philippine islands." General Lawton's expedition has returned to Manila. All the territory he had captured was evacuated, and the launches he seized will be given back to the persons from whom Aguinaldo's soldiers took them."

After giving the opinion that 100,000 men will be required to subdue these islands, General Lawton explained the situation to the World correspondent as follows:

"The difficulties in the way are those of fighting guerrillas in a tropical country. With my brigade I could force my way from one end of the island to the other if I did not have to hold the territory I traversed. But leaving garrisons behind would soon eat up the

whole of the force." General Lawton regretted exceedingly being compelled to evacuate the territory he had captured.
