### INTEMPERATE OPPOSITION.

With all the emphasis and the eloquence at his command, Senator Pettigrew declared in open debate in the United States senate this week, that the soldiers under Aguinaldo were fighting for a righteous cause, and the soldiers of the United States were waging an unholly war. He declared dramatically, that if he were a Filipino, he would fight against the aggression of the United States until his hair was gray.

The Spokesman-Review says: There is but one construction for these intemperate utterances. Pettigrew is "egglog" on the enemies of his country. He is inciting the Filipinos to shoot our flag to tatters and kill our soldiers. And in the face of these utterances, he has the effrontery to say that the blood of our soldiers is on the head of the president.

Pettigrew glories in his incendiary sentiments. The spirit of opposition has blinded him to the seriousness of his course. He is boasting of his friendship for the insurgent enemies of his country, just as the copperheads of the civil war boasted of their sentiments, and wore badges on their breasts bearing the insignia of a copperhead snake. But there came a day when they ceased to boast of their copperhead sentiments. There came a day when in all the northland not one badge could be seen in open defiance of the Union cause.

Fault is not found here with earnest and temperate criticism of the conduct of the war in the Philippines. Opposition to the retention of the islands is natural, and is entitled to respectful consideration. That is a grave question, and much may be said on both sides of it. But that is very different from the intemperate and incendiary speeches of Pettigrew, Hoar and others.

When Dewey's squadron destroyed the Spanish warships, the nation consented by acclamation. When the army and the navy took Manila from the Spaniards, not an objection was offered. Up to that point men of all parties concurred in the military possession of Manila and naval and military control of the surrounding country.

We sent then a peace commission to Paris, to meet the Spanish commissioners, and they negotiated a treaty which delivered the Philippine islands to the United States, to be held by the president in trust, for future disposal by congress. While that treaty was before the United States senate, Aguinaldo's army, in flames and indignant because it was not permitted to loot the city of Manila, attacked our soldiers; and ever since that attack men like Pet-

tigrew and Hoar have been inciting them to vigorous action.

The farmers who raise flax in the middle Northwest have been very fortunate this year. The crop of Minnesota, North Dakota and South Dakota is estimated at about 15,000,000 bushels, and the price at Chicago has reached \$1.40 per bushel. The farmers have probably obtained over a dollar a bushel for the whole crop. Two or three explanations for the unusually high price have been advanced. One is that some speculator worked up a corner on the crop; and another report says the Standard Oil Company has been buying up all the flax, regardless of cost, for the purpose of crushing competitors in the oil business. If things take their usual course, flax will be low priced next season.

Equally interesting is the scientific and tempting fashion in which the sorting and packing of the orange is here accomplished.

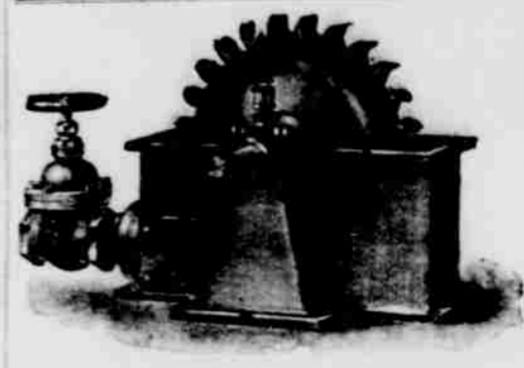
