BRIEFS FROM THE STATE HOUSE

Measures to Be Passed Upon—No Apparent Change in the Senatorial Question.

SALEM, Or., Jan. 28, 1901. The people of Oregon are watching with interest, the actions of the house committee on railways and transportation, in regard to the disposition of the bill, which is now in its possession providing for a reduction of railway rates in the state. This measure is in the interests of the whole people, not only those of the shipping and traveling classes, but for the welfare of the producer and merchant as well. It is said by many here, that the committee, of which Mr. Story, of Multnomah, is chairman, will hold the proposed law in its possession, and not report it back to the house for action. The introducer of the bill, Mr. Carter, of Jackson, on the other hand, however, says he will see to it that the proposition will be presented to the house early this week for consideration. It is certain, that should the members desire to take up the measure for discussion, they can demand the bill from the committee and secure a vote upon it whether the committee is willing or not.

Senator Johnston has introduced a measure in the senate, which is in the interests of a portage railway at the dalles. While it is improbable that the bill will pass the house, yet it will serve to bring the attention of representative men of Oregon to the needs of the people of the northeastern section of the state.

Another item of great interest to the citizens of that section, is the possible construction in Eastern Oregon of an agricultural college. In support of locating such an institution there it is claimed that the present state agricultural college does not meet the demands of a large part of the state. That the soil, conditions and climate existing in the eastern section, are not even similar to those of the Willamette valley, hence many of the experiments made here are of no practical value to residents of the other locality. It cannot be stated at the present time just what will be done in regard to this matter, but it is very

reasonable to suppose that the voice of the citizens of such a large portion of the state, will receive some consideration at the hands of our legislators.

The senatorial situation is as it has been from the first.

The most graceful act that could be done, would be for both Mr. Corbett and Mr. McBride to withdraw from the race, and let some new candidate be presented, voted upon and elected. The followers of Corbett are pledged to their constituents, to oppose the election of McBride, while the McBride men are also pledged to secure the defeat of Corbett. Thus it can be seen, that, unless some of the members abuse the trust and confidence of the people, neither McBride or Corbett can be elected.

We Shall Be Represented.

NEW YORK, Jan. 25.—A special to the World from Washington says: The United States will be officially represented at the crowning of King Edward VII. It has not yet been determined who shall make up the American delegation on that occasion, but it is certain that some representative citizens will be sent from the United States, and that many American Diplomatic Corps and Military and Naval Attaches in Europe will be sent to London upon that occasion.

Today, all the legations and embassies having displayed their flags at half-mast out of respect for Queen Victoria for the period of three days, will resume the routine of this capital, except during the obsequies of the dead Queen, when the flags will fly again at half-mast and the embassies and legations will be closed to the public.

Honor For Kaiser.

COWES, Isle of Wight, Jan. 27.—This morning Emperor William received from the hands of the Duke of Connaught his sword on his appointment as Field Marshal of the British army, in the presence of the households of King Edward and the dead queen, as well as a number of British and German naval officials. His Majesty expressed great delight at the appointment. He will entertain King Edward and the members of the royal family at tea on the imperial yacht Hohenzollern. Today he celebrated his birthday at Osborne. Shortly after 8 o'clock this morning the members of the German embassy who arrived from London yesterday proceeded to Osborne and tendered congratulations to Emperor William upon his birthday. The emperor, accompanied by the Crown Prince, met them in the reception-room. There were no formal speeches.
