JUMPED TO HIS DEATH

Colonel Hart Leaped From Moving Train Into River—Well-Known Mining Promoter Did Act With Suicidal Intent, as Proved By Letters.

BOISE, Idaho, Feb. 16.—Colonel W. Thomas Hart, of Weiser, today committed suicide by jumping from the "Cannon Ball" train when a few miles from Huntington, as it was crossing the Snake river. No trace of the body has yet been found.

Colonel Hart was one of the most familiar figures of the inter-mountain section. He was a promoter of mines, railways, etc., and had scored many successes. His latest attempt to promote the Bridgeport & Helena Railway, to run from near Huntington, Or., down the Snake to Lewiston, met with failure.

Colonel Hart has all along been supposed to be in this section in the interests of the O. R. & N., and when asked the question point blank, refused to answer. He lately has been especially interested in mining enterprises at Mineral. It is understood he was without means, and his friends believe despondency was the cause of the suicide. The end of his life was deliberate. He telegraphed friends at Weiser, this morning, that he would not be home today, ending by "See my letter." He forwarded a letter on the same train from which he leaped, which read:

"J. B. Coakley, Weiser.—I will commit suicide as the morning freight crosses the railroad bridge. Destroy my papers. Yours gratefully, W. Thos. Hart."

Mr. Hart was especially well known throughout Eastern Oregon and Western Idaho and all financiers had a friendly feeling for him. He was a colonel in the Confederate service. He later was manager of the Bi-metallic mine at Phillipsburg, Mont., when it was one of the greatest silver producers of the West. He was born in Georgia. Little is known of his history because of his extreme reticence regarding personal matters.

DAMAGE BY DRIFT JAM

Bridal Veil Factories Sustain Considerable Loss—All the Bents in the Three-Track Bridge of the O. R. & N. Co. Were Washed Out.

BRIDAL VEIL, Or., Feb. 16.—Considerable damage was done to the O. R. & N. Co.'s bridge and to the property of the Bridal Veil Lumbering Company and the Oregon Pulp & Paper Company, at this place, last night, by a drift and slides forming a dam in the Bridal Veil Creek about three miles from this point, and at an elevation of 2000 feet. The creek is a large mountain stream, even in low water, and the heavy rains and melting snow for the past two days have made it more than a torrent. The Bridal Veil Lumbering Company had the gates to all its dams wide open early in the afternoon, so that the dams would not break, but the drift formed a dam just above the sawmill late in the evening and broke at 11:30 p. m., taking everything before it. Great trees, logs, timbers and rocks came tearing down over Bridal Veil Falls, taking out several sections of the Bridal Veil Lumbering Company's lumber flume and coming up against the paper mill with such force that it tore away their stock platform and scattered bales of rags and papers and barrels of tar all along the banks of the creek to the river. The railroad bridge over the creek got the full force of the flood and drift, and all the bents were washed out of the three-track bridge. The passenger trains are being transferred today with very little delay, and the bridge will be repaired in a few hours.

It is hard to tell at present the extent of the damage done to the lumber company's and the paper company's property, but the large waterwheel that runs the paper mill was taken out, and has

not yet been located, and it is safe to say that it will be several days before either one of these large companies will be able to run their mills. There was no loss of life, Mike Supple's house was torn from its foundation and nearly turned around, and the front steps and porch of L. G. Gurnett's residence was torn off and carried away in the flood. The occupants of both houses escaped without injury.
