



New Law On Weights and Measures.

The new state law relating to the standard weight of produce, provides that whenever wheat, rye. Indian corn, oate, barley, clover seed, buckwheat, dried apples, dried peaches, potatoes or pears shall be sold by the bushel, and no special arrangement as to the meas- butter for sale at J. H. Cross store. 14 ure or weight thereof shall be made by the parties, the measure thereof shall be ascertained by weight, and shall be computed as follows:

Sixty pounds for a bushel of wheat or clover seed.

Fifty-six pounds for a bushel of rye or Indian corn.

Thirty-two pounds for a bushel of oats. Forty-six pounds for a bushel of bar-

ley.

Forty-two pounds for a bushel of buckwheat.

Thirty-eight pounde for a bushel of dried apples or peaches.

Sixty pounds for a bushel of potatoes. Forty-five pounds for a bushel of apples or pears.


