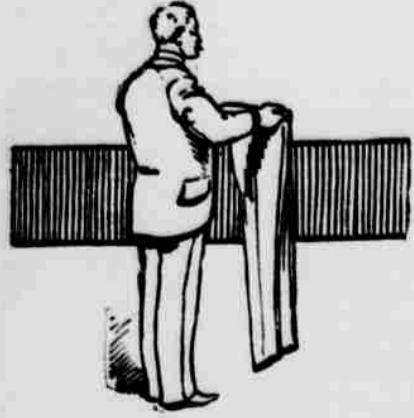

NOTICE TO WATER-CONSUMERS. All persons using Dalles City water for irrigating purposes between the 1st day of May and the 1st day of September, will observe the following rules and regulations:

Persons will be permitted to use the water below the bluff on all even days, and above the bluff on all odd days from 6 o'clock a. m. until 8 a. m., and from 6 o'clock p. m. until 8 p. m. The above rules must be strictly complied with, and any infraction of the above rules will subject the offender to a fine of \$1, and the water will be shut off until paid; and for a second offence double the amount. The following charges will be made: For one full lot 50x100, \$1.50 per month. Each additional lot \$1.25; half lot 75 cts. All persons using water in closet or toilet will see to it that the water is shut off when not in use, or water will be shut off altogether if allowed to run to waste. J. B. CROSSEN, Supt.
