With free entry of sugar into the United States the Cuban sugar raisers know that this country would be their best market, and they will leave nothing undone to remove the barrier that now exists in the form of tariff duties. With these Cuban interests the trust will make common cause, for it wants the raw material for its refineries and it desires to get it without paying duty on it. Back of the attempt, therefore, to make a reciprocity treaty with Cuban sugar free, will be found the immense resources and influence of the sugar trust.

It is needless to say that on the other side there will be those who are determined to make a vigorous contest in behalt of the beet sugar interests which would be seriously gestion or dyspeysia.
