THE GREAT LOGANBERRY INDUSTRY AGAIN

Efforts are being made by the managers of the two greatest juice concerns to get closer together in the marketing of their products.

This movement promises to further stabilize the great and growing loganberry industry and thus to give it a still firmer foundation, and for that reason it is to be hoped that the efforts of the managements may succeed, and that the working out of the plans will be harmonious, both in the near and far future.

There is no doubt that the loganberry industry can be made many times greater than it has already become; and it is now one of the chiefest of Oregon's industries.

The world is the market; or will be after the war. It is good to know that efforts are on foot to so organize the industry that the whole world may very soon be put under tribute to the great loganberry industry of the Willamette valley.

A CRUMB OF COMFORT

England's journalistic troublemaker, Horatio Bottomley, editor of the London John Bull, has been on a visit to the trenches and has returned with words of cheer. In John Bull he writes:

"And now for what I have learned. We will have the truth from the trenches at last. The war is won. Germany is beaten. On every front she is weakening and weakening—and it is now only a question of the psychological moment to strike. That momentous decision rests with one man—at least, I hope to God it does. If the politicians will kindly keep out of the ring Haig will very soon administer the knockout blow.

"I know what I am saying. I do not profess to speak as any military expert or prophet. I say that which I have learned. I mention no names—I disclose no secrets—I abuse no confidence. From Field-Marshal Commander-in-Chief right down to the rawest Tommy in the trenches there is but one spirit—that of absolute optimism and confidence. And there is not a German prisoner who does not tell the same tale. 'Es ist fertig,' said every one of them with whom I talked—it is finished."

It is snowing for world democracy in the Alps.

Shifting a bit the well known expression attributed to Abraham Lincoln, the world cannot exist half-German and half-free.

Some one remarks: "Expelled from the old Jerusalem, the Germans are by no means certain of ever reaching the New."

No use calling the Russians hard names—they're accustomed to them," remarks a cynic.

Hooverizing is commonly regarded as something new, but some one found this in Proverbs 15:17: "Better is a dinner of herbs."

The interesting suggestions are noted by the Survey that the abandoned Shaker settlements be used as sanitariums for disabled and invalided soldiers and as institutions for defective dependents of the state. There are many thousand acres of land in these settlements capable of a high state of cultivation, and many of them have large buildings substantially constructed which could be easily modernized. There are fewer than 1000 Shakers in the whole United States today, and many of the settlements have been abandoned. Their locations and their proved possibilities make the suggestions for their use well worth official consideration.

COMING INTO THEIR OWN.

It is claimed by high officials of the Methodist church that, for the first time in the history of Methodism, the average salary of the Methodist preacher is more than \$1000 a year. Some of us remember the time when the circuit rider, or itinerant minister, was paid mostly in sorghum, cornmeal and "middlin'"—and that he sometimes was compelled to raise a little crop and

carry conviction and should close the incident. Certainly the result of the investigation of no other group of men in Oregon is entitled to more consideration. The statement of these men indicates that a wrong has been done President Kerr and the Oregon Agricultural college. Few men in the state have enjoyed the confidence of the people that President Kerr has and no institution has received more hearty approval than the O. A. C.

There may be some who from financial, political or other selfish reasons may attempt to discredit the statement of the board of regents, and thereby the members of the board of regents individually as well as Dr. Kerr and the Oregon Agricultural college, but such an attempt can only come from a sinister motive or a selfish purpose.

MINISTERS OF LIGHT.

The author of "I Need These Every Hour" lies dead at her home in beautiful Vermont. She was 83 years old when she passed away. It would seem that there are persons to whom the Almighty actually entrusts some definite mission in the world, persons who come among men as ambassadors from a higher sphere to bring comfort and knowledge and wisdom to the inhabitants of earth. That Annie Sherwood Hawks lived 83 years perhaps means little in itself. That she wrote "I Need These Every Hour" has meant and will continue to mean much to the world. To be a prominent church official may or may not mean a great deal, but the author of "Lead Kindly Light" will be remembered more because of that song than for anything and everything else he ever did. It has been said: "We live in deeds, not words." In heart throbs, not in figures on a dial.

And it is just as true that those who live after us will remember us not for the many little things we did and said, but for the one strongest and finest expression of our lives.

RYAN PLATFORM IS ANNOUNCED

Assistant Treasurer Declares His Candidacy to Succeed Kay

Thomas F. Ryan, assistant state treasurer, yesterday announced his candidacy for the Republican nomination for state treasurer at the primaries in May.

In announcing his candidacy Judge Ryan said he would make neither a speaking nor a traveling campaign in behalf of his candidacy. He declared that during the present world struggle for democracy it is the duty of all citizens to devote their energy, time and money towards aiding to win the war.

Judge Ryan is the fourth to announce for the office. The other aspirants are Ed. C. Cusick, an Albany banker; O. M. Plummer, Portland school director; and William Adams, treasurer of Portland. Ben F. West, Marion county assessor, is expected to make his announcement next week.

"For the past seven years I have occupied the office of assistant state treasurer, and in the coming primaries my official record will be my platform," said Judge Ryan.

Leaves It to the People.

"With the world at war and our nation sacrificing the flower of its manhood and wealth that democracy may triumph and gain a world-wide hold, it is the duty of every citizen to devote as much of his time, energy and money as possible to aid in winning the war, and I shall make neither a speaking nor a traveling campaign, but shall submit my qualifications to the people and leave my candidacy to their verdict," he continued. "This is not time for politics and costly campaigns; no time to be touring and scouring the state for votes to gratify political ambitions.

"I am proud of the system that has been inaugurated in the state treasury department by State Treasurer Kay and myself. The national examiners have given us credit for performing more work with less money than any other treasury in the union and also with having the best regulated and most efficient office. If I am nominated and elected, I pledge myself to maintain the present high standard of the office that the Oregon treasury department may continue to hold first place among the treasuries of the United States.

Knows State Institutions. "Having, as assistant state treasurer, made a study of the several state institutions, I feel that I am thoroughly conversant with their requirements, and also the duties of the boards and commissions on which the state treasurer serves as a member. I also believe that my long residence in Oregon and years of service as a public official have made me familiar with the needs of the agricultural, horticultural, drainage, irrigation and other industrial interests of the state, and if nominated and elected, I will endeavor to the best of my ability to promote the welfare of these industries and to give the people an efficient, economical and business-like administration."

ical and business-like administration."

Judge Ryan is a resident of Oregon City, and previous to becoming assistant state treasurer he had served as mayor of that city, and also as county judge of Clackamas county. Among the reforms inaugurated by him as mayor, was the creation of a board of water commissioners through which Oregon City procured its present system of pure mountain water. He was also the original promoter of the movement which resulted in giving to the city of the falls its municipal elevator, the first of its kind on the coast.

For eight years he served as county judge of Clackamas county, and all of his administrations were characterized by efficiency and economy. He was re-elected by one of the largest majorities ever given a public official in the county. He also served as school director for Oregon City for eighteen years.

Judge Ryan is a recognized authority on state inheritance tax law questions. During the time he has served as assistant state treasurer he has represented the state in several hundred inheritance tax cases in court. In all saved two he obtained favorable decrees, resulting in recovering for the state thousands of dollars.

He is a member of the grange and during the last session of the legislature rendered valuable assistance to the committees of the grange and farmers' union in preparing and securing the passage of the rural credit law. He was a pioneer in the good roads movement in the state, and with the late Tom Richardson and others, formulated the plans for the Oregon Good Roads association, and campaigned the state urging the construction of good roads from farming sections to market places. Judge Ryan has always been recognized as a leading Republican and stands high in the councils of his party. He is also prominent as a worker in civic, fraternal and charitable organizations. He has always been interested in horticulture and agriculture and is the owner of the Ryan fruit farm near Oregon City. Judge Ryan married Miss Inez Marshall, a prominent Portland teacher, in 1897, and has two sons and two daughters.

PORTLAND ASKS ORDER HELD UP

Would Have Six-Cent Fares Postponed Pending Litigation in Courts

W. P. LaRoche, city attorney of Portland, filed with the public service commission yesterday a resolution of the Portland city council petitioning the commission to postpone pending action in the courts, its recent order allowing the Portland Railway, Light & Power company to increase its street car fares to 6 cents. The postponement asked is from January 15, the date on which the order is to go into effect, until a date is set by the supreme court where the case will be appealed from the circuit court.

Griffith Also Appears. President Franklin P. Griffith of the utility accompanied Mr. LaRoche and offered a verbal argument against the postponement. He endeavored to shift all the burden of the litigation to the company. He will hold out for a stipulation that the city put up a bond to reimburse the company for its financial losses if the order is postponed and the city loses the case. This would amount to \$50,000 a month on the basis of \$600,000 a year increase in wages that has been allowed by the company and its employees, and it is declared that the case cannot be put through the courts under three months.

Commission Against Postponement. Chairman Miller was the only member of the commission in the office yesterday when Mr. LaRoche and Mr. Griffith appeared. He announced that the commission would meet and act on the petition Monday. Mr. Corey, however, returned from Seattle later in the day and declared that this is also Miller's attitude, making the majority of the
