Floral Society to Hold Annual Exchange Today

The Salem Floral society will hold its annual "Floral Exchange" today in the building formerly occupied by Gardner & Keebe, 386 State street. This is an event that will be of interest to all lovers of flowers, as well as those who propose to cultivate war gardens. As in former years, opportunity will be given for all who have a surplus of seeds, flowers or shrubs, to bring them in and exchange for other varieties. The exchange proved very successful last year, several thousand plants being exchanged.

A large quantity of flower and vegetable seed has been secured by the society this season, to be exchanged for anything that may be brought in.

As is generally known, the object of the society is to further the work of civic improvement and ornamentation and in past seasons has accomplished gratifying results. Last year no less than 12,000 rose cuttings were distributed, and an impetus given to the beautifying of residence streets. Included in the membership of the society are several florists who have willingly co-operated in its work. There are now about 200 members but it is hoped this year to increase it to 1000.

HULL WILL BE COMPANY HEAD

Salem Gets One of Four Companies of State Military Police

One of the four companies of state military police to be commanded by Major Deich, and for which provision was made by a recent meeting of the state emergency board when \$250,000 was appropriated, is to be organized in Salem. O. J. Hull has been appointed captain and George C. L. Snyder first lieutenant. Both are men of military experience, Captain Hull having been a member of Company K and Lieutenant Snyder a member of Company A, Second Oregon volunteers, in the Philippine islands.

Salem will have the privilege of drawing from other towns of the Willamette valley in enlisting the fifty men who will compose the company. A large number of the men are to be taken from the new militia companies who have the privilege of transferring to the military police organization. Enlistment here began last night and a recruiting officer will be on duty at the armory for several days.

The Salem company expects to be located in Portland, where it will relieve men who are now on guard duty there.

GRANTS PASS LAWYER FILES

One of the surprises that was sprung yesterday, among last day filings for state and district offices, came when Fred A. Williams of Grants Pass appeared as an aspirant for the Republican nomination for public service commissioner. He will be opposed in the primaries by Frank J. Miller, incumbent, and the present challenger against Mr. Miller, in running against Mr. Miller, Williams is a candidate to represent the state at large on the commission. It was not expected that Miller would have opposition.

Another announcement that was not expected in Salem was that of Bruce Dennis, who, at a late hour last night, sent in his declaration of candidacy for Republican national committee against Ralph Williams of Portland. Mr. Dennis' slogan is "The Republican party must insist on winning the war." No platform accompanies the declaration.

Further uncertainty was injected into the contest for the nomination for state labor commissioner when John C. Nickum of Portland announced himself, making four Portland men after the Republican nomination, which will amount to election since no Democrat is in the race. The other three men are William A. Dalziel, C. H. Gram and John H. Holston. Mr. Nickum's slogan is "Roosevelt in 1290," and his platform is "Foster industries, protect investments, and give employer and employe a square deal."

In announcing for service commissioner, Mr. Williams comes out against 5-cent street car fare with his slogan "A 6-cent car fare is too much for a 5-cent ride." His platform follows: "In case any public service corporation shall apply for a rise in rates during my term of office I will take the sworn statement of such company as the true valuation of its property for the basis upon which to figure the percentage of its earnings. I will devote my special attention toward helping all projects referred to the commission that will increase the productivity of the state of Oregon, thereby securing to our soldier boys at the front a continuous and never-failing base of supplies."

With the declaration that he will not resign if elected, A. H. Burton of Portland filed as a candidate for the short term as United States senator to fill the vacancy in the term ending March 4, 1919. "Do all in my power to bring victory to our armies in France," he says in his platform. "I will work for national prohibition, equal suffrage, federal marriage, divorce and corporation laws. I will work for the opening of every acre of the O. & C. land grant to settlers. I believe in the initiative and referendum for the federal government and the election of president by direct vote. I stand squarely for the common people, the laborer and the farmer, and will not be controlled by the predatory interests." Mr. Burton's slogan is "Win the war. Back the boys. For the common people. No resignation."

A third candidate appeared to compete for the nomination for superintendent of water division No. 1. He is J. B. Schaefer of Linnton. In his platform he says: "Will keep in mind at all times the interest of the water users, the men on the land, which means the development of our state, keeping in mind that a fair deal to all is my platform."

Seven more candidates from the 18th representative district, Multnomah county, filed their candidacies for the legislature. All are Republicans. They are: E. C. McFarland, Chester C. Moore, Joseph G. Richardson, Elwood Wiles,
