TREATING WITH THE OUTLAW OF NATIONS

When President Wilson, on January 8, delivered to Congress and the world his message giving the war aims and peace aims of the nations at war with Germany, members of the Potsdam gang sneered at his words as those of a visionary; and they professed to believe, and no doubt did believe, that Mr. Wilson spoke for himself alone, and not as the voice of America and of civilization.

Now, Prince Maximilian of Baden, the new Imperial German Chancellor, professes to place his country in accord not only with the fourteen conditions precedent of that message, but he goes further, and accepts the sentiments of President Wilson expressed in his Liberty Loan speech delivered in New York on Sept. 27, in which our chief executive said Germany must redeem herself not by what passes at the peace table, but by what follows.

That would seem on the face of it to be all that is required to lead up to world peace, by agreements at the final council to be held by representatives of all the powers at war.

But is it all?
No; and why?
Because, unfortunately, Prince Maximilian comes to a station that has been held by a succession of men whose words could not be trusted; representing a gang of international outlaws riding at full tilt in charge of and backed up by a people apparently approving all the outrages and crimes that were committed in the name of ruthlessness.

So President Wilson, to whom the present peace appeal is principally directed by Germany, Austria and Turkey, must take stock of the conditions as he finds them, in the light of past performance as well as present fair promise.

He must treat with the outlaw of nations. And in so doing, he must weigh his words.

He must avoid a trap.
The present peace proposal will no doubt be accepted, but with such conditions precedent as will make the forces of civilization absolutely secure before they shall be led into a peace council.

Prince Maximilian may be shocked at the frankness with which he will be told that he is the diplomatic head of an outlaw nation. And, even so, he may survive; for if he is worthy of the place to which he has been called, he must know better than President Wilson that the crimes of Germany could not be painted as black as they deserve.

The story is that Von Hindenburg has resigned, because he told Kaiser Bill that the German armies must retreat on a wide front.

Beirut is gone, and the Hindenburg line caving in. President Wilson may make the answer as strong as he feels like doing.

Time to remind Oregon voters that this is a year to vote straight. No time to sidestep.

Foch marches on.

Kaiser Bill would better be at it.

Keep your mouth shut and your pocketbook open these perilous times. It is the only safe plan.

Germany is now worrying about the rubber shortage. But the allies strove to please by erasing their line for them.

No wonder the last Turkish loan was a failure—there has been a shortage of paper in that country for some time.

German armies burning villages as they retreat from France, while Berlin asks for peace. This is characteristic boche blundering.

Uncle Sam will have no dealings with Kaiser Bill. He is verboten, spurious versenkt, and ausgespielt. He is outlawed, and his word is no good.

Politics may be adjourned, but the Democrats are going right ahead with their plans to load up the census force of 1920 with deserving Democrats.

It is reported that the Kaiser "looks every inch a Prussian king"; but that is anything but a compliment, outside the dismal circle of the Potsdam gang.

The German people can have peace and on much better terms than they deserve. But they must speak for themselves, and not through the mouths of the Potsdam pirates.

The fact that Secretary Baker has been selected as chairman of the Cuyahoga county (Ohio) Democratic central committee indicates that politics has been adjourned again.

THE SOUTH RULES—THE NORTH PAYS.

Secretary of the Treasury McAdoo has issued a statement showing the proportion of population in each state that subscribed to the Third Liberty Loan.

In Illinois more than 25 per cent of the population subscribed. In North Carolina only 3.3 per cent subscribed.

Yet North Carolina has the chairmanship of the ways and means committee in the house and of the finance committee in the senate—the two most important committees in congress. Illinois has one chairman-ship in the senate, James Hamilton Lewis being chairman of the committee on expenditures in the department of state, and one chairmanship in the house, Representative Sabath being at the head of the committee on alcoholic liquor traffic.

DISTRICT DRIVE IS PROGRESSING

Twelfth Federal Reserve Has Over \$131,000,000 of Liberty Loan

SAN FRANCISCO, Oct. 7.—The Twelfth Federal Reserve district has \$131,316,200 in subscriptions to the fourth liberty loan in bank. It was announced tonight. The quota is \$102,000,000. Many banks failed to complete their returns. Campaign Manager George K. Weeks said, and consequently the total subscriptions shown only the amount in the banks Saturday.

Subscriptions throughout the district mounted steadily. Idaho's subscription is \$6,864,000, subscribed by 29,236 persons. The state has reached 50 per cent of its quota.

Oregon has subscribed approximately 70 per cent of its quota, \$9,512,000 subscriptions.

Southern California has \$26,071,500 in bank. Northern California counties, outside of San Francisco, have purchased \$11,571,750, or 23.5 per cent of their quota.

Washington's subscription to date in bank is \$24,625,000 and it is declared that the actual total subscribed is \$33,000,000.

In cities of Class A in the ship-

ping contest, Los Angeles leads San Francisco. In Class B Oakland has a substantial margin over Portland, with Seattle third. Tacoma leads in Class C, with Salt Lake City second and Spokane third. In Class D the race is "bunched" with Berkeley and San Jose making a strong showing.

Hawley Has Three Places to Choose for West Point

The war department at Washington has invited Representative W. C. Hawley to nominate a principal and two alternates from which to choose a cadet to the United States Military academy at West Point, New York. This is a special appointment due to the war emergency and the successful nominee will be admitted to the academy on November 1, 1918. Candidates must be actual residents of the First Congressional District of Oregon and must not be under 18 years of age nor more than 22 years old on November 1, 1918. Mr. Hawley will make his nominations from a register of eligibles to be established by a competitive examination at the University of Oregon, Eugene, Oregon, under the direction of President P. L. Campbell, on Saturday, October 12. This examination is open to all eligible candidates, whether students at the state university or not.

TOKIO, Monday, Sept. 30.—(By the Associated Press.)—Takashi Hara, the new premier, has informed the newspapers that his cabinet will avoid secrecy and that he will frankly reveal his policies to the public. He requested the support of the newspapers.

Foreign Minister Uchida said today that, though there were numerous diplomatic questions, especially relating to Russia and China, he was determined to discharge his duties in such a way as to satisfy the nation.

Prominent Parisians Are Suspected of Espionage

PARIS, Oct. 7.—Suzy Dobey, a former actress in Sarah Bernhardt's theater; Emile Cullier, her husband, who once was manager of Sam McVey, an American pugilist, and Maurice Tremblay, a bank employee and representative of an Austrian named Rosenberg, who was prominent on the Paris bourse and whose bank in Switzerland is under sequestration, were placed on trial today on charge of maintaining relations with the enemy. The hearing was secret.

Patients' Mail Not to Be Censored by Superintendent

WASHINGTON, Oct. 5.—The superintendent of the Oregon state hospital may not censor letters to and from patients in the asylum for the insane, according to a ruling of the postoffice department, without the patient's consent, but he has the widest discretion in withholding from the mail letters written by patients and to refuse to deliver letters to patients when such delivery would in his judgment be harmful.

Central Powers Must Get Out of Bulgaria in Month

AMSTERDAM, Oct. 7.—A dispatch received here from Sofia quotes the Bulgarian semi-official newspaper Prepetetz as giving the following as the terms of the armistice entered into between Bulgaria and the entente allies:

The evacuation of the territories occupied by Bulgaria in 1916 which belonged to Serbia or Greece.

Re-establishment of Bulgarian rule in the portion of former Bulgarian territory occupied by troops of the entente, for instance, Strumitza.

Demobilization of the Bulgarian army, except three divisions of infantry and four regiments of cavalry.

Consignment to the allied army of the arms, ammunitions and war materials of the demobilized troops.

Capitulation by the Bulgarian units stationed westward of Uskub when the armistice is signed, the troops to remain guarded by the entente until further orders.

Departure within a month of German and Austro-Hungarian troops, military agencies, diplomatic and consular representatives and persons of those nationalities.

The Turks were not mentioned in armistice, according to the dispatch.

Another Continuance In Anti-Trust Cases Asked

WASHINGTON, Oct. 7.—Postponement of the hearings of all pending anti-trust suits until next term was asked of the supreme court today in motions filed by Attorney General Gregory.

"These motions are made," Attorney General Gregory said in the government brief, "in view of conditions set forth in a motion filed with the court in December last, for the continuance of several of the same cases over to the last term—conditions which still obtain. This reference was to general war conditions."

"Notice has been given to the opposing counsel," continued the government brief, "and so far as we are advised there is no opposition to the motion in any case except that counsel for the United States Steel corporation have asked that it be stated to the court that they are opposed to a continuance."

The cases to which the motions applied are those of the Reading company, the so-called anthracite case; the United States Steel corporation, Eastman Kodak company, Associated Bill Posters and Distributors, American Can company, Quaker Oats company, Corn Products Refining company, Lehigh Valley Railroad company, and the Southern Pacific company.

Commander First Marines to Go to France Is Dead

WASHINGTON, Oct. 7.—Brigadier General Charles A. Doyen, who commanded the first regiment of the marine corps to go to France with the expeditionary forces, died at Quantico, Va., last night of influenza. He will be buried with full military honors, but arrangements for the funeral have not yet been announced.

General Doyen remained in France for nearly a year, being promoted to the rank of brigadier and to the command of the first marine brigade of his duties wrought on his health and to avoid a physical breakdown he was transferred back to this country. He was made commandant of the training station at Quantico.

Former Silverton Woman Is Dead at Walla Walla

WALLA WALLA, Wash., Oct. 7.—Mrs. Angeline Sweeney, widow of the late Alexander P. Sweeney, a pioneer Presbyterian minister of Washington and Oregon, died here this morning, aged 82 years. She came across the plains in 1847, and was married at Silverton, Or., in 1852, aiding her husband in pioneer church work in the Willamette valley.

FOUR DIE AT BREMERTON

BREMERTON, Wash., Oct. 7.—Four deaths among civilians in Bremerton and nearly 50 among the naval training camp forces at this station is the mortality toll of Spanish influenza during a 10-day period ending tonight. Three deaths among the naval men and one among the civilian population were reported today. It is said that there are not more than 200 influenza cases in the Puget Sound navy yard forces. In Bremerton 57 cases are under treatment.
