BOGUS USE OF NAME ALLEGED

Associated Advertising Clubs Have Tomahawk Out for Oil Concern

The Associated Advertising Clubs of the World, through a special bulletin of the National Vigilance committee, is directing another attack against alleged questionable stock selling enteerprises. A circular received by State Corporation Commissioner H. J. Schulderman shows that the advertising club, after investigation has turned its guns upon the Studebaker Oil & Refining company, a \$20,000,000 Arizona corporation with headquarters at South Bend. Ind., the circular bearing particularly upon the company's advertising campaign through the newspapers.

The oil and refining company is alleged to be making improper use of the name "Studebaker," and the public is said to have been misled into the belief that the Studebaker Oil & Refining company has a relation to the well known Studebaker corporation of South Bnd. There is a blood relation between the men in the two concerns, it is claimed, in that the three Studebakers in the oil company are the sons of Henry Studebaker, one of the founders of the Studebaker corporation, but who left the business in the days when it was a small wagon shop before the Civil war.

"This report is issued," says the circular, "because we understand the promoters of this enterprise, who have not succeeded in obtaining the approval of the capital issues committee, are planning a further advertising campaign to sell stock, and we have been informed that advertisements will be offered to tthe news

"Newspapers have already been misled by the skilled manner in which the promotors have played up the name Studebaker. Newspapers have told us that they accepted advertisements of the company because of the use of the name Studebaker by the promoters.

"Though none of the men con-nected with thee enterprise has ever contributed to the success of the Studebaker corporation, of South Bend, Ind., the name Studebaker is given prominence in the advertising matter in such manner as to imply they are the Studebakers who built the wonderful business bearing that

name Studebaker runs through the advertising matter. Too. the name Studebaker Bros. is used freely, and that was the name under which the Studebaker corporation formerly did business. The advertising has quoted the address of the off company as 'Studebaker Bldg. South Bend, though there is no office building of that name in South

"Thus, the coupling, in the advertising, of the good name Studebakeer and the city South Bend, has misled

and misinformed the public.
"The Studebaker corporation emphatically states, and has so stated when numerous inquiries have been made regarding the off scheme, that no officer of that company, and no man connected with it, is officially interested in the oil scheme." The report concludes:

"In the light of such facts, we strongly urge that newspapers and other advertising mediums decline to publish advertisements offereed by the Studebaker Oil & Refining company, or by brokers representing this company or offering its stock for

"We make this recommendation in the interest of clean and legitimate advertising. The publication of advertisements that mislead the public public has a right to believe advertising, and newspapers have a re-sponsibility to their readers to pre-sent only advertising which is wor-thy of confidence."

IS SUSPECTED

Highway Engineer Thinks Claim May Be for Patented Pavement

State Highway Engineer Herbert Nunn in an inquiry addressed to Attorney General Brown, indicates his belief that a claim of the Warren Brothers company against Oskar Huber, contractor who constructed the pavement on the West side highway from the Multnomah county line to Newberg, is for royalties on patented pavement rathert han for labor and materials furnished as asserted in a written notice which the Warren company has filed with the engineer. Nunn desires to know whether, regardless of the claim, the highway commission can proceed at once to settle with Huber, and the attorney general holds that this can be done.


The length of the improved portion of the highway is 15 miles and the amount of the claim of the Warren Brothers company against Huber is \$23,874.53, which is against a bond furnished Huber by the American Surety company of New York. Nunn claims that no proof was furnished with the claim. The bond is for the sum of \$127,308.18. By taking the required bond the attorney general holds that the highway engineer has protected the state and all persons furnishing the contractor with labor and material. Notice of the claim as filed with Nunn by the Warren Brothers company, the opinion holds, is not sufficient to prevent the highway commission from making final settlement with the contractor. "Under no corcumstances," the opinion concludes, "would the claim of the Warren Brothers company become a lien upon the public






