Savage, president of the board, has been suggested as a possible receptive candidate for the position in the event Mr. Lea decides to withdraw.

INFLUENZA HITS STRICKEN FAMILY

Son and Daughter-in-Law of J. D. White Both Victims of Disease

The hand of death has fallen heavily upon the home of Mr. and Mrs. J. D. White, 1490 Chemeketa street. Yesterday their son, Clarence M. White, well known lawyer of Pendleton was buried. Today Mrs. John F. White, a daughter-in-law, formerly Miss Nellie Hargrove, will be taken to her last rest.

Mrs. J. F. White was prominently known in Salem. She was the daughter of Mr. and Mrs. Thomas Hargrove and died Sunday morning at 8:30 at their home on Center street. Besides her parents and a three-weeks-old son, she is survived by the following brothers and sisters: Chester, Salem; Mrs. William Walton, and Miss Vivian Hargrove, Salem; Mrs. Edith Plank, Portland; Mrs. Grace Smith, Corvallis and Misses Maud and Winnie Hargrove, Portland.

Her husband, who also survives her, is ill of influenza and will be unable to attend the funeral services. He is connected with the Salem-Falls City Lumber company. Sergeant Horace R. White, a brother, arrived here yesterday from Camp Lewis to attend the funerals of his brother and sister-in-law.

While Clarence M. White never lived here, he made an impression upon Oregon life as a lawyer, as is indicated by the following tribute paid him by Judge Stephen A. Lowell in the Pendleton Tribune:

Clarence M. White, who died at 5 o'clock Friday afternoon as the result of an attack of influenza came to Pendleton last spring, entering the office of Stephen A. Lowell. Later he became associated with Raley & Raley, and was with them when taken ill about two weeks ago. He was highly esteemed among his acquaintances, and was looked upon by the legal fraternity as a lawyer of unusual ability and a man of high character. He was rapidly making a place for himself in the courts and his departure will be deeply regretted by the men who knew him best. Mr. White was not a mixer and his circle of acquaintances was not large. He was quiet, unassuming, studious, but dependable, honest, clean and able.

He was born in York, Neb., May 23, 1879, and received his law training at the University of Michigan.

For some years Mr. White resided in Morrow county, and was deputy district attorney when Judge Phelps was district attorney for Umatilla and Morrow counties. There he became an intimate friend of William Courter, the well-known Pendleton grain buyer, who then resided at Lone. That was nearly a decade ago. Soon after the expiration of his term of office, Mr. White removed to Portland, becoming associated with the law firm of Farrington & Farrington, where he practiced his profession until his removal to Pendleton less than a year ago.

Mr. and Mrs. James D. White, his parents reside in Salem, and have been at his bedside for several days. He has three brothers, James D. and Horace R. of Camp Lewis, and J. P. White of Salem, and two sisters, Etta and Elsie White of Salem. He leaves a widow and two daughters. Mrs. White comes from an old time family in this county, the Glascock family. Her mother, now Mrs. W. W. Smead of Heppner, has been here during Mr. White's illness, and for the past week Mr. Smead has been here also.

The death of Mr. White was not caused by influenza direct, but by some unusual complication, not pneumonia. Until Thursday he was seemingly on the road to recovery.

The body will be taken to Salem tomorrow for burial.

TAPS SOUNDED FOR COL. YOUNG

Until Recently Head of Willamette Soldiers; Oregon Losses Inspector

Col. George S. Young, for two months commander of the S. A. T. C. at Willamette university died at 6:30 Sunday evening at the post hospital, Vancouver barracks, as the result of influenza. Colonel Young had been ill for two weeks but left for Portland last week and expected to take up his new position of inspector-instructor of the Oregon National guard soon.

Colonel Young had been in the army service since 1875, when he was given a commission in the regular army by President Grant. He was at that time only a little more than 20 years old. He has seen service in Indian campaigns and served as a captain in the Spanish American war. In 1912 he was assigned to Vancouver barracks as colonel of the 21st infantry, where he remained until 1916. That year he was sent to the Philippines for the last time in command of the Eighth infantry.

In May, 1917, he received his discharge from service but in June was recalled and made head of the army recruiting in Oregon, which work he continued until October, 1918.

On November 1, he took charge of the S. A. T. C. of Willamette university. Colonel Young was born at Harpers Ferry, Va., May 17, 1854. He is survived by his widow, one daughter, Mrs. Henry G. Reed, who is the wife of Captain Reed, of Camp Lewis and one son, Captain Harold W. Young, serving with the Eighteenth engineers, railway, in France.

IRRIGATION IS TO HELP VALLEY

Farmers Near Turner Will Probably Move to Form First District Here

Willamette valley is likely to have its first irrigation district, State Engineer Copper announces following his return from a meeting of farmers near Turner, in this county, at which a project was discussed. The old Willamette Valley irrigated lands company constructed an irrigation canal between West Stayton and Turner and this will be the basis of the proposed new district. If the details are finally worked out. It is expected that about 15,000 acres will be brought under the district. Considerable argument has been advanced in favor of irrigation in the Willamette valley and in event the project is put through its success will be watched with keen interest by those who have been favorable to artificial crop production in this section.

BOLSHEVISM IS ON RAMPAGE IN UNITED STATES

New York Declared to Be Honeycombed Now With Trotsky Agents

BIG POT IS SENT OVER

Agents Come to Country With Pockets Lined With Gold of Red Russia

NEW YORK, Jan. 6.—Department of justice agents in New York who have been watching German securities in this city have been assigned to the work of frustrating the activities of five groups of Bolsheviks which have established headquarters here, it was announced tonight. The spread of Bolshevism was admitted to have become "alarming."

Coincidentally, Alfred L. Becker, deputy state attorney general, declared that his department has unearthed evidence that secret agents of Lenin and Trotsky have reached this city with a fund of nearly \$500,000 to be used for propaganda purposes.

These agents, it was said, have been circulating in work shops and factories, holding secret meetings, which culminated today in the opening session of a three-day convention in the Labor Lyceum building. Plans of the agitators are said to include a program for weaning away from the American Federation of Labor radical members of 45 unions throughout the country, who are to be urged to organize "workmen's councils" under the Lenin-Trotsky plan.

At the offices of the department of justice it was admitted that a card index of 2000 "red" agitators in this city, Chicago, Philadelphia, Detroit, Boston and other places has been compiled and persons whose names appear in this index are being closely watched.

SOUTH AFRICA SEEKS RULE.

LONDON, Jan. 6 (Via Montreal). The movement of the South African nationalists headed by General Hertzog for separate representation at the peace conference has been discouraged by the imperial government. Viscount Buxton, governor general of South Africa, has informed the nationalists that their resolution of voting separate delegates with a view to securing the independence of South Africa, was laid before King George, who referred it to his advisers. Walter Hume Long, colonial secretary, in communicating this information to the governor general, said the South African government and parliament alone can be regarded by the British government as authorized to speak for the South African people.

SILVER IS UNUSED

MEXICO CITY, Jan. 6.—Infinite annoyance to every resident and an appreciable loss to business houses has resulted from the virtual disappearance from circulation of silver coins. These comprise half peso pieces and those of twenty and ten centavos. The constantly increasing price of silver has given speculators a chance to make enormous profits by cornering the silver coins for sale as bullion. When the shortage became noticeable, the capital press printed stories on the disappearance of the coins. An immediate rush to hoard what coins remained began. Persons without change are unable to make small purchases as many merchants will decline to sell if they are forced to give silver change for a ten or twenty peso gold piece. The government, to relieve the situation, is rushing preparations to mint a new gold coin worth two and a half pesos.

Drake Athletic Director May Get Training Place

DES MOINES, Iowa, Jan. 6.—Captain John L. Griffith, former athletic director at Drake University here and since similarly engaged at Camp Dodge and Pike, has been selected to succeed Dr. Joseph E. Raycroft of Princeton, as chairman of the committee to training camp activities under the war recreation board, according to private advices received here tonight.

CROPS HIT IN ISLANDS.

MANILA, P. I., Jan. 6.—Heavy crop losses were sustained in the Philippine islands as a result of the typhoon that raged in the archipelago on Christmas day and night. This loss to hemp growers alone, it was estimated, would total \$2,000,000.

HIGHER SHOES—DITTO SKIRTS.

CHICAGO, Jan. 6.—Higher shoes for women in 1919, higher prices rather than reductions, and short skirts, are the views of the National Shoe Travelers' association as expressed in resolutions, tonight at the close of its seventh annual convention. dent Wilson said: "I am very much moved, to be in the presence of this monument. On the other side of the water we have studied the life of Mazzini with almost as much pride as if we shared in the glory of his history and I am very glad to acknowledge that his spirit has been handed down to us of a later generation. It is delightful to me to find that I am taking some part in accomplishing the realization of the ideals to which his life and thought were devoted. It is with a spirit of veneration, sir, and with a spirit of hope, of emulation, that I stand in the presence of this monument and bring my greeting and the greeting of America with our homage to the great Mazzini. In accepting the gift of Mazzini's works from the municipality, the president said:

"Mr. Mayor, it is with many feelings of a very deep sort, perhaps too deep for adequate expression, that I find myself in Genoa which is a natural shrine for Americans. The connections of America with Genoa are so many and so significant that in some sense it may be said that we drew our life and beginnings from this city. You can realize therefore, sir, with what emotion I receive the honor which you have so generously conferred upon me in the citizenship of the great city. In a way it seems natural for an American to be a citizen of Genoa and I shall always count it among the most delightful associations of my life that you should have conferred this honor upon me and, in taking away this beautiful edition of the works of Mazzini I hope that I shall derive inspiration from this volume as I have already derived from the principles which Mazzini so eloquently expressed. "May I not thank you, sir, for myself and for Mrs. Wilson and for my daughter for the very gracious welcome you have accorded us, and express my pride and pleasure.

Speaking at the monument of Columbus the president said: "Stand-

ing in front of this monument, sir, I fully recognize the significance of what you have said. Columbus did do a service to mankind in discovering America and it is America's pleasure that she has been able to show that it was a service to mankind to open that great continent to settlement, the settlement of a free people of a people, who because they are free, desire to see other peoples free and to share their liberty with the people of the world. It is for this reason, no doubt besides his fine spirit of adventure, that Columbus will always be remembered and honored not only here in the land of his birth, but throughout the world, as the man who led the way to these fields of freedom which, planted with a great seed have not sprung up to the fruition of the world."

REFEREE DIES
PHILADELPHIA, Pa., Jan. 6.—John J. McGuigan, a widely known boxing referee and match maker, died today at the Norristown hospital. He was 43 years old. McGuigan was until recently director of the National Athletic club in this city.
