Private Control Again Near for All Railroads

Because he believes the railroads are soon to be returned to private ownership, Judge C. A. Prouty, director of traffic in the office of the railroad administration, does not believe it is feasible to attempt any revision of switching charges affecting cases where shipments are transferred from one government controlled road to another in the same city. He expresses this opinion in a letter to the Oregon public service commission. The commission, acting on complaints from numerous shippers, asked for the elimination of the switching charges in Portland. Judge Prouty says that return of the roads to private ownership will probably cause a recurrence of the former competitive condition.

tee said, showed that the "dry" have captured only 28 states, or eight less than the three-fourths required. The fourteen states referred to are: Arkansas, California, Colorado, Idaho, Maine, Michigan, Missouri, Nebraska, Nevada, New Mexico, Ohio, Utah, Oregon and Washington. "The people in these 14 states under their constitutional referendum right are a part of the law making body," declared the distillers' statement. Until the people have voted upon the proposition there has been and can be no legislative action.

"This referendum is now a fundamental right of the people. It is intended that the people shall avail themselves of this fundamental right and that they shall vote upon the question whether inherent state powers and privilege and individual liberty shall be destroyed."

PLEA IS MADE FOR CHILDREN

Family of Representative and Mrs. Stannard to Be Sent to Relatives

Four children, all under 7 years old, were left orphans and with meagre support by the death of Representative J. R. Stannard of the Oregon legislature and Mrs. Stannard, and Representative T. J. Thrift of Coos county was before the ways and means committee last night to ask a small appropriation for transportation of the children to the home of relatives in New York. Representative Stannard died of influenza during the first week of the session. His death occurred at Bandon where he became ill while coming to Salem from Coos county. Mrs. Stannard died of the same disease a few days later. The committee has not yet acted on the request.

The joint ways and means committee last night made a tentative out of \$10,000 from the budget submitted by the Oregon Normal school of Monmouth, leaving the amount \$88,730, or \$14,442 in excess of the continuing millage appropriation of 1-25 of a mill. The cuts were \$4000 asked for the heating plant, \$1000 from the estimate of \$2000 for the library and \$4000 from the amount that the millage tax is estimated to produce for the next two years. President J. H. Ackerman of the normal school appeared before the board. Members of the committee were of the opinion that President Ackerman was unusually liberal in pointing out where cuts could be made if absolutely necessary.

In tentative action on the budget of the state fish and game commission the full amount of \$69,400 requested was allowed. F. W. Warren, a member of the commission; Master Fish Warden Clanton, State Game Warden Carl D. Shoemaker and representatives of the federal bureau and of the American Canning company spoke before the committee on the needs of the department.

Unanimous approval of the bill to remove state aid, including administrative expense, from the state accident commission was voted by the two committees. The bill is to be up for final action in the house today. The commission itself has recommended permanent removal of the state's assistance as far as the contribution of one-seventh of the amount paid in by employers and employees is concerned, but will agree to removal of administrative expense only as a temporary measure for the present biennium. The labor element in the house is said to be opposed to the bill. The one-seventh payment for the next two years amounts to \$680,000. Administrative expense totals \$300,000. By passing the bill with its attached emergency clause before February 1 an additional saving of \$30,000 a month for five months is possible, and that this saving may be made it is necessary to pass the bill this week.

Sumpter Valley May Get Needed Additional Revenue

A plan by which the Sumpter Valley railroad will be able to receive additional revenue has practically been decided upon which follows out a suggestion of the Oregon public service commission made in a letter of Commissioner Corey to Judge C. A. Prouty, director of traffic in the office of the director general. This will be a division of some through rate established by the Oregon-Washington Railroad & Navigation company and it is estimated that the Sumpter Valley will benefit to the extent of \$25,000 or \$30,000 annually, enough, according to Judge Prouty to enable the road to pay operating expenses and something on its bonds.

"The road under this arrangement," says a letter from Judge Prouty, "will be as well off as all roads under federal management taken as a whole are today on an average."
