Upon reconsideration yesterday the senate passed a bill introduced by the house committee on revision of laws giving workers the right of appeal to the courts from decisions of the industrial accident commission. This was H. B. 492 which was defeated the previous day.

Representative Lewis' bill creating a tax supervising commission in counties of more than 100,000 population, and a bill by the roads and highways committee of the house, providing for the filling of specifications by the highway commission, county courts and municipal corporations before receiving bids for road construction, were passed.

The senate concurred in house amendments to senate bill No. 69, introduced by Senators Pierce and I. S. Smith, and providing that the state pay the expenses in institutions of higher learning for returned soldiers, sailors and marines who wish to complete their education. The amendments exclude from the provisions of the act men who were only in training camps and exempt the act from the operation of the 6 per cent tax limitation. The measure will go on the ballot at the special election.

A resolution was adopted calling upon the secretary of state to provide lunch facilities for members and employees of the legislature two years hence.

Another house bill passed by the senate was that introduced by Representative Smith of Baker providing for the inspection of cattle hides and fixing fees. The bill is designed, Senator Pierce explained, to prevent the freemasonry of cattle.

Senator La Follette insisted on his bills Nos. 111 and 112, designed to abolish the position of state parole officer, being withdrawn from the table where they were placed yesterday. The first was voted down and Senator La Follette then moved the indefinite postponement of the other bill.

Five of the 22 were turned over to the immigration service for investigation service and the others were dismissed.

The men sentenced are: Lewis Shipman, six months; Andy Gaff, four months; George Ricker, four months, suspended; Sam Landerman, three months; William Holz, 30 days. All of the men were held on vagrancy charges and the two suspended sentences were imposed on condition that the men find employment.

Admiral Williams Will

Go on Southern Coast

SAN DIEGO, Cal., Feb. 27.—Rear Admiral George S. Williams has hoisted his flag aboard the cruiser Chicago and is now enroute to the east coast of South America to relieve Admiral William Caperton as commander of division one, Pacific fleet. Advises to this effect were received here tonight by the navy department.

Admiral Caperton will be relieved at Santos, Brazil, and will retire to private life as he reaches the statutory age limit in April.

The armored cruiser, Pittsburgh, Admiral Caperton's flagship, will be sent to New York and engage in carrying troops from France.

According to navy department advice, Rear Admiral William Fullam will be commander of all ships operating in the Pacific until summer. Rear Admiral Fullam announced here today that a flotilla of submarine chasers at the Azores is expected to pass through the Panama canal for San Diego next week. These chasers will be distributed to the various naval districts on the Pacific coast. A second flotilla of chasers will arrive from the war zone the middle of March and be conveyed to their stations in the Hawaiian and Samoan Islands.

SCHOOL FUND BILL PASSES

County Treasurer Will Disburse Moneys for Various Districts in Future

The bill by Senator Bell providing that the county treasurer shall disburse school district funds, passed the house yesterday after a most tempestuous career in that body. It had once been killed, then it was reconsidered and then passed.

It was finally amended so as to make it elective as to whether or not a county court should accept its provisions and in that condition it passed.

It is understood that the Marion county court, the school superintendent and the county treasurer are all in favor of the bill.

AUTO WORKERS TO TAKE TESTS

New Board of Examiners for Mechanics Required Under Legislative Act

A board of examiners of auto mechanics is one of the new boards created during the closing day of the legislature when the house passed the bill by Senator Shanks and Representative Stewart which provides for a board of three to examine auto mechanics and to issue licenses to them for an annual license fee of \$5.

The examinations are to be held at least quarterly and are to be at Portland, Eugene, Astoria, LaGrande and Klamath Falls.

It is expected that this bill will result in about \$50,000 in fees being turned into the road fund.
