SOLDIERS' AID BILL NEEDS A LEGAL OPINION

Deputy Secretary of State Kozler to Seek Advice from Brown

NEW ACT INDEFINITE Before Educational Bill Can Become Operative Must Be Further Defined

In view of the vague and uncertain provisions of the soldiers' and sailors' educational aid bill, passed by the people at the recent special election, Deputy Secretary of State Sam A. Kozler has requested an opinion from Attorney General Brown as to its intent and purposes of the act. His office is now receiving many inquiries daily concerning the measure.

In view of the fact that the provision of this measure are somewhat indefinite, it is not possible to advise inquirers just exactly what procedure is necessary on their part in order to secure any benefits accruing under the provisions of this act," said Mr. Kozler.

"In the first place, an institution of learning, public or private, as therein mentioned is nowhere defined. Further, the act provides that all honorably discharged soldiers, sailors and marines are granted the right and privilege of state financial aid to an amount not exceeding \$25 for any one month and not more than \$200 for any one year for a period of not more than four years. Yet it further provides that upon the approval of the soldier's application by the executive head of the institution he desires to attend, the secretary of the state shall pay over to such institution monthly, a sum not exceeding \$25, and the institution is required to provide lodging, board and other necessities required by such applicant to pursue the course or courses of study he desires.

Many of the soldiers desiring to avail themselves of the privileges and benefits of this act doubtless wish to maintain themselves, and further very few institutions of learning in the state are equipped to furnish board and lodging to students. It is with a view of reconciling the several apparently conflicting provisions, as well as securing a legal determination of the intent and purpose of the act that the attorney general's opinion has been requested.

"Under the existing conditions it is possible only for this office to provide inquirers with a copy of the law and advise them of the fact that its provisions are more or less indefinite and consequently referred to the attorney general for a legal determination. It is the desire to have the attorney define the scope of the law, an institution of learning as contemplated thereunder, how the funds and to what extent they may be available, as well as when the benefits thereunder begin to operate. In due course, publicity will be given the attorney general's opinion in order that all soldiers and sailors who desire to avail themselves of this act may be fully informed."

\$40,000 Fire Destroys Meat Plant at Albany


ALBANY, Ore., June 16.—A fire early Sunday morning almost completely destroyed the packing plant of the Neberghal Meat company just outside of the city, entailing a loss of about \$40,000. Approximately half of the loss was covered by insurance. The plant, which was constructed in 1915 had become one of the largest institutions of its kind in the valley. The company had spent \$10,000 the past winter for new machinery and equipment, most of which is apparently ruined. Roy O. Bushong, secretary of the company, has announced that the plant will be rebuilt at once.




