MEXICO TOLD ANNOYANCES MUST CEASE

Stern Note Sent Southern Republic Protesting Arrests and Molestation of Jenkins, Ransomed Consular Agent

OBJECT OF BANDITS IS TO "SHOW UP" POWERS

Official Believed to Be in Custody—Weakened Condition Worries

WASHINGTON, Nov. 20.—Mexico was warned today by the American government any further molestation of William O. Jenkins, American consular agent at Puebla, who recently was kidnapped by bandits, would "seriously affect the relations between the United States and Mexico, for which the government of Mexico must assume sole responsibility."

Jenkins was first arrested early this month on the charge of collusion with the bandits who took him from his home at Puebla on October 19, but he was released after remaining in the penitentiary two hours. He was restricted to his home however, and on Tuesday was re-arrested on complaint that he had threatened persons who had given evidence on which the state authorities acted in first taking him into custody.

So far as the department has been advised he still is held in custody and because of his weakened physical condition resulting from the hardships endured during the week the bandits held him in the mountains of Puebla state, officials feared long imprisonment might permanently affect his health.

DRY ACT IS TO STAY IN EFFECT

21 VETERAN CITIZENS SERVICE MEN GET VOTE NATIONALITIES VARIED

Union Pacific Thanked for "Haul" in Wire Signed "Carlisle" Field in Casper, Wyo.—Training Guards are Doubled

WESTERN UNION OFFICE AND PAPER ARE VISITED

Boast of Being "Greatest Robber in History" Is Recalled

CHEYENNE, Wyo., Nov. 20.—William L. Carlisle, train bandit, still is at liberty tonight. A telegram signed "Carlisle" filed in Casper, thanking the Union Pacific for the "haul" is the only additional bit of information today. Union Pacific officials said the telegram had not been received here.

Casper is being combed by police and sheriff's officers, a posse of 70 men is still searching the country around Medicine Bow aided by United States cavalry and other armed men are in readiness to leave Cheyenne on 10 minute's notice by special train in case of new depredations of the bandit are reported to headquarters of the Union Pacific railroad here.

Activity During Some detective force, the message purporting to come from Carlisle said. Last night the bandit was reported to have entered a Casper newspaper office to inquire about news of the train robbery. Descriptions furnished by Western Union employees of the man who filed the message at Casper and by the Casper editor tally with those of the bandit who robbed the Union Pacific passenger train Tuesday night. In Cheyenne the chief concern of Union Pacific officials is for the safety of passengers traversing this state, guards were doubled on trains yesterday and officials are confident that the bandit will attempt to repeat his exploits of 1916 when he held up three trains within a short period and "blatant" officers with telegrams and letters.

Boast Is Recalled Carlisle is known to have boasted that he is the greatest train robber in history. Officials are considering the possibility that Carlisle may try to leave the state for Montana or some other state of the northwest because in Wyoming train robbery is a capital offense.

PARTY HONORS R. E. WILLIAMS

G. O. P. National Committeeman Unable to Go East for Big Job

PORTLAND, Nov. 20.—Ralph E. Williams, Republican national committeeman from Oregon received a telegram from Will H. Hays, national chairman, asking him to go east and take charge of a political bureau until the convention is held. Mr. Williams has declined on the ground that private business obligations prevented.

"I don't mind going back and attending the meetings of the committee but it is impossible for me to give up my business for six months or a year, even though the department tendered to me 'one which I like,' declared Mr. Williams.

Oregon City Fire Not Incendiary, Is Report

After an investigation by George H. Allen, inspector for the state fire marshal's department, that department finds that the costly fire which recently destroyed a church and the Price Brothers store at Oregon City was due probably to a defective flue in the church and was not of incendiary origin.

Reports had reached the department that the janitor of the church was a disloyal radical and after looking into his record Allen reports that the man bears a good reputation in the community and that his loyalty is unquestioned.

DISCIPLINARY BARRACKS IS RAZED BY FIRE

LEAVENWORTH, Kans., Nov. 20.—Fires, which broke out tonight in the prison exchange building at the federal disciplinary barracks here at a late hour, had destroyed the exchange building and spread to the wooden cantonments near the large new cell house. The flames were spreading rapidly and efforts to check them failed. All officers at Fort Leavenworth and all the soldiers were ordered out to assist in keeping the prisoners in check.

SECOND CLINIC FOR BABIES IS GREAT SUCCESS

Nine Have Registered for Third Test to be Given in December

VOLUNTEER WORK HELPS Literature Is Distributed—Babes From Out of Town Examined

Salem's second eugenic clinic, conducted under the auspices of the Marion County Children's bureau held yesterday afternoon in the auditorium of the Salem Commercial club duplicated the success of the original clinic. Only 30 babies were examined, and in consequence the work was much more systematically and quickly done. There was no confusion and no crowding that was unavoidable at the first clinic when over 60 children were examined.

Mothers were given numbers upon arrival and these were referred to in making the work orderly. Booths were arranged for the different departments, and placards placed upon them, only one person besides the mother and child being admitted at a time.

Mrs. A. N. Flerel of Portland, president of the Oregon Congress of Mothers and Parent-Teacher association was present and further assisted in getting the local chapter upon a consistent running basis. The local nurses who lent their assistance were Miss Margaret Wishart, Miss Nell Hollenbeck, Miss Porter, Miss Roberts, Miss Florence Cauborn and Sister Helena and Sister Anna, both of the Deaconess hospital. A group of Salem women who have been active in the bureau work from the first also aided in carrying on the work yesterday.

A large number of books relative to prenatal and postnatal care were displayed on a large table, and Miss Flora M. Case, city librarian, was present to aid in the selection of the proper books for mothers.

All the official score cards have been issued to parents from the first clinic, the work of issuing them being a bit slow, owing to its newness to the local secretary who was requested to do all the work in compliance to a state regulation.

As only 30 children will be examined on future dates, it is necessary that application be made beforehand to the bureau's secretary, Mrs. F. Von Eichen.

"Jack" Johnson to Fight Morris in Mexico Soon

The bout will be in December, the exact date to be announced later, Jones said. It will be a finish fight.

11 ALLEGED REDS ARE UP FOR HEARING

First Degree Murder Is Charge for Men Held in Connection with Armistice Day Outrage at Centralia

TWO FUGITIVES STILL AT LARGE IN HILLS

Defendants Appear Without Attorney—Have 36 Hours to Plead

CENTRALIA, Wash., Nov. 20.—Eleven alleged I. W. W. charged with first degree murder in connection with the Armistice Day shooting here today were arraigned before Superior Judge W. A. Reynolds at Chehalis, the county seat, and given 36 hours in which to plead.

In addition to the 11, two other alleged radicals, Ole Hansen and John Doe Davis, are numbered among the defendants. Hansen and Davis, still at large, are being pursued by deputy sheriffs from here. The two, it is believed, are hiding in the hills not far from Centralia.

Grimm Murder Charged. The defendants were charged, specifically, with the murder of Lieutenant Warren O. Grimm, one of the four former American soldiers killed when alleged I. W. W. fired upon the Armistice day parade.

No attorney represented the prisoners today. The defendants will not be able to retain any Lewis county lawyers as the local county bar association has passed resolutions barring any of its members from taking part in the defense of the alleged radicals.

Hansen's Capture Expected. Work was expected tonight from three Centralia men who, at last reports, were on Hansen's trail. One report received from the posse said it was thought they had him surrounded in a thicket of woods near Rochester, Wash., where Bert Bland, another of the defendants, was captured Tuesday.

MR. OLCOTT IS MADE SHRINER

Preland Kendrick, imperial potentate of the order. The class was the largest ever taken into the local temple.

PORTLAND, Or., Nov. 20.—On suspicion of having committed a dozen recent burglaries, in residences here where women's clothing and jewelry were the chief loot, a woman described as 20 and good looking was being sought by the police today. She was surprised in the home of Mrs. P. K. Morse on the east side, when the mistress returned home suddenly and found her ransacking the place. The female burglar fled through a door which she had left open and escaped, according to Mrs. Morse's report to the police.

20 GALLONS OF BREW IS FOUND

Frank Day Charged With Having Liquor in Possession and Drunkenness

Frank Day is held in the county jail on a charge of having intoxicated liquor in his possession, and of being intoxicated, as a result of a raid participated in by Chief of Police Varney and Sheriff Needham. About 20 gallons of brew found in Day's hut near Brooks avenue, North Salem, has been allowed to trickle down the gutters, except for a gallon of the concoction which is held as evidence.

Day is said to have wobbled down South Commercial street Wednesday afternoon following an alleged drunken brawl and attracted the attention of an officer who arrested him. Following the discovery of quantities of liquor, which is claimed to have strong pungent qualities Day was held on \$200 bond for justice court. When arraigned before Justice Unruh yesterday, Day claimed his statutory right to plead and will appear before Justice Unruh tomorrow. Day claims that he was making vinegar but the liquor is thought to have been many degrees more vicious than vinegar has any right to be.

PALMER WARNED TO TAKE REST

Attorney General on Verge of Nervous Breakdown Report of Physicians

WASHINGTON, Nov. 20.—Attorney General Palmer was reported today on the verge of a nervous breakdown and under orders from his physicians to get away from work and take all the rest he needs. Mr. Palmer's physician has told him, it was said at the department of justice, "that unless he quits work for more than a week he would not be responsible for the consequences." It was explained, however, that this was not to be taken to mean that he was in a serious condition.

2 MEN HELD AS SUSPECTS NOT WANTED

Grilling Cross-Examination by Deputy Sheriff and American Legion Man From Centralia Absolves Coffee and Larson

REMARK IN BARBER SHOP WAS QUOTATION, CLAIM

No Connection Established Between Pair and Outrage on Armistice Day

After a grilling cross-examination by Centralia officers last night, Walter Larson and Ed Coffee, held here on a charge of making seditious remarks and suspected of possible complicity of the I. W. W. outrages, Armistice day, were declared not to be the men wanted. Deputy Sheriff Preston McDonald, and J. C. Hampe, American legion representative failed to find any resemblance in the two men to I. W. W. agitators still at large. In cross examination the two men gave versions of their travels that corresponded well with each other and when confronted by the officers the men held to their stories firmly.

Further cross examined as to the alleged remarks favoring the Centralia I. W. W. made in a Salem barber shop, the two men who have been kept in ignorance of the nature of the charges against them, gave a fairly satisfactory version of the affair. Walter Larson, who admitted that he talked to a barber concerning the Centralia incident, declared that any remarks he made concerning "the right American legion men having been gotten" was in reference to a newspaper statement which he was quoting. While this explanation did not quite satisfy the investigators, the other elements in the men's version were strongly presented.

Story of Rambling Told Coffee and Edwards told a story of rambling about the country in a Ford car which persisted in turning all of their resources. Starting from Seattle and stopping in Portland a few days, they claim they went on into the state of Washington in quest of work. Arriving in Centralia Sunday and being nearly out of funds, they claim that they slept in the car that night near an old vacant house in Centralia. The next day, being Monday they claim that they chopped and put in three cords of wood for a Centralia citizen and spent the next night in a barn. Then they say that they left the Washington town about 9 a. m. November 11, and did not hear of the I. W. shooting until that night upon their arrival in Portland.

After spending four or five days in Portland, the pair claim to have exhausted their funds in Salem and also the gasoline for the car. Then they decided to obtain temporary work for a few days and endeavored to negotiate a loan on the Ford. While endeavoring to do this, the pair excited suspicion as being possible auto thieves and were arrested. Upon their being turned loose the next day, Tuesday, November 13, they finally secured the \$5 loan on the car and the barber shop incident ensued.

AMERICAN LEGION GREATEST FORCE IN COUNTRY SAYS CENTRALIA MAN

Outrage Brings Out Power of Service Man According to J. C. Hampe

"The American Legion is the greatest force in America today and no one knows it better than we of Centralia who have learned its power through the Armistice day outrage," said J. C. Hampe of the Centralia, Washington, post of the Legion who, with Deputy Sheriff Preston McDonald, came to Salem last night to investigate the two men, Ed Coffee and Walter Larson, a resident here as suspected I. W. W.

"The men of our post are running things in Centralia," continued Mr. Hampe in conversation. "We have taken over the entire administration of the county and city for the emergency. Our police were inadequate to the situation—we have only three officers. We could not wait for the
