WILLIAM BOWEN, PIONEER, DEAD

Veteran Resident of County Crossed Plains from Missouri in 1853

William Bowen, a pioneer resident of Marion county, died Sunday afternoon at his home, 491 North Twentieth street. The funeral will be held this afternoon at 1 o'clock from the Rigdon chapel. Burial will be in Mt. Hope cemetery in the Waldo Hills.

Born in Monitor county, Mo., on August 4, 1844, Mr. Bowen crossed the plains in 1853 by ox team and settled near Silverton. Since coming to Oregon he has spent most of his life in the Waldo Hills. He was a member of the Willard Congregational church. In 1877 he married Miss Alice Poole.

He is survived by his widow and by four sons, A. L. Bowen and E. Bowen of Salem, C. E. Bowen of Dallas, and R. A. Bowen of Great Falls, Mont., two sisters, and one brother also survive him. Mrs. Rebecca Walt of Salem, Mrs. Carrie East of Silverton, and James Bowen of Silverton.
