

HUNS TO ANSWER FOR PART TAKEN IN WORLD WAR

Names of High Boche Officers to Be Tried by Allies Are Made Public

EXTRADITION IS SOUGHT

Many of Men Under Indictment Commanded Hun Troops in Long Struggle

BERLIN, Feb. 4.—Among the persons demanded for extradition from the German government are:

Some of the names in the list are distorted and the military or civil rank of the persons desired is not indicated.

The list contains, among others, the name of Hellfritz, which possibly is a telegraphic error for Dr. Karl Helfferich, former minister of finance. Up until six o'clock this evening the covering note to the extradition list had not been received. Both documents are believed to have been transmitted unofficially through the correspondent of the Wolff bureau at Versailles, since Baron von Lersner refused to accept them. A report is current here that the baron indignantly threw the note back at Premier Millerand.

The von Lersner episode created surprise here, as he said he had been instructed to forward the list directly to Berlin and not permit personal scruples to influence him.

Today, says the Taegische Rundschau, "marks the beginning of the extradition crisis and the very existence of the German empire depends upon the outcome of the entente demands."

TREATY SCORED AT DEMOCRATS

Reed, of Missouri, Would Eliminate America From Entire Proceedings

BOSTON, Feb. 4.—The peace treaty was attacked by Senators James A. Reed of Missouri and David I. Walsh of Massachusetts, in addresses tonight.

Senator Reed declared "that the only way the league of nations can be Americanized is to take America entirely out of it."

Senator Walsh said he believed the people were "overwhelmingly in favor of a league of nations" but that the league covenant ought not to be ratified "without the strongest possible American reservations."

The greater part of Senator Reed's address was devoted to the Viscount Grey letter.

"All Americans," he said, "may well hang their heads when they contemplate the fact that a large part of the American government has been insisting upon giving the British empire advantages of the league so unfair to the United States that a British statesman lifts his voice in protest."

CUBA IN FAVOR OF PEACE PACT

House Votes Ratification of Treaty Without Proposed Amendments

HAVANA, Feb. 4.—The house of representatives tonight voted ratification of the peace treaty with Germany without amendment. Only one negative vote was cast. The senate approved the treaty unanimously on December 8 last.

LAWS TO HANDLE RADICALS UP TO U. S. CONGRESS

Legislation Simple in Character Recommended by Attorney General

FREE SPEECH IS GUARDED

Federal Official Says Citizens Rights Should Be Protected to Last

WASHINGTON, Feb. 4.—Additional anti-sedition legislation, simple in character and guarding the guarantees of the bill of rights but covering the "hiatus in present statutory laws" was urged by Attorney General Palmer today before the house judiciary committee.

Upholding the right of free speech and constructive criticism, the attorney general protested against pending measures which he said were too drastic and far-reaching and so searching that they over-reach their purposes.

More harm than good would come from repressive legislation, he added. "But there is no existing statute adequate to meet the present situation," Mr. Palmer told the committee. "There is a condition of revolutionary sentiment in the country on the part of both aliens and citizens which is sufficiently widespread to merit serious consideration of congress."

This revolutionary intent is manifested chiefly by threats both written and spoken by persons who would injure, destroy or overthrow the government by physical force or violence. Citizens' rights should always be guarded, Mr. Palmer said, adding that he agreed with those who criticized the Graham-Sterling bill on this ground.

"But I do not agree with those who object to the bill because they believe that acts of violence should be met with argument only and not by the firm hand of federal statute," he asserted.

FIGHTER WOULD BATTLE BOCHE

Dempsey's Former Wife Admits Charges Against Husband Without Foundation

SAN FRANCISCO, Feb. 4.—The government investigation into charges of irregularities in connection with the classification of Jack Dempsey, world's champion heavyweight pugilist, under the selective service act, was continued here tonight following the interrogation of Mrs. Maxine Dempsey, divorced wife of the pugilist, by Assistant District United States Attorney Charles W. Thomas.

Thomas refused to divulge the nature of questions asked, Mrs. Dempsey, but San Francisco newspapers said she had presented to him a sworn statement in which she repudiated previous charges she was alleged to have made against her former husband. This affidavit stated, according to the newspapers, that Mrs. Dempsey and Dempsey's mother and father were dependent upon him for support, and that the pugilist had attempted to enlist on two occasions.

Six Foreign-Born Are Admitted as Citizens

Six foreign born residents of Marion county were granted the rights of United States citizenship in the examinations held at the county court house yesterday. Six other applicants for naturalization papers were continued. Citizenship papers were granted to Anton Plennert, native of Austria; John Ruscher, native of Austria; Herman Bernger, granted citizenship without filing first papers because he served in the United States army; John Marr, native of Scotland; Andrew Pederson, native of Norway; Katharina Schmidt, native of Russia; Henry Isherwood, native of England.

SERVICE COSTS ARE SOUGHT IN TROLLEY CASE

Traffic Expert Tells Commission There Is Nothing to Replace Streetcars

PRESENT FARE TOO LOW

Company Demands More Revenue Held Necessary to Meet Operating Expenses

PORTLAND, Feb. 4.—In the hearing today before the state public service commission on the application of the Portland Railway, Light and Power company for permission to advance car fares on its local lines, J. P. Newell, a traffic expert, told the commissioners that there is nothing in sight at present to replace street cars as public conveyances. Utility motor buses are shown by actual figures to be out of the question as a solution, hence the problem of financing the Portland Railway, Light and Power com-

pany comes down to a proposition of how much the service costs and how much is necessary per fare to meet operating expenses and whether anything may be done to minimize the present operating cost through one-way traffic or other expedient.

The present fare of 6 cents is held by the company to be inadequate for this purpose. Newell's testimony occupied the greater portion of the day.

President in Favor of Reasonable Reservations

CASPER, Wyo., Feb. 4.—President Wilson is ready to accept "any reasonable reservations" to the senate treaty. Senator John B. Kendrick of Wyoming told the Democratic state central committee, meeting here today. He predicted adoption of the treaty and league of nations covenant by the senate next week.

LIQUOR VESSEL WILL BE FREED BY INSPECTOR

Yarmouth, Carrying Big Cargo of Booze Encounters Rough Waters Outside

FEDERAL OFFICIALS ACT

Captain Says Much of Contraband is Thrown Overboard on Return Voyage

NEW YORK, Feb. 4.—The steamer Yarmouth with its \$4,800,000 cargo of whiskey seized yesterday by prohibition inspectors, will be released and allowed to sail for Havana, it was announced tonight, following a telephone conversation with the attorney general's office in Washington.

While this conversation was in progress the federal grand jury began investigating the shortage in the Yarmouth's cargo which developed between her sailing from and returning to New York.

The Yarmouth sailed for Cuba with a heavy load to starboard, resulting from hurried efforts to load the ship before midnight, January 16. She ran into rough weather and was forced to return to New York. Her captain explained that 500 cases of liquor were thrown overboard before she turned back.

EX-SERVICE MEN ARE UNDER TEST

Profit Sharing Plan for Soldiers Declared Practical and Very Popular

SAN FRANCISCO, Feb. 3.—The plan used by the United States army to place every recruit where he would do the most good is being tried in a modified form in Pacific coast industries by a group of former army officers, psychologists and specialists in vocational training and employment problems.

These specialists have organized a non-profit bureau with Captain J. Vid Hauser, formerly chief psychological examiner at Camp Kearney, as president. The organization has undertaken surveys of the employment problems of the several large business houses including three big department stores, a street railway company and several other concerns.

It offers to give intelligence tests to employees and applicants for positions, to prepare scientific application blanks for each concern. It seeks to eliminate excessive labor turnover over attendance upon the ordinary haphazard method of employment.

Research work is being carried forward dealing with experiments in industrial democracy, profit sharing, plans for making the lazy employee work and plans for established promotion schedules, regular complaint channels and other means for reducing discontent.

Wilford E. Talbert of the bureau of personal research of the Carnegie Institute of Technology is director of the bureau here. The staff includes Dr. Roy W. Kelly, director of vocational guidance at Harvard university; Lieutenant C. C. Stech, psychological examiner at Camps Dix, Funston and Logan; Lieutenant A. S. Otis, psychologist and statistical analyst for the surgeon general's office; Major Lewis M. Terman, professor of education at Stanford university, and Dr. Ira B. Cross, chairman of the economics department of the University of California, consultants.

Maitea and Moorea Are Scene of Bad Twister

SAN FRANCISCO, Feb. 4.—The islands of Maitea and Moorea of the Society group, were swept by a cyclone and tidal wave the night of January 23 with the loss of many lives on Maitea, according to news reaching here today on the liner Tofua.

The information came to the Tofua by wireless from Papete, on the island of Tahiti, to Thomas B. L. Layton, American consul at Papete who was on his way home to the United States.

Wage Question Is Far From Final Settlement

REVOLUTION IS PREDICTED BY SOCIALIST RED

Rights of Ex-Service Men Declared Limited in Wake of Social Unrest

LEGION MEN IN ACTION

Judiciary Committee Denies Motion to Strike Out Testimony of Woman

ALBANY, N. Y., Feb. 4.—Testimony that Charles Solomon, one of the five suspended socialist assembly men being tried by the assembly judiciary committee on charges of disloyalty, had predicted that the four million ex-service men in the United States would be unable to check the socialist "revolution" was given today by William R. Hart, a Brooklyn attorney, who was defeated by the assembly by Solomon last fall.

Hart declared Solomon had made his prediction after he himself had stated, if the socialists were ready to start their revolution, "let them go ahead," that he belonged to the American legion which "soon will have four million in its membership, and that nothing would please us more than to sit on the seat of a machine gun and give them a reception."

In reply, Hart testified, Solomon said: "There will be nothing which will be able to hold the wrath of the working class in check. They will be able to sweep aside like chaff in the wind the opposition of four million men. What right have ex-service men to hold in check the destiny of 100,000,000 people in this country?"

The judiciary committee today denied a motion by a member to strike out as "obviously impossible" the testimony of Miss Ellen B. Chivers that Solomon spat on the American flag in war time in the presence of police officers.

ROTARY CLUB TO BEAUTIFY ROAD

Thousands of Trees Will Be Planted Along Highways of Southern State

WASHINGTON, Feb. 4.—The first Rotary club in the country to report plans for a road of remembrance to the American Forestry association, which is registering all memorial trees in a national honor roll, is the organization at Tampa, Florida. At a cost of \$7000 a tree will be planted along the west coast road for every man in the service from Hillsborough county.

At Middletown, Ohio, the Welfare association will plant 1000 trees along the Dixie highway next spring and at Chattanooga, the National League for Women's service will plant a road remembrance leading out of that city. In Minneapolis a road remembrance between two parks is being laid out now and the trees will be planted in 1921. The Woman's club of York, Pa., will plant 25 miles of the Lincoln highway with memorial trees.

LONDON, Feb. 4.—An official information is forthcoming on the result of the cabinet's discussion of the exchange problem, but according to unofficial reports the government favors the calling of an international finance conference, sitting preferably in London.

Former Premier Asquith, in a speech at Paisley tonight declared that the governments of Europe and the United States could meet in a great economical conference from which no nation should be excluded whether allies, enemies, or neutrals.

Red Cross Members To Be Released by Reds

WASHINGTON, Feb. 4.—Ludwig C.A.K. Martens, representative in this country of the Russian soviet government, made public today a cablegram he had sent to Max Litvinoff, assistant commissioner of foreign affairs, now at Copenhagen, advising that American Red Cross personnel, recently captured in Siberia, be released unconditionally. Pending that action, Martens said in a statement he wished to assure relatives of the Americans that they would be treated with every consideration.

Stock Markets Disturbed By Exchange Conditions

CHICAGO, Feb. 4.—Material declines in the corn market today were due for the most part to sympathy with the demoralization of sterling exchange. Opening prices, which ranged from quarter to 1 3-4 cents lower, with May \$1.33 1-2 to \$1.34 and July \$1.30 5-8 to \$1.31, were followed by a moderate further set back.

After opening 1-4 to 5-8 cent off, including May at \$1 1-2 to \$1 3-4, oats continued to sag. Provisions were pulled down by the fresh breaks in exchange.

COURT REFUSES TO QUASH CASES AGAINST EILERS

Action in Bankruptcy to Have No Bearing on Criminal Indictments

JUDGE RULES IN CASES

Defendant Faces Four Counts One Charging Him With Larceny of Piano

PORTLAND, Feb. 4.—Bankruptcy proceedings in federal court in which Hy J. Eilers, Pacific coast piano dealer, is involved, have no bearing on his prosecution by the state on charges of embezzlement, nor will the disposition of civil suits in which Eilers is a party affect the criminal prosecutions.

This was the answer of District Attorney Walter H. Evans today to the plea of Attorney Ralph R. Dunaway, who appealed to Evans to dismiss one of the four indictments charging larceny by embezzlement, returned against Eilers early last fall, for the reason that the acceptance of a voluntary non-suit by the Northern Trust company, Monday cleared Eilers.

Eilers was indicted on four counts after an extensive investigation by the district attorney's office, one of the indictments charging him with the larceny of a piano. This piano formed the basis of the suit dismissed by the Northern Trust company and on this ground asked that the indictment be dismissed.

Two Persons Are Dead As Result of Rioting

LIMERICK, Feb. 4.—Two persons are dead as a result of the rioting here Monday night when demonstrators clashed with an armed military patrol and constabulary. Richard Dwyer, a publican, was killed, and Lena Johnson, a young woman who was wounded by a shot, died yesterday.

The authorities withdrew the military patrols last, confining the troops to their barracks. The motion picture theaters were closed and in some of the Catholic churches the people were advised to keep off the streets, which they did.

Hayward Would Enter Team in Big Events

PORTLAND, Feb. 4.—A request that William (Bill) Hayward, veteran trainer of the University of Oregon track teams, be taken to the Olympic games at Antwerp next summer as one of the coaches of the American track and field men, was made today by T. Norris Dunne of this city to the secretary of the Amateur Athletic union. Dunne has charge of choosing northwest candidates to the American team which will compete at Antwerp.

Because there has never been a trainer from the northwest taken to the Olympic games and because of Hayward's record in developing talent, Dunne said he expected the Oregon coach would be chosen.

COUNCIL AGREES TO PAY DEFICIT CAUSED BY WAR

Contractor Loses \$67,000 in Construction of Auditorium at Portland

MANN JOINS MAJORITY

Councilmen Declare Deficit Due to Rapid Advance in Materials and Labor

PORTLAND, Feb. 4.—Arbitration of the moral claims against the city of the bondsmen for Han Pederson, a contractor who built the municipal auditorium for \$76,400, became assured today, when City Commissioner John M. Mann announced that he would vote in favor of the proposal, thus insuring a majority vote of the council for it.

Pederson claimed to have expended \$67,000 more in building the auditorium than he received for his work, and to be unable to meet his obligations to that amount, thus placing the liability on his bondsmen. The deficit he said, was due to changes in the original specifications ordered by the city. The bondsmen do not profess to have a legal claim against the city, but ask that it assume liability for the \$67,000 as a matter of right.

A majority of the councilmen now have announced themselves in favor of having this question arbitrated.

Roseburg Takes Steps to Curb Flu Epidemic

ROSEBURG, Feb. 4.—Drastic action to stamp out influenza in this city was taken by the city council at its regular session last night when a resolution was adopted closing all public places of assembly for a period of two weeks. The order was effective today and no dances, religious assemblies or public funerals will be permitted. The school board also held a meeting at the same hour, passing an order closing the public schools in the city for a like period.

The decision to close the town followed a conference of Mayor Hamilton and Health Officer Dr. Shoemaker, and other physicians here.

Hands Up, She Routed Bank Robbers by Ringing Alarm With Her Foot

The four bandits, startled by the clanging of the gong, rushed from the bank to an automobile in which were two more men and the six made their escape.
