

MUSIC FEAST MARKS END OF PERFECT DAY

Old Time Song Preferred to Oratory by Delegates at Attendance at Democratic National Convention

PALMER BOOM EXPLODES AFTER BRIEF UPROAR

Factional Differences Are Forgotten and Delegates Vie in Party's Interest

SAN FRANCISCO, June 30.—Lifted out of itself by hours of oratory, old songs that tugged at the heart strings and the throbbing appeal of a mighty pipe organ, the Democratic national convention brought nomination day to a tremendous emotional crisis that had nothing to do with candidates or platform issues.

Factional differences were forgotten, political jealousies were swept aside, and from the seething tumult on the floor to the singing, cheering thousands in the packed galleries, the vast assembly gave itself up at intervals without stint to a great brotherly reunion as unexpected as it was overwhelming.

The scene was unparalleled in the memory of the oldest convention observer.

Even before the convention was called to order before noon, the hall was touched with the hint of what was to come. Roosters for Palmer and for Cox had come armed for a great demonstration.

Applause is liberal.

High against the wall of the western gallery, a red-coated band from Ohio was placed, trotted by a solid block of roosters who got into action before the delegates had filled more than half their seats.

When the first nominating orators had been heard and the names of Senator Owen, former Ambassador Gerard and Senator Hitchcock, had been placed on the ballot amid liberal applause, Florida yielded to Pennsylvania and the name of A. Mitchell Palmer was presented to set the convention on its wild ecstasy of singing and cheering.

Up in front of the platform a long, slim, red-headed yell leader waved frantic arms from a rickety perch on a chair, while a California woman in white drove the demonstration forward with almost equal vigor. The shouting of the Palmer adherents grew and swelled until a Georgia delegate with the state standard started the march of states.

The tumult lasted more than half an hour. Around and around the aisles the procession went, the standards bobbing awkwardly high over the heads of the marchers.

On the platform a score of Palmer women crowded to the speaker's stand waving flags, while the band joined heartily in the songs, which were caught up all over the hall and galleries.

CONVENTION TURMOIL FAILS TO STIR PROPOSED CANDIDATE

Former Director General of Railways Unaware of Honor Paid Him at San Francisco Gathering

HUNTINGTON, L. I., June 30.—A reporter reached the McAdoo home shortly after word was received that the former secretary of the treasury had been the subject of a tumultuous demonstration in the auditorium at San Francisco.

At the front door a maid answered the bell and took a note to Mr. McAdoo's room. Written by the reporter it told of the nominating speech and asked:

"Will you accept the nomination?"

She soon returned with the information that all members of the family were asleep.

Employees at the McAdoo home said when Mr. McAdoo retired shortly after 10:30 o'clock he apparently was unaware that his name had been placed before the convention.

THREE BURNED IN PLANE FIRE

Villa Followers Dynamite Train

EL PASO, Tex., June 30.—Followers of Francisco Villa dynamited a southbound passenger train from Chihuahua City, near Armerdaz, shortly before noon yesterday, captured and executed a federal officer, but were finally driven off, according to a report made public today by Luis Montes Oca, consul for Mexico here. Ninety-five passengers on the train escaped injury, it was said.

Several federal soldiers were captured and a lieutenant executed, according to the report.

Two or three Americans were reported on the train.

Jazz Selections Disturb Sleepers, Says Complaint

ELLA WILSON SLATED FOR FAIR BERTH

Woman Long in Public Service May be Named to Succeed A. H. Lea, Secretary of State Fair Board

FAIR APPLICANT IS CHOICE OF OFFICIAL

James Linn Said to be Only Member of Board Opposed to Woman Secretary

The next secretary of the state fair board and manager of the Oregon state fair will be a woman. She will be Mrs. Ella Wilson, who for five years has been assistant secretary, having served one year when the late W. A. Jones was secretary, and for the last four years with A. H. Lea, present secretary, who has submitted his resignation to the fair board. Mrs. Wilson's home is in Salem.

That Mrs. Wilson will be the choice of the board is a virtual certainty, since it has become known that she is the choice of at least four of the five members. She will receive the votes of J. E. Reynolds, A. C. Marsters, W. H. Savage and J. D. Farrell. It is doubtful if Mrs. Wilson will receive the support of James R. Linn, the Salem member of the fair board, who is believed to be favorable to Frank Meredith for the secretaryship.

Woman Gets Support

Mr. Lea has declined to recommend any person as his successor, and said yesterday he did not know who the choice of the board would be, but that whoever it is, the new secretary will receive his assistance and co-operation until after the next state fair, which will be in September.

There is a possibility that Mr. Lea will make the 1920 state fair. This depends mainly on the wishes of the board. If Mrs. Wilson is chosen as his successor, now regarded as certain, she will be able to shoulder the responsibility at any time the board sees fit to place it upon her. Mr. Lea resigned to accept the vice presidency of the Bankers' Mortgage corporation of Portland, and his affiliation with that firm will demand at least a part of his time prior to the next fair. He had expected to begin his new duties July 1, but was prevailed upon by the fair board to remain with the board for a few weeks longer.

Election Date Remote

A date for the election of Mr. Lea's successor has not been fixed. The selection of Mrs. Wilson will not have the approval of Governor Olcott, since with Mr. Linn, he is believed to be favorable to Meredith. However, the executive has nothing to do with the choice of the secretary of the fair board except through the executive appointment of members of the board, and at the present members, with the exception of Mr. Linn, are appointees of the late Governor Withycombe. Under the law the governor has power at any time to remove members of the board arbitrarily and put in their places persons of his own choosing. Only in that way could Governor Olcott influence the selection of the next secretary. Such a move, however, is believed to be beyond the realm of probability at this time, since it would have a disrupting influence on the coming fair.

Removal Not Expected

Except by the removal process, Governor Olcott will be unable to gain control of the fair board before March, 1922. There are five members of the board. Last March the term of M. L. Jones expired, and the governor appointed in his place his close friend, James R. Linn. He will have another appointment in March, 1921, when the term of A. C. Marsters expires, and another in March, 1922, when J. D. Farrell's term expires.

PORTLAND TRIO HELD FOR FRAUD

Starr Fruit Company Head Arrested for Profiteering in Sugar Manipulation

PORTLAND, June 30.—Parrott & company, Richard Adams, its agent; the Starr Fruit company and L. M. Starr, its president, were indicted by a federal grand jury today charged with profiteering in the manipulation of sugar.

The indictment charged that the concerns bought several cars of sugar from a San Francisco refiner for the alleged purpose of preserving fruit here, but that instead they transhipped the sugar to Omaha and other interior cities, where they sold it at an alleged profit of \$4000 a carload.

SALEM UNIT AFFECTED BY MILITARY RULING

COMPANIES OF LESS THAN 50 MEN BARRED FROM JULY ENCAMPMENT

Adjutant General Sends Protest to War Department—Few Companies Able to Qualify Under Order

Unless the war department recedes from a ruling made recently prohibiting units containing less than 52 men from attending annual encampments on federal pay, not more than two or three companies of the fifth infantry regiment, Oregon national guard, will go to Camp Lewis next month, according to announcement made by Adjutant General George A. White here yesterday.

Orders for the encampment of field infantry, Oregon national guard were issued Tuesday by the adjutant general and sent to unit commanders in all sections of the state. Under these orders the encampment was to start on July 6 and continue until July 20. Units included in the order were all companies of the fifth infantry, three coast artillery companies, staff corps and Company A engineers. Oregon towns and cities to be represented at the encampment included Portland, Salem, Medford, Ashland, Marshfield and Newport.

Yesterday a wrench was thrown in to the guard machinery when a telegram was received at the adjutant general's office to the effect that only those units having a minimum of 52 men would be allowed to go to Camp Lewis on federal pay. It also was stated in the telegram that the militia bureau had ruled against consolidation of units and the transfer of men from one unit to another.

Adjutant General White last night sent a telegram to Washington protesting against the militia bureau order, and asking that it be held in abeyance until after this year's encampment. Commanders of the various units included in the call for encampment call will be asked to join in the protest.

HIGHWAY CLAMOR TO BE SATISFIED

Capitol Highway Association Organized at Meeting Held Salem Last Night

A central organization to be known as the Capitol Highway association was organized last night in the Commercial club rooms by the representatives of the residents of Benton, Linn and Marion counties.

For sometime residents of Yamhill county, of those living in the district west of Salem, and of the southern Willamette valley have been clamoring for a highway that would make the connection to Portland more direct. The object of the meeting last night was to perfect plans for such a highway.

The tentative plans as outlined at the meeting is to have a paved highway connecting the residents of southern Willamette valley coming north to West Salem and thence connecting up with the paved road north of Salem on the west side.

Several plans for the routing of the road were presented at the meeting but none were acted upon for the object of the meeting was not to consider any particular route, that the main object of the meeting, as one of the speakers said, "to consider plans for a road." After having perfected a road for a road, then the Capitol Highway association is to consider the merits of any particular routing. The main object at this time is to consider a road.

All agreed at the meeting that plans for some road should be taken first, rather than to go off on a tangent and consider, or enter into controversies about routings. To discuss at this time, they said, and consider claims of particular localities might defeat the object and purpose of the meeting.

The officers for the permanent organization to be known as the Capitol Highway association for the ensuing year are as follows: I. N. Patterson, president; A. J. Johnson of Corvallis, vice-president; T. E. McCroskey of Salem, secretary-treasurer.

By action of the organization three directors were authorized to be elected from each county involved in the proposed highway. The directors elected are: W. H. Malone, J. O. Wilson and C. E. Ingalls of Benton county; A. H. Steiner, H. Herschberg and Andrew Miller of Polk county; F. J. Miller, H. H. Hewitt and J. M. Hawkins of Linn county; has, Parke, T. B. Kay and Percy Varney of Marion county; R. J. Moore, W. S. Allen and D. A. Snyder of Yamhill county.

An executive committee is to be elected that will present the plans of the Capitol Highway association to the state highway commission. Under the plans of the organization seven members are to be appointed by the president from the directors.

MARINE INSURANCE HEAVY

WASHINGTON, June 30.—Formation by 15 insurance companies of three marine insurance syndicates for the purpose of underwriting American vessels to the extent of \$2,500,000 on a single risk, was announced tonight by Chairman Benson of the shipping board. Organization of the syndicates was prompted by threatened refusal of British companies to continue their risks on American ships.

PARTY HEADS GIVE M'ADOO BIG OVATION

Dr. Burris Jenkins Places Mr. McAdoo in Nomination Over Protest of Candidate—Few Words Are Wasted

LEADER DRAFTED INTO SERVICE, IS CHARGE

Balloting For Highest Office in United States Expected to Start Early Today

SAN FRANCISCO, June 30.—Seemingly in a matter that William G. McAdoo was the inside track on the Democratic presidential nomination tonight, attempts were being made within the inner circle of old line Democratic party leaders to prevent his selection by the convention. The plan includes prominent consideration of Champ Clark, former speaker of the house of representatives, as a candidate.

SAN FRANCISCO, June 30.—William G. McAdoo was placed in nomination for the presidency late this afternoon at the Democratic national convention in one of the shortest nominating speeches on record by Dr. Burris Jenkins of Kansas City.

Dr. Burris Jenkins took the platform at five thirty o'clock and the McAdoo demonstration started on the floor.

Speech is Eliminated.

Jenkins told the convention he had intended to make a nominating speech for McAdoo, but on account of persistent and insistent requests from him that he name be not presented in a speech, I have decided not to do so.

"I am sure that from the spirit manifested in my delegation and in this convention that we shall draft him for the service of the country," said Jenkins.

"We know that if so drafted he will accept the nomination," said Jenkins, "and any rumors of acceptance supposed to have been received from him that he would accept the nomination are falsehoods perpetrated by the enemies of our party. I therefore place in nomination William G. McAdoo."

Silence Declared Best.

After Cox, Palmer, Gerard, Cummings, Hitchcock and others had been placed in nomination, Jenkins took the platform and told the convention that in view of the persistent and insistent demands from McAdoo that no nominating speech be made for him, he would accede to that request, but that it might be necessary to "draft him for the service of the nation."

Any rumors that McAdoo would not serve if nominated, Jenkins told the convention, could be dismissed as the "work of enemies."

Jenkins merely said: "I nominate William G. McAdoo, and the pent-up enthusiasm of the McAdoo forces broke loose in a loud and noisy demonstration."

After the nominating speeches for Governor Cox were finished, W. Bourke Cochran of New York took the platform and delivered a nominating speech for Governor Smith.

Senator Robinson finally got order after the tumult had been going on for almost an hour.

D. Roosevelt, assistant secretary of the navy, seconded the nomination of Governor Smith.

He got a crash of applause when he told the delegates that their nominee "will not be selected at 2 a. m. in a hotel room." And when he finished the New York delegation led in another round of cheering.

The nomination also was seconded by Mrs. Lillian R. Sore of New York.

Demonstration in Sight.

John W. Davis, ambassador to Great Britain, was the only man on the list of those for whom nominating speeches were to be made who was not reached on the day's program. The ten candidates placed in nomination were Senator Owen of Oklahoma, Attorney-General Palmer, Senator Hitchcock of Nebraska, Homer Cummings, chairman of the Democratic national committee; William G. McAdoo, Governor Smith of New York, Governor Edwards of New Jersey, Secretary Meredith, Governor Cox of Ohio and James W. Gerard, former ambassador to Germany.

The big demonstration of the day came with the presentation of Palmer, Cox and McAdoo, although there was a spontaneous outburst with the presentation of Governor Smith.

The Cox and Palmer demonstrations were fully expected and looked for, but the McAdoo nomination coming after days of uncertainty as to whether a nominating speech was to be made for him or not, added an element of interest and surprise. It was easily the loudest, longest and most tumultuous demonstration of the lot and kept the convention in an uproar for the best part of an hour.

Situation is Explained.

Dr. Burris Jenkins of Kansas City who was ready to place the former

DRIVERS' LICENSE IS MENACE TO TOURISTS

NON-RESIDENTS IN DANGER OF ARREST UNDER PROVISIONS OF LATEST ACT

Legislature Will Be Asked to Pass Amendment to Present Law at Next Session

Under the provisions of the so-called motor vehicle operators' license law passed at the special session of the legislature last January, there is nothing to prevent over-zealous police officers of Oregon from arresting all non-resident automobile tourists who enter the state unless they comply with the act and obtain a driver's permit. This was made known last night by John Cochran, assistant secretary of state, following a conference at which the Oregon license law was gone into thoroughly by Attorney General Brown.

This wording of the law is specific, according to Mr. Cochran, and provides that all persons over 16 years of age who drive motor vehicles in Oregon shall provide themselves with a license. The only exemptions are those of chauffeurs and motor cars registered in other states.

Although it is not expected that the police officers will go so far as to arrest non-resident automobile tourists who pass through the state, it was stated here yesterday that the next legislature would be asked to pass an amendment to the present law. This amendment will provide that only residents of Oregon shall take out these licenses.

JULIEN HURLEY FACES CHARGES

State Senator From Malheur Is Accused of Falsifying to Homestead Entries

PORTLAND, June 30.—Julien A. Hurley, state senator from Malheur county, Or., was indicted today by a federal grand jury charged with subordination of perjury. Hurley is alleged to have persuaded five witnesses in a homestead contest to give false testimony in favor of Zella Becker, one of the contestants and Hurley's client.

New York Governor to Investigate Schwartz Case

Governor Olcott last night received a telegram from Governor Al Smith of New York in which the latter executive said he had instituted an investigation of the release there of Milton Schwartz and that some definite action might be taken by the New York officials within the next few days. Schwartz was arrested in Portland last night on an insanity charge and was committed to a private hospital for treatment.

In New York he was accused of tormenting little girls, but was given his freedom upon the promise of his relatives to take him to Oregon.

SUGAR TAKES DROP

SAN FRANCISCO, June 30.—All sugar allotments placed on sale here today were quoted at \$22.75 a hundredweight, refiner's price, a drop of 25 cents since yesterday.

Sugar has been declining steadily since it reached its maximum of \$26.30 a hundredweight, refiner's price, a few weeks ago.

FIGHT WAGED IN ADOPTION OF PLATFORM

Reports Indicate That Injection of Wet Plank Is Remote—Drys Plan Support for Eighteenth Amendment

LEAGUE OF NATIONS STARTS REAL BATTLE

Tentative Planks Deal With Situation in Mexico and Protection for Labor

SAN FRANCISCO, June 30.—A long and bitter platform fight to-night confronted the resolutions committee when it assembled at 7:30 o'clock to take up the tentative platform draft of the sub-committee of nine headed by Senator Glass of Virginia, chairman. The full committee was prepared to sit well into the night in the hope of reporting the platform to the convention tomorrow afternoon and having final action taken in time for balloting on candidates Friday.

Reports came from the sub-committee at 7 o'clock that it had finished work drafting the tentative platform and would be ready to submit the draft to the full committee at 7:30.

The platform ballot was confined to three subjects—prohibition, the league of nations and the Irish question. On the other numerous planks little difficulty was in prospect.

Tentative Draft Fuzzies.

The sub-committee, while the full committee was in recess, worked at top speed all day to finish its tentative draft for the entire committee's consideration tonight. Finally, in order to save time and realizing that the issues would have to be fought out by the whole committee, the sub-committee decided to pass along the three principal problems, with only a tentative agreement on the proposed planks.

In the liquor fight, indications tonight, as the fighting forces assembled, ere for exclusion of any pronounced wet declaration. And incorporation of some pronouncement sustaining the 18th amendment. Administration forces were reported endeavoring to build a situation where an "administration plank" would rally a majority. Administration leaders declared the plank would be regarded as "slightly moist" through a clause criticizing vexatious and unnecessary restrictions of personal liberty in prohibition enforcement coupled with approval of President Wilson's veto of the Volstead law.

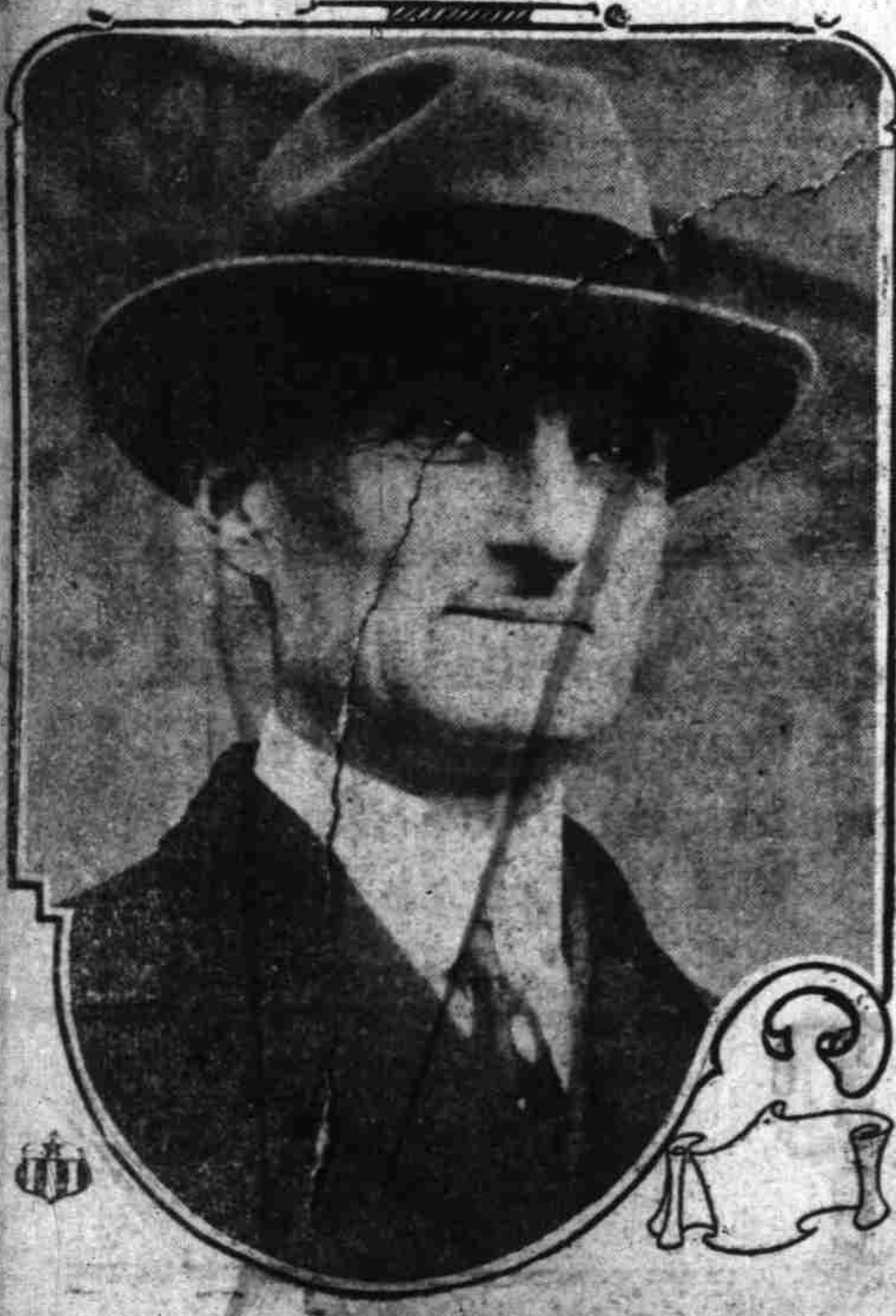
Bryan Is Conspicuous.

William J. Bryan and other drys went into tonight's meeting, however, girded for a battle to wedge in a square-toed prohibition mandate. A strong movement to keep all mention of the liquor question from the platform also was on foot.

Another pitched battle impended on the league of nations. The sub-committee, except Senator Walsh of Montana, was reported solid for the administration plank, presented by Senator Glass, Secretary Colby was
