That religion is at times retroactive and does not always bring peace and happiness was indicated in a complaint for divorce filed yesterday in the county clerk's office in the case of Sam Iungen against Elsie Iungen.

Also that she has spent much of her time reading literature from this sect thus neglecting her home duties as a wife. She has, he claims, on several occasions accused him of possessing hands "tainted with blood" and with working for "the devil." His wife does not approve of his interest in charitable institutions because "they are of the devil."

### MORE HELP NEEDED OF POSTOFFICE

#### Civil Service Examinations to be Held in Salem Starting on July 24

Postmaster Huckestein announces that there will be civil service examinations at the local postoffice for mail carriers and postal clerks. Salaries for these positions range according to grade 1, 2, 3, 4, 5 and 6. Beginning with the first grade the pay is from \$1000 to \$1500.

More carriers are to be employed in the local office. The present corps of carriers, as are the mail clerks, are overworked. The mail for Salem is unusually heavy and its distribution takes the present force.

The civil service examination will be held at the postoffice on July 24, 1920.

Another item announced by Postmaster Huckestein that is of interest to the public is the matter of writing the return address on the letter sent, or on the package to be mailed.

Any letter that is unclaimed and for the lack of the return address on the envelope necessitates mailing it to the dead letter office will cost the sender 3 cents for its return, if the sender desires the letter returned to him. The same regulation applies to unclaimed letters without return addresses on them.

### Mrs. Luella Darby Passes After Lingered Illness

### LEAGUE TO HAVE SOUTH AMERICAN QUESTION UP

#### Strip of Country as Large as State of California Bore of Bitter Contention

### PARAGUAY DISAGREES

#### American Peace Experts Collect Data Concerning Small Bit of Land

BUENOS AIRES, June 29.—The famous Tacna and Arica dispute, involving Chile, Peru and Bolivia, is not the only South American problem which may go before the league of nations for settlement. There has existed for years a controversy between Paraguay and Bolivia over a strip of territory in the heart of South America as big as the state of California. This, it is understood, is on the program for consideration by the league.

It is probably not generally known, that when the American peace experts, under Colonel House, collected their data on world problems for use at the Paris peace conference, they included a report on the issues between Bolivia and Paraguay over the possession of this territory, which is called on Bolivia maps the Bolivian Chaco, an on Paraguayan maps the Paraguayan Chaco.

The case of the Chaco is known to have been also brought before the conference by the Bolivian peace delegate, Senator Montes. It was decided, it is understood here, to

### BABCOCK LAUDS PACIFIC COAST

#### Salem Looks Good To Former Resident After Long Residence in New York

C. D. Babcock arrived in Salem last night from Spruce, N. Y., and will make his home in Oregon. He drove through as far as Spokane, Wash., with his daughter, Miss Glenna, and Mr. and Mrs. H. P. Roeder (Grace Babcock). Miss Glenna left the party at Livingston, Mont., and came on to Salem by rail and Mr. Babcock came from Spokane by rail. Mrs. Babcock and little daughter, Vera, came all the way from the east by rail and have been here about three weeks.

Mr. Babcock was a resident of Marion county for about eight years, leaving here in 1917 for the east where he has held responsible positions at Detroit and in New York state. He was at one time city editor of The Statesman, publisher of the Stuyton Mall, Corporation clerk and member of the industrial accident commission. He has not fully decided what work he will take up in Oregon but has fully decided to make this state his permanent home. He says he was well treated in the east but both he and his family have been spoiled for living anywhere except on the coast.

These problems hold for Bolivia, hemmed in on all sides by other states, the realization of her great political and commercial ambition, her own territorial outlet to the sea. Possession of the port of Arica would give her an outlet to the Pacific, and, curious as it may seem, possession of the Chaco, or at least a part of it, would give her access to the Atlantic. For the Chaco borders the great River Paraguay, affluent of the River Plata, and on the Chaco side of the river, 2000 miles from Buenos Aires, is a little port called Bahia Negra. Here ocean steamships from the United States and Europe could take on cargo transported across the northern edge of the Chaco from the Bolivian mines and farms.

But in the year 1886, a few years after Bolivia had lost in war the Pacific port of Antofagasta and was turning her eyes eastward, Bahia Negra was seized by Paraguay and has been in her possession ever since. Paraguay, furthermore, has made land allotments in the Chaco, whose unsurpassed pastures and great quebracho forests were beginning to attract the white man. A mysterious, unexplored land, stretching northward from the Pilcomayo river on the Argentine border and westward from the River Paraguay into undisputed Bolivian territory, it has not been directly crossed by white man since the days of the Spanish conquerors, since the year 1548, to be exact. Except near the rivers, it is inhabited only by savage Indian tribes to this day, but both nations looked forward to its possibilities, which recently have included that of finding petroleum.

Bolivia protested the seizure of Bahia Negra and also made land allotments in the Chaco. It is true that Bolivia had an eastern outlet already by the River Paraguay, but her commerce had to go through the Brazilian river port of Corumbá, a little north of Bahia Negra, moving down from the Bolivian city of Santa Cruz by mule team, along the northern edge of the Chaco, as it still does.

To uphold their claims, both governments unearthed rusty archives in Madrid dealing with the expeditions of the Spanish conquerors and the land grants of the Spanish crown

in South America. Various diplomatic negotiations have been initiated between the two governments from time to time looking to a division of the territory, but either one congress or the other refused to ratify the agreements which the diplomats drew up.

The report of the American peace experts on the question was placed in official archives against the time when the league of nations was ready to take the matter up. Much of the material, it is learned, was supplied by a young American sent to South America to investigate and whose private opinion is that a logical settlement of the dispute would be an equal division of the territory, but which would give Bolivia her coveted port.

There are interesting possibilities in the settlement for those who have received land grants in the Chaco from one government or the other. Some of these are vast in extent. One citizen from Argentina has secured in Paraguayan territory sole title to an area larger than Holland and Belgium combined.
