

ROBERT BEAN QUITS BOARD OF REGENTS

Heppner Man Appointed by Governor Olcott to Succeed Federal Judge—Duties of Judge Multiply Rapidly.

NEW REGENT WELL AND FAVORABLY KNOWN

Retiring Official Lauds College in Letter of Resignation to Governor.

C. E. Woodson, of Heppner, yesterday was appointed a member of the board of regents of the University of Oregon; he was a member of the board of regents of the University of Oregon, but resigned. Announcement of Mr. Woodson's appointment was made by Governor Olcott.

Mr. Bean was president of the board of regents, but was compelled to resign, according to his letter to the governor, because his official duties as United States district judge are such as he is unable to give the affairs of the university the attention they demand.

Mr. Woodson, successor to Judge Bean, is a prominent attorney of Heppner. He is a graduate of the University of Oregon; was a member of its faculty, as was also Mrs. Woodson, and his children attend the university as well. Mr. Woodson was also a member of the last legislature and the Republican nominee from his district to succeed himself in the coming legislature. He is one of the best known citizens in his section of Eastern Oregon. Before Mr. Woodson's appointment, there was but one Eastern Oregon man out of the ten members on the board.

In his letter of resignation to the governor Judge Bean had the following to say:

"I hereby tender my resignation as a member of the board of regents of the University of Oregon to take effect at your pleasure.

"I do this with reluctance. I have been a member of the board since 1882 with the exception of an interval of four years, and president since 1899. During that time, I have had a modest part in directing the development and growth of the institution from one unimproved building, a teaching force of seven, and an attendance in the collegiate department of 72, and an annual income of \$12,000 to an institution with fifteen well equipped buildings, 25 or more well organized departments in charge of an able and efficient teaching force, an attendance on the campus of 1700 and an assured income of approximately \$800,000. I therefore regret to sever my connection with the institution, but my official duties are such that I find myself unable to give the time and attention to the affairs of the university which its interests now imperatively demand. I am unwilling to occupy any public position unless I can give the best that is in me to the discharge of the duties thereof.

"My interest in the institution will continue, and I sever my connection with it knowing its income will continue in able hands, and that its future growth and influence are assured."

JAPS TAKE LAST RUSSIAN PORT

Possession of Bay Gives Japs Control of All Rail Terminals.

WASHINGTON, July 7.—Possession of the last of the first rail harbors on the Asiatic coast north of Port Arthur remaining in possession of Russia, has passed into the hands of Japan, according to official advice received here today which reported occupation of the town by Japanese troops.

The harbor of Possiet bay, 75 miles southwest of Vladivostok and part of Russian Siberia, was considered for a time by Russia as the logical terminal of the trans-Siberian railroad in preference to Vladivostok on account of the excellent facilities offered by its natural position.

Possession of the bay, together with other ports occupied by the Japanese this year on the Asiatic coast, according to official advice, gives Japan not only all salt water terminals of the Manchurian and Siberian railway, but every possible future terminal.

1921 CONVENTION IN ASTORIA
MARSHFIELD, Or., July 7.—Astoria was chosen today at the final session of the convention of the Spanish-American War Veterans of Oregon, as the place for holding the 1921 convention. Delegates to the convention and that of the woman's auxiliary, held simultaneously, were entertained today with automobile trips to the beach.

MEXICAN SITUATION GIVEN CAREFUL STUDY PROVISIONAL GOVERNMENT ASKING RECOGNITION

American Officials Impressed with Evident Sincerity of Provisional President.

WASHINGTON, July 7.—The Mexican situation is receiving more careful study by the American government than has any subject since the Paris peace conference, it was stated today at the state department. This is with a view to according recognition to de la Huerta's provisional government, provided satisfactory assurances are given that it can and will maintain order and will live up to its obligations respecting the protection of the lives and property of foreigners.

Iglesias Calderon, the special envoy sent by de la Huerta to ask recognition, will ask for another conference with acting Secretary Davis as soon as he has discussed the situation with the members of his staff who have just arrived here from Mexico City.

American officials, it is stated authoritatively, are impressed with the evident sincerity of the expressions of Provisional President de la Huerta and of the efforts to bring about order in Mexico, but they have taken note that the active workers in the various departments of the Mexican government have not been changed and that the newly appointed cabinet officers leave the work of their officials chiefly to the same men who conducted the affairs under Carranza.

BRIDGE CLOSED OVER SANTIAM

Ferry Boat to Replace Span Pending Completion of New Structure.

The bridge over the Santiam river at Mehama was closed last Tuesday and will remain closed until the completion of the new steel bridge. The county commissioners have ordered the construction of a ferry boat for the use of the traveling public. The ferry boat will be ready for service in about a week.

The work on the steel bridge over the Santiam at Mehama has begun, and the contractors say the bridge will be ready within three months. Travel over the road will be resumed as soon as the ferry boat is completed.

In the meantime, says Commissioner Hunt, the routing to Mehama from Salem goes through Stayton and then to Mehama on the Linn county side of the river.

IMMIGRATION BOARD IN S. F.

Congressional Committee Begins Hearings on Jap Question.

SAN FRANCISCO, July 7.—The immigration and naturalization committee of the house of representatives arrived today to begin hearings here Friday in regard to the subject of Japanese and Chinese immigration. Other hearings will be held later at Sacramento and Fresno. Governor Stephens and Senator James Phelan will be among the witnesses called. It was announced. Congressman Albert Johnson of Washington heads the committee. The other congressmen are Walter N. Valle of Colorado, John C. Kleczka of Wisconsin, John E. Raker of California, Riley J. Wilson of Louisiana, E. Sabath of Illinois, John C. Box of Texas and J. W. Taylor of Tennessee.

PACKERS AGAIN IN THE TOILS

Indicted on Federal Grand Jury on Charge of Profiteering.

BOSTON, July 7.—Indictments charging profiteering in food were reported here today by a federal grand jury against E. C. Swift and company, Armour and company, N. E. Hollis and company and the Independent Sugar company of this city. The indictments are the first returned in New England for alleged food profiteering.

The Swift indictment charges that 17 cents was received for beef which cost the corporation only 10½ cents a pound, yielding a net profit of 6½ cents. The Armour company, it is charged, sold New Zealand lamb which cost 3 and a fraction cents for 25½ cents a pound. The Hollis company, according to the indictment, charged 18 cents for beef which cost only 10½ cents a pound. The indictment against the Independent Sugar company charges that the corporation sold for 24.2 cents sugar which cost it 16 cents a pound.

COURT BOUND TO LEVY TAX FIXED BY LAW

Justice Johns Holds that Discretionary Taxes Are of Secondary Consideration in Making up Budget.

SCHOOL DISTRICT IS DEFEATED IN ACTION

Court Holds that County Superintendent in No Way Levies Tax.

County courts in making up their annual budgets of taxes, should take care of mandatory levies in preference to those levies of a discretionary nature, according to Justice C. A. Johns, who, in a supreme court opinion given yesterday dismissed the action brought by school district No. 24 of Marion county to compel W. M. Smith, county superintendent, to turn over to that district certain funds raised in excess of the six per cent limitation law.

In making up the tax budget last December the Marion county court, according to Justice Johns, made a levy of \$8.25 per capita of school children of school age in the county, when the law specifically provided that this tax shall be \$10 per capita. Other items of the budget contained levies for market roads and for other improvements discretionary with the court.

Opposition is voiced. Later, when opposition was voiced to cutting the school levy to \$8.25 per capita instead of \$10 per capita as provided by law, the county court levied another tax sufficient to make up the deficiency. Collection of the latter tax was enjoined in the circuit court here on the grounds that the amount raised was in excess of the six per cent limitation law.

School district No. 24 later brought mandamus proceedings in the supreme court to compel Mr. Smith, county superintendent, to apportion to that district funds raised through the second levy of \$11.75 per capita. This suit was opposed by Mr. Smith on the grounds that his authority was confined to apportioning funds raised for school purposes, but that he was in no way connected with the levying or collection of the tax. His contention was upheld by Justice Johns.

Justice Johns opinion, which was concurred in by other members of the court, made it plain that it is the duty of the county courts to first make provisions for taxes fixed by the law, and then discretionary levies of the total, not to exceed the six per cent limitation. The opinion, it is said, is of general interest as it applies to tax levying methods in every county in the state.

WIFE IS JILTED; SEEKS DIVORCE

Mrs. Hazel Huege Says Husband Swore at Her and Life Unbearable.

"Your hubby is an ex-con. How do you like that?" This sentence uttered frequently before her, together with inhuman treatment and heaping of indignities upon her was the basis of a complaint for a divorce case filed at the county clerk's office yesterday by Hazel N. Huege against H. G. Martip Huege.

She alleges in her complaint that her husband had no consideration for her feelings. He swore and uttered other unconventional epithets, she declares in her complaint, at her when in the presence of company. This conduct of her husband, she states, injured her feeling and was the source of much humiliation. It made life unbearable; hence her suit for a divorce.

The couple were married in 1917 in Salem and have one child, a daughter. In her complaint she seeks custody of the baby girl and a suitable amount for the support of the baby.

Turkish Treaty Clauses Must Remain as They Are

SPA, Belgium, July 7.—The important clauses of the peace treaty with Turkey will remain as they are, it has been decided by the supreme council in session here. At this morning's meeting the council decided it would be impossible to grant the Turkish request for the revision of these clauses. A commission of experts will be appointed, however, to study the minor clauses with reference to a partial revision of the document so far as these are concerned.

ROBBERS SWOOP DOWN ON CITY CAMP GROUND

MONTANA MAN LOST WATCH AND SOME LOOSE CHANGE

Officers Notified But Are Unable to Find Any Clue to Person Responsible.

Finding the campers at the city automobile camping grounds an easy prey on a previous occasion was perhaps the motive for the visit of a night prowler at the camp last Tuesday night when small losses were reported at the police station on Wednesday morning. It was a lean night for the visitor for he gathered in only two watches and about \$5 in silver.

J. H. Jensen of Missoula, Mont., turned in a call about 1:45 in the morning to the police station and said he was robbed of a watch and \$5 in silver. B. H. Bradshaw stated that he lost a watch from his pants pocket.

PALMER NEXT IN LIME LIGHT

Investigation Committee to Delve into Campaign of Attorney General

CHICAGO, July 7.—The senate committee investigating pre-convention campaign expenditures plans to "dive" thoroughly into the campaign of Attorney General A. Mitchell Palmer, before adjourning its hearings. Chairman Kenyon said tonight. In this connection Edward F. Goltz, of St. Louis, Democratic national committeeman, and Joseph T. Davis, a St. Louis lawyer, have been subpoenaed.

In addition to questioning Davis and Goltz, the committee will investigate charges filed today by William Armstrong, Chicago lawyer, that the department of justice had been instrumental in granting pardons to alleged criminals who might help politically and had blocked prosecution by the government of the persons trying to gain several hundred thousand dollars by illegal means.

Mr. Armstrong's documents consisted of a printed book of 52 pages. Mr. Armstrong charges the department of justice with attempting to "prevent indictments being returned against the New York Central railroad by a federal grand jury" and said "a Democratic member of congress" agreed with "a certain person to obtain \$227,178.13 from the government on post-war claims if given 25 per cent."

Details of his charges are expected to be brought out later. Mr. Goltz is in San Francisco, it is said, and may not be able to reach here for several days. If he can get here this week he will appear before the committee immediately but if delayed, he probably will be called at another hearing. Senator Kenyon said.

Swiss Papers Say Germans Aim to Evade Treaty Terms

GENEVA, July 7.—Several Swiss newspapers including the Democrite, say that Germany should be obliged at Spa to make known what amount of German capital has been placed in different countries since the armistice. They assert that Germany has deposited 200,000,000 Swiss francs in Zurich banks, ostensibly for commerce, and it is reported that similar deposits have been made elsewhere.

The newspapers charge that these deposits are designed to evade the financial clauses of the treaty of Versailles and support the contention of Germany's impoverishment.

RURAL WORK IS SUBJECT OF PASTORS

School for Rural Ministers Opens at Willamette University—Dr. Edwin Earp Dean of Summer School.

CHURCH IS STUDIED FROM ALL ANGLES

Carl Gregg Doney, President of Institution, Conducts Interesting Discussions.

The school for rural pastors of western Oregon and southern Washington conducted in cooperation with the department of rural work of the board of home missions and church extension of the Methodist Episcopal church is now in session at the Willamette university. The sessions commenced July 5 and will conclude July 24.

About 50 rural pastors are in attendance to gain information from the expert instructors. The aim of the summer sessions is to encourage rural pastors to seek greater efficiency, to have a broader ministry and thus be able to give more effective service. This branch of the home mission bureau was created by the Methodist Episcopal extension department about two years ago, growing out of the realization for greater leadership in the rural districts.

The school for rural pastors exists that it may give the training and information needed by the rural clergymen of America in solving problems that come before their charge. Edwin Earp in Charge. Dr. Edwin L. Earp, professor of Christian sociology and rural leadership in Drew Theological seminary at Madison, N. J., is the dean of the summer school for pastors. He conducts the classes in rural sociology.

Rural church methods are under the direction of Dr. Edward Laird Mills, editor of the Christian Advocate, of Portland. Andrew Warner, pastor of the Methodist Episcopal church of Sunnyside, Washington, assists in this department.

Women's work in rural communities are discussed by men and women from Oregon Agricultural college of Corvallis. They are: Paul V. Marks, director of extension service; W. L. Kaderly, assistant county agent leader; Jessie D. McComb, state home demonstration leader; Dr. H. McPherson, professor of rural economics; A. G. Lunn, professor of poultry husbandry; Lattie Lane, nutrition demonstration agent; A. L. Peck, professor of landscape gardening; R. V. Gunn, farm management specialist; Jessie Biles, clothing demonstration agent; and E. B. Fitts, dairy specialist.

Doney Leads Discussions. Carl Gregg Doney, president of Willamette university will conduct the discussions about "The Preacher and His Message." Dr. H. J. Talbot will assist in the lectures.

No classes are conducted in the afternoon, this being devoted to recreation, athletics and swimming. This part of the work is under the charge of Paul Doney. The rural pastors will play their baseball games on Sweetland field.

The evening sessions are devoted to lectures by prominent men of the summer school faculty.

U. OF O. TRIO GO TO BOSTON

Will Compete in Final Tryout for Olympic Games at Antwerp.

EUGENE, Or., July 7.—Trainer "Bill" Hayward of the University of Oregon, left today with his trio of star athletes, Tuck, Foster and Bartlett, for Boston where they will compete in the final tryouts for the Olympic games at Antwerp. The party goes by way of Portland and Seattle, thence by steamer to Vancouver where they will take the Canadian route for the eastern seaboard. By this route Hayward hopes to obviate the rigors of the overland journey incident to travel over a more central trip through the humid midwest.

The tryouts are scheduled from the 17th to the 27th of this month. Hayward said he feels assured that his men will make good if the climatic change is not too trying.

Prof. Hale of University of Illinois Comes to U. of O.
URBANA, Ill., July 7.—Prof. William G. Hale, for nine years, instructor in the law school at the University of Illinois, has tendered his resignation, effective September 1 and will accept the position of dean of the college of law at the University of Oregon.

SATURDAY LAST DAY TO FILE ARGUMENTS

CHARGE PER PAGE IN VOTERS' PAMPHLET INCREASED

More Than 350,000 Pamphlets Will Be Necessary to Cover the State in Belief.

Saturday, July 10, is the last day on which arguments favoring any constitutional amendments and measures to be submitted to the voters at the general election on November 2, may be filed by the persons or associations initiating or proposing them, according to announcement made by Sam A. Koser, secretary of state.

Arguments opposing any of the amendments or measures may be filed with the secretary of state not later than July 20. With every argument filed, whether they be for or against the proposed amendments or measures, there must be deposited with the secretary of state \$150 for each page of space required in the voters' pamphlet. Prior to the primary election held on May 21, a charge of \$100 a page was made for space in the voters' pamphlet, but because of the increased cost of paper and labor, it was necessary to increase the rate to \$150 a page.

Based on the present registration of voters in Oregon it is estimated that 350,000 of these pamphlets will be necessary to comply with the law regulating their distribution.

JOHNSON WILL SUPPORT TICKET

Harding Much Pleased over Californian's Announcement.

MARION, O., July 7.—After several weeks spent in preliminary preparation, Senator Harding today began the actual writing of his speech to be delivered on July 22, before the republican presidential nomination. He expects to complete it in about ten days during which time he plans to see but few visitors. The announcement made by Senator Johnson of California, that he would support the republican ticket greatly pleased Senator Harding when informed of it today. The statement did not come as a surprise however.

"I am glad Senator Johnson is going to give the ticket his support," the republican nominee said. "I am glad to know of everybody's support," he added, "and I would rather have support on the grounds that our platform is appealing than on the grounds of interest in the nominees." Senator Harding added that throughout the campaign he intended to emphasize "interest in party." "It is going to be a bid in the campaign," he said, "to elect the Ohio senator." Attention was called to statements attributed to Governor Cox, democratic presidential nominee, that he planned an intensive campaign with an extended speaking tour through the country.

"I should imagine he would but that does not change my plans any," Senator Harding said. The senator today received a letter from Herbert Taft, editor of the Cincinnati Times-Star, pleading to him the support of that publication as well as the "Taft family."

Trading in Grain Futures to Be Resumed on July 15

CHICAGO, July 7.—An advisory committee composed of representatives of all wheat interests today accepted the report of the committee representing the leading grain exchanges, calling for the re-opening of trading in wheat futures on July 15. The report provides that there shall be no trading in deliveries beyond March or this side of December.

The advisory committee also discussed the transportation situation as it affects the marketing of wheat. It was decided that the exchange committee composed of two representatives from each of the eight grain states should remain a permanent organization to take up any problems that may result from the re-opening of trading after a three-year's suspension.

MAN OBJECTS TO FIGHTING TO SAVE WIFE

Austrian, up for Naturalization Gets Scoring When He Says He Would Not Battle Under Any Circumstances.

THREE OF FOURTEEN FOREIGNERS GET BY

Several Would-be Citizens Temporarily Restrained from Getting Honors.

On naturalization day in circuit court only three out of 14 applicants received the coveted honor of American citizenship. Nine were instructed to continue their studies until the next naturalization day in circuit court, which will come on September 29. Only two applicants were denied the citizenship.

The following having fulfilled the requirements of the federal naturalization bureau were granted the franchise of American citizenship: Hertrand Iverson of Silverton and a native of Norway; Edward Joseph Ward of Salem, a Canadian, and Bernhard Paul Johnson of Silverton; he is a native of Norway. Wilfred Lawrence Baker of Portland was granted his papers of citizenship. Mr. Baker served his full enlistment in the navy and received an honorable discharge. This fact, the court considered as sufficient evidence indicating that the applicant would defend the constitution of the United States.

Man Unwilling to Fight. "I would not fight under any circumstances," was the statement of Herman H. Keunzi, an Austrian, when asked by Judge G. M. Bingham if he would take up arms in defense of the United States constitution. "Wouldn't you fight if your wife was attacked?" queried the judge.

"No, I would not fight under any circumstances," was his ready reply. The court denied his application, saying that should the applicant give his oath that he would defend the constitution of the United States in time of danger, he would be committing a perjury. The concluding remarks of the magistrate was for him to remain ever faithful and devoted to his religious beliefs, for he is a violent, conscientious objector, and that if he did live such a life, the same constitution that he declared on the stand he would not defend in time of danger would protect him.

Admission Is Denied. Philip Carston Strange was denied citizenship because his petition was not properly verified. The court granted him the privilege to file a new petition should he so elect. The other applicants were temporarily restrained from gaining the highest honor in the land—American citizenship—because of lack of requisite knowledge. They created a favorable impression to the examiners and American citizenship will be granted to them in due time.

Some Are Continued. These were continued for further study: William Lentz, a Russian, of Salem; John Zahler, a Swiss, Salem; Albert Clark and Anders Peter Jackson were continued by their own requests; Frank Calaba, an Austrian of Salem; John Filosa, an Austrian of Turner, continued for non-appearance; Leo George Seifers, a Hungarian of Silverton.

The citizenship papers of Frank Eechout of Woodburn is to be withheld from him until the return of an affidavit from the office of the federal naturalization bureau at Washington. He served in the A. E. F. across the seas.
