

AMERICANS WIN OLYMPIC SHOOT

Win Both Team and Individual Matches Using Regular Army Rifle

BEVERLOO, Belgium, July 31.—The American marksmen using the American army rifle against 13 other teams have, by the unofficial score, won both the team and individual matches in the Olympic classic free-for-all rifle competition.

Other teams used for the most part high power hunting and target guns. Although all scores are not in, it appears America leads in the team shoot with 4,876. Norway scored 4,743; Switzerland, 4,699; Denmark, 4,640; Sweden, 4,591; France, 4,478; Italy, 4,319; Holland, 4,376; Greece, 3,927.

Rainy weather greeted the marksmen when they began shooting.

Following are the American individual scores:

Fisher, 976; Osburn, 978; Spooner, 976; Lee, 985; Ponton, 960.

Fisher is believed to have won the individual championship. His score, 997, so far as returns show, is only approached by that of Larsen, a Dane, who had 985. Osburn's 978 has not been beaten for third place.

The best shooting by the Americans was in the kneeling and prone positions. They were beaten by the Danes in the first round, standing position.

The official result will not be known until tomorrow, but it is not likely to change the relative position materially. Conditions of the match, called for forty rounds for each man standing, forty rounds kneeling and forty rounds prone. The best possible individual score was 1200; the best team possible 6,000.

The individual American scores were made up as follows:

Fisher, standing 288; kneeling 361; prone 348—total 997.

Osburn, standing 280; kneeling 347; prone 351—total 978.

Spooner, standing 306; kneeling 328; prone 342—total 976.

Lee, standing 277; kneeling 347; prone 341—total 965.

Ponton, standing 267; kneeling 343; prone 350—total 960.

The original rule provided for teams of six men but this was changed to five.

"WHEREAS, Salem lodge No. 336 does not hesitate to assume the responsibility for any act or deed authorized by or with the approval of said lodge, and

"WHEREAS, certain just criticism has been made in the public press, condemning the acts of divers persons who, during the said state con-

vention committed disgraceful and unlawful acts in public places in the City of Salem, and

"WHEREAS, attracted by the large crowd of people brought to Salem by the holding of said state convention, there gathered many questionable characters who took advantage of the occasion to carry on their nefarious and unlawful practices, and

HARDING GIVES FIRST SPEECH OF CAMPAIGN

Theme Is Plea For Solidarity of Purpose and Mutual Understanding

MANY DEMOCRATS THERE

Would Reduce Excess Tax to Peace Basis With All Possible Speed

MARION, O., July 31.—Turning from the political issues in the forefront of the campaign, Senator Harding took for the theme of his first front porch speech today a plea for solidarity of purpose and mutual good understanding among all classes and geographical sections.

Only a spirit of "commingling friendship," he said, could produce the full realization of mutual interdependence necessary to attain the nation's highest destinies. He pleaded for west, north and south and the jealousies of class and selfish interest be forgotten in peace as in war.

The nominee declared the excess profits tax schedule should be modified to accord with peace requirements and that he would not hesitate to ask congress for prompt action. He added, however, that he was "not yet prepared to suggest an equitable substitute."

The speech was delivered to a delegation from Mansfield, Ohio, which came up in marching order and serenaded the candidate with four bands.

In the crowd were many known personally to the candidate and they cheered him as he held up their conception of neighborliness as a model for the nation. In a short address of greeting E. B. Capeller of Mansfield told Senator Harding that many democrats were in the delegation.

"We ought to make wealth bear its full share of taxation," he said, "and we ever will. Having thought in mind and also thinking of the excessive cost of living, I doubt if the excess profits tax for war was precisely accomplished the end we seek in peace."

"I would gladly recommend a change, but I am not yet prepared to suggest an equitable substitute, though I should have no hesitancy in asking congress to seek the earliest possible solution."

The league of nations he did not refer to directly but he declared the nation's "highest duty is to cling to the fundamentals on which we build—to world astonishment and hold fast to the nationality which inspired our onward march."

"It is with a keen sense of delight that I welcome your visit today," said Senator Harding.

"We need to cultivate friendliness and neighborliness. I sometimes think in this busy, workaday world we are neglecting those little acts of neighborliness that make life sweet and worth while."

"I feel myself almost a part of Richmond county. Our people, early in the last century settled in a section that was bounded by Richland and Crawford counties and my earliest recollections are of grists taken to Lexington for grinding. I recall distinctly the stories of my great-grandmother, who related to me how she had often gone with one of her sons on horseback while the men were busy in the fields, and the cries of the wolves were a frequent accompaniment to the weary homeward journey. That was in the days when heroes were without fame's acclaim, when a sturdy manhood and womanhood were battling with the wilderness."

The special thought in my mind today is the interdependence and the mutuality of interest of all our people. The Pilgrim Fathers laid their eternal foundations of new world liberty in grim necessity, and the same spirit, the same concord, the same mutuality followed every pioneering step in the development of the republic.

"The tendency to class consciousness is a product of developing fortunes and is both a reflex of achievement and a menace to maintained progress. We must caution against class distinction and class conflict at every step."

In recall 40-cent wheat, flayed from the fields of Richland and Morrow. That was before industry developed the home consumer, that was before railways and improved highways opened the way to markets. That was when farming was a fight for subsistence, instead of the present day pursuit of attainment.

"I trust no one will misquote me as saying I believe in 40-cent wheat, because I have indulged by memory. Sometimes we are very unfair in handling the utterances of public men. I remember when the senate was discussing the war time guaranty on wheat, when we felt we ought to give the American farmer that assurance which would encourage a seedling to guard against war famine, a western senator was arguing that wheat could not be raised for less than \$2.50 a bushel. I interrupted him to say that I well recalled that Ohio farmers in pre-war days had rejected to get \$1 for their wheat. I was speaking of normal days prior to the war. You will bear no witness that I spoke fairly and correctly. Yet there are those today who seek to convey that I said a dollar a bushel is enough for wheat today."

"I pardon the diversion. I am recalling the old time low level of prices, to recall at the same time the people's inability to buy, and to remind you that mounting farm prices, mounting wages, mounting expenditures—all are inseparably linked, and a grim mutuality will ultimately assert itself no matter what we do."

"There is no living today or tomorrow according to the standards of yesterday. Every normal being is looking forward. Only a little while ago our grievances about taxes were wholly local, because a half

century of Republican control of the federal government held us free from direct burdens. But the new policy, the democratic drift to freedom of trade which is international rather than national, and mounting cost of government and finally war burdens, turned federal taxation into a colossal burden."

"No one seriously complained while the national crisis hung over us, but we must work a readjustment for stabilized and prosperous peace."

"It is good that our producing interests are diversified. In that lies our great strength as a nation. The manufacturing centers and the food producing areas complement and supplement each other. There is not and there must be no conflict between them. There is a disposition of some to inveigh against one or another, as selfish interests may suggest, but the broad national welfare contemplates no east and no west, no north and no south."

"I rejoice to recall that when the great world war summoned our sons to duty and to death, perhaps, there was no question about geography. By cultivating the spirit of friendliness, by a recognition of interdependence, the problems of life are made much easier for all. There is a growing tendency to look to government for all remedies, forgetting there are natural laws that will operate to correct evils, if given a fair chance. Oftentimes well-meaning laws defeat the very object they are designed to accomplish."

"Our country holds out opportunity to rest upon the supreme condition that those who would avail themselves of that opportunity shall be entirely worthy and know and accept fully the spirit of American institutions."

Baker Will Be Candidate for Re-election This Fall

PORTLAND, Ore., July 31.—George L. Baker, mayor of Portland, today announced his candidacy for re-election next November, in response to a petition of several hundred citizens in which he had been requested to reconsider his previously announced decision not again to become a candidate. Thus far no other candidate for the office has announced himself.

RAIN QUENCHES FIRE

FREEWATER, Ore., July 31.—Reports today from Lincoln Mountain, in the district near here, where a forest fire had been raging for several days past, were that rain had extinguished the flames, thus bringing relief to a force of men who had been vainly combating its progress. According to the report ten acres of green timber were burned over.

German Theaters Hit by Heavy Luxury Tax

BERLIN, July 29.—Taxation amounting to something like 55 per cent of gross revenue and heavy running expenses are responsible for the recent closing down of 60 first-class theaters in Germany. Many theatrical and operatic companies are said to be in sore financial straits. Few people can afford to pay for the higher priced seats at the present increased rates, and the moving picture houses, with their popular prices, are reaping the benefit.

The manager of the Reinhardt concern which controls the three most important Berlin theaters, states that the latest "luxury" tax alone takes more than 20 per cent of the box office receipts. Boxes and stalls are now rarely booked. The Kapp revolution week, he said, caused the concern a loss of 750,000 marks.

Director Barnowsky of the Lessing theater, the home of the drama in Berlin, told a Tagesspiegel representative that the German stage is passing through a most critical period. Theatrical budgets, he said, can no longer be balanced. The greatest menace, he said, was "Americanism" by which, he explained, he meant "art for amusement's sake; not for art's sake."

RUSSIAN COURTESY

George T. Page, president of the American Bar association, at a dinner in New York was telling of some of the differences between Russia and this country, and added that Russians, as a nation, did not like Americans.

"This fact is particularly noticeable," he said, "when American actors have played on Russian stages. I recall a friend of mine who took his company to Petrograd. He put on a capital performance, but the audience was decidedly cold."

"After it was over, he felt very badly and as an old stage hand tried to comfort him, he said: 'Never mind, Mr. Blatz. That is the way they always treat Americans. Why even if you had been good, they would not have applauded you.'"
