Bohemian Club Stages Annual Outdoor Play

BOHEMIAN GROVE, Cal., July 23.—California redwoods were as scenery level bit of ground was the stage and a hillside provided seats for the audience at the presentation here tonight by members of the Bohemian club of San Francisco of "Ilya of Murom," taken this year for the club's annual grove play.

Presentation of the play came at the end of the Bohemian club's yearly Midsummer Jinks held in the club grove here on the banks of the Russian river. The jinks opened two weeks ago and was attended only by members, many of whom spent the fortnight in camp here.

Dedication of a new pipe organ, built for use in the grove, opened the fortnight. The organ is to remain here throughout the year and will be housed during the nights and winter in a concrete building, electrically heated to keep out the forest damp.

Following the dedication came presentation July 17 of the club's annual "Creation of Care" a playlet depicting Bohemia's triumph over care. This was followed by a vaudeville Low Jinks. Last Sunday the club band gave a concert and on Friday was held the annual grove dinner and the Friday night camp fire entertainment. Tomorrow will come a Sunday morning concert, a touch of song before the camp closes.

"Ilya of Murom," presented tonight, is a folk lore story of Little Russia, written by Charles Caldwell Dobie. Leading parts were taken by Dion Holm, William Rainey, William Homley and Ben Purrington. Ulderico Warcelli, a San Francisco orchestra leader, composed the music for the piece. Reginald Travers was director. The author, composer, director and actors are members of the club.

Big Mob Storms Jail and Lynches Negro

CENTER, Texas, Aug. 2.—A mob of more than 1000 men today stormed the county jail, battered down the steel doors, wrecked a steel cell and took out Lige Daniels, a negro, charged with the murder of a white woman, and hanged him to an oak tree in the court house yard.

The lynching followed an announcement by officers of a confession made by the negro to the grand jury and also to the district attorney.

The wife of a farmer was brutally attacked and later found unconscious near her home Thursday night. Her skull was crushed and her body bruised. She was brought to a local sanitarium, dying Friday.

Captain V. P. Bridgess, commanding Company L, 7th cavalry received instructions from Austin to protect the prisoner, but was unable to find any members of his company in time for mobilization.

HILLMAN PLEADS NOT GUILTY

SAN FRANCISCO, Aug. 2.—C. D. Hillman, Pasadena capitalist, pleaded not guilty to charges of grand larceny and conspiracy preferred against him as a result of the alleged swindling of Edward Wineman of San Luis Obispo out of \$300,000, when arraigned here today in superior court. His case was continued until September 7 upon motion of his attorney. The case of D. J. Walsh, who, with Kay McKay, is also charged in the indictment, was continued a month.

OBNOXIOUS LAW TO BE REPEALED

Objection Made to Truck Parking Ordinance Recently Passed in City

The city ordinance which was passed at the council meeting two weeks ago pertaining to the parking of motor trucks on the streets of Salem was rendered inoperative last night when the marshal was instructed not to enforce the ordinance. It prohibits the parking of trucks on the business streets.

Councilman R. W. Simeral brought the matter before the assembled councilmen when he moved reconsideration of the ordinance, advancing the argument that the regulation for the parking of motor trucks as passed operates as a hardship on the small draying concerns that have only one truck, and as a favor for the larger transfer companies because the latter have established offices on the main streets of Salem with attractive signboards. Mr. Simeral said the small truck owners depend for their trade by establishing their quarters in some drug store, barber shop or store building. It was his opinion that if these individuals with only one truck are forced to park on designated side streets their business will suffer.

Upon the opinion of City Attorney B. W. Macy the matter of reconsideration was dropped until the next meeting of the city council. It was Mr. Macy's opinion that the ordinance could not legally be reconsidered after it became a law. He advised the councilmen to instruct the marshal not to enforce the ordinance until after the next meeting. His suggestion was accepted and Mr. Simeral incorporated it in a motion which has temporarily stayed operation of the ordinance.

Ordinance No. 1786, pertaining to vending on the streets of the city of Salem of merchandise, machinery, mechanical supplies and mechanical devices was passed by the city council for the third reading, making the ordinance a law.

According to City Attorney B. W. Macy this ordinance was designed to curtail the selling of mechanical devices, automobile accessories and similar supplies on the streets, or if such selling is permitted, to be governed under the articles of the ordinance and a license procured for such privilege. The vendor of articles described by this ordinance must pay a license of \$10 for one day, \$50 for one week, \$100 for one month, or \$150 for three months.

Yelling, or other unnecessary noises designed to attract the attention of passersby is prohibited under the ordinance. Also the agent who has secured a license for the sale of his goods must comply with the orders of the city marshal in regard to his conduct, and as to the street on which he may operate his stand. The fine for violation of the ordinance was fixed at not less than \$10 or more than \$100 and revocation of the license.

A resolution submitted by residents adjacent to the Oxford baseball park was read, accepted and referred to the sewer committee. The residents complained of ball players and ball fans disturbing them during ball games, alleging that many come to their homes for drinking water and for the use of their lavatories. The resolution requested that the management of the ball team have installed a water hydrant near the ball diamond.

The Capitol garage submitted a communication to the city council containing a bill for \$400, which amount the garage company claims was suffered by the firm when Liberty street was closed during the Elks convention in the city. No definite action was taken by the members of the council. Liberty street was closed so that concessions could be operated. In regard to carnival companies, it was intimated that the council meeting last night that steps are being taken to draft an ordinance prohibiting them from operating on the streets of Salem. One council member labelled the carnival concessions as a disgrace to the city.

Corporation Department Shows Gain in Business

An increase of \$84,888 in receipts of the state corporation department for the fiscal year ending June 30, this year, as compared with the previous year is noted in a statement made public yesterday by T. B. Handley, corporation commissioner. For the year from July 1, 1918, to June 30, 1919, the receipts were \$222,176.81, and for the year July 1, 1919 to June 30, 1920, the receipts were \$307,064.81.

The number of corporations filed for the two years respectively were 578 and 1055, a gain of 477. Expenses for the year just closed totaled \$18,008.95 and for the year before \$16,614.80, an increase of \$1,394.16 for the last year.

For the fiscal year 1918-1919 73

permits were issued under the blue sky law, involving \$4,373,130 in securities, and for the year 1919-1920 188 permits were issued involving \$28,457,072 in securities. Permits cancelled for various reasons during the last year numbered 64 and involved \$1,371,134 in securities, while permits refused, or applications withdrawn or indefinitely postponed numbered 21 and involved \$5,050,250 in securities.

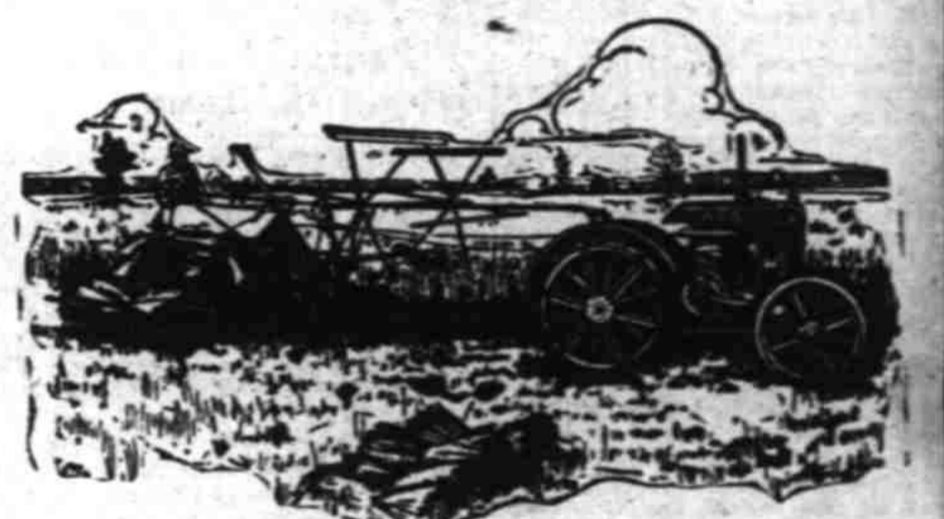
