

ROOSEVELT SAYS PARTY TRICKED

Declares Old Guard Muzzled Progressives Like Hoover and Johnson

HELENA, Mont., Aug. 18.—Charges that the "old guard" of the Republican party had muzzled progressive leaders by tricking Senator Hiram Johnson, General Leonard Wood, Herbert Hoover and others into pre-convention pledges of regularity, were made by Mr. Roosevelt, in his address here tonight.

These men down in their hearts don't want to support reaction, but while they were in the race for the nomination rumors of bolts were circulated until each was forced, in order to protect his own candidacy, to declare his adhesion to the party, whether successful or not. With these pledges in hand the bosses proceed to put over their man," Roosevelt declared.

He quoted Senator Johnson, who was successful in Montana's presidential preference primary, as saying that he "didn't have a Chinaman's chance with that gang."

Declaring that the ratification by Tennessee of the suffrage amendment, does not merely mean a Democratic victory, "we've got that all ready—but to a Democratic landslide," Roosevelt derided what he declared was Senator Harding's attitude on the suffrage issue.

"On June 24, 1915, Senator Harding told a delegation of suffragists he was 'utterly indifferent,'" Roosevelt asserted. He then charged that the Republican nominee dodged the first test vote on the suffrage amendment in the senate in October, 1915, and "only climbed onto the band wagon June 4, 1919, when it was assured that the amendment would go safely even without his support."

He renewed his attacks upon senatorial opponents of the league of nations and declared that "the Republican party itself cannot interpret either its platform or its candidate's speech of acceptance."

Roosevelt delivered four speeches in Montana today and motored more than 150 miles. He twice crossed the Rocky Mountains by car, and made the third crossing later in the evening when he took a train for Spokane, and Coeur d'Alene, Idaho, where his next speeches will be delivered tomorrow.

FRANCE IN COMPLETE ACCORD WITH COLBY

Interpreter of the feelings of the American people, desires to help the Russian people in whose future the United States retains an unshaken faith. The government of the republic associates itself unreservedly with this declaration. The French government has never altered its determination to uphold the principles so clearly formulated by the United States. It is in this spirit that it has been decided not to approve the armistice conditions offered to Poland unless they are in conformity with these principles.

Wragel True Statesman
"It is in this spirit also that, after mature examination, it has in face recognized a Russian government which declares it accepts the same principles."

"In informing your excellency of the reception given to the declarations of the American government by the French government, I am instructed by M. Millerand to notify you that the French government is happy to see the French people of the close harmony feeling which animates the French and American people when the future civilization is at stake."

"Accept, Mr. Secretary of State, the assurances of my high consideration."
(Signed) "Bearn."

Agree in Principle
The American and French governments are in agreement in principle as to the future of Poland and Russia, Secretary Colby declared today in a statement interpreting France's rejoinder to the American note to Italy. His statement accompanied publication of the translation of the French note, which was delivered to the state department August 14, by Prince de Bearn, the French charge.

Declaration Gratifying
France's declaration "of its opposition to the dismemberment of Russia," is "most gratifying," Mr. Colby said, and adds a notable declaration from every viewpoint and brings to the position taken by the United States a striking emphasis and powerful support.

Diverge on Wrangel Case
The secretary referred to France's recognition of General Wrangel in south Russia as a "divergence" between the two governments on one point, but said the United States was "disposed to regard the declared agreement of France with the principles of the United States as of significance than any divergence of policy involved in the specific action of France in this respect."

Colby Answers Soviet Note
Mr. Colby issued a reply to an assertion by Foreign Minister Tchitcherine of the soviet government that the bolshevik have shown they "strictly adhere to obligations" and that if they promised to protect the United States "against agitation of the third international, all our representatives will rigidly fulfill this pledge."

Writer Is Not "Boss"
"I do not suppose," said Mr. Colby, "Mr. Tchitcherine has supposed" Lenine as the authoritative spokesman of soviet purpose. The actual words of Lenine are in sharp contrast to the utterances of his foreign minister."

Recalls Lenine Statement
"Said Lenine before the council of the people's commissaries during negotiations on the Prinkipe conference: 'I have never hesitated to come to terms with bourgeois governments, when by so doing, I thought I could weaken the bourgeoisie.' * * * The time has come for us to conclude a second Brest-Litovsk this time with the entente. We must make peace not only with the entente, but also with Poland, Lithuania and Ukraine, and all other forces opposing us in Russia. We must be prepared to make every concession, promise and sacrifice, to entice our foes into the conclusion of this peace. We shall know that we have not betrayed our principles, but that we have completed our preparations for a decisive onslaught, which will insure our triumph."

"In the same connection, on February 2, 1919, Zinoviev, intimate associate of Lenine and Trotsky, said: 'We are willing to sign an unfavorable peace with the allies.' * * * It would only mean we should put no trust in the bit of paper we should sign. We should use the breathing space to gather our strength in order that the mere continued existence of our government would keep up with the world-wide propaganda which soviet Russia has been carrying on for more than a year."

Aim To Plant Tares
On another occasion, he is reported by Mr. Lincoln Eyre to have said: "Our propaganda system is as strong and as far reaching as ever. 'The third international' is primarily an instrument of revolution. This work will be continued, legally or illegally. The soviet government may pledge itself to refrain from propaganda abroad, but the third international, never."

Real Issue to Get Rid of Present Administration
NEWTON, Mass., Aug. 18.—The Democratic administration was arraigned by Governor Edwin P. Morrow of Kentucky, the principal speaker today at a mass meeting of the Associated Republican clubs of Massachusetts in honor of Governor Coolidge.

The real big issue in this campaign," he said, "is that we want to get rid of the Democratic administration. We have had enough of it."

Governor Coolidge, who presided, said the United States was confronted with a crisis which had its issue restoration of America "to the good graces and confidence of the nations abroad," and establishment of "an orderly government at home under the constitution."

(He paid high tribute to Senator Harding.

Senator Harding sent a personal message congratulating Massachusetts Republicans "that their distinguished governor has added so much to the strength of the Republican ticket."

BORTON CASE INVESTIGATED

McCarthy Recommends Player Be Prosecuted for Criminal Libel

LOS ANGELES, Aug. 18.—An investigation of the charges of W. Baker (Babe) Borton, former Vernon first baseman, with a view to a decision whether to act upon the suggestion of President W. H. McCarthy of the Pacific coast baseball league, that Borton be prosecuted on a charge of criminal libel, was begun here today by Edward F. Wehrle, attorney for Ed R. Maier, owner of the Vernon club.

"I shall not ask Thomas Lee Woolwine, district attorney, or any one else for a complaint against Borton unless I can obtain sufficient evidence," said Attorney Wehrle. "My time is now being used in investigating Borton's charges. I shall notify the press as soon as I conclude my investigation."

Borton, who has charged that members of last year's Vernon team collected a pool of \$2000 with which to "purchase" the club in winning the pennant, said today: "This is a particular game of checkers, it is Vernon's next move."

Pitcher Elmer Reiger, who started the 1919 season with Vernon, concluded it with Seattle and now is with Salt Lake, and who, according to Borton, was "to get \$100 for bearing down a game at Los Angeles last season," is quoted by the Los Angeles Evening Express as explaining "the \$100 he received from the Vernon players was part of the bonus money raised and voted him by the Tigers because he won games for them at the start of the season."

Reiger is out of the game temporarily with a bruised finger. He is here awaiting the arrival of Seattle next week.

Capital of Corporation Reduced to Original

NEW YORK, Aug. 18.—The capital of the United States grain corporation was reduced today from \$150,000,000 to its original \$50,000,000 at a special meeting of the board of directors, in accordance with an executive order signed by President Wilson.

FLYER FALLS IN RIVER

VANCOUVER, B. C., Aug. 18.—Hibbert B. Brenton, purchasing agent of the Union Steamship company was drowned late this afternoon when an airplane he was piloting fell into English bay. The machine was seen to execute a nose dive and then burst into flames as it fell to the water. The aviator's wife was an eye-witness of the accident. Brenton was an experienced aviator, having seen service overseas during the war as major in the Royal air force.

His two brothers were killed overseas.

GENERAL WRANGLER GAINS

CONSTANTINOPLE, Aug. 18.—An official communique issued Monday from army headquarters of General Baron Wrangel, reports further advances against Bolsheviki forces in South Russia.

The anti-Bolshevik forces claim the capture of several villages in the provinces of Taurida and the Don and the crossing of the Donetz river in this section.

Cossack troops are said to have revolted against the soviet government and joined forces with General Wrangel.

SEAPLANE SENDS S. O. S.

SAN DIEGO, Aug. 18.—Seaplane No. 8 of the fleet air detachment, which was coming from San Pedro to San Diego, was reported in distress late tonight off Del Mar, 21 miles north of San Diego. Signals calling for help were sent up and a sub-chaser was sent from the harbor. The seaplane was one of the 11 which started to San Francisco August 14.

OLYMPIC TIMBER SOLD

PORTLAND, Aug. 18.—The district forester's office of the forest service today awarded the Snow Creek Lumber company of Seattle the sale of 2,000,000 feet of timber on Snow Creek, in the Olympic national forest. The timber includes Douglas fir, western red cedar and hemlock and prices range from \$1.65 a thousand feet for Douglas fir to \$2.20 a thousand feet for cedar and 50 cents for all other species.

BIDS CALLED FOR

ROSEBURG, Or., Aug. 18.—Forest Supervisor today stated that bids have been called for in the construction of the Tiller trail road to Crater Lake. The county, state and federal governments have all made heavy appropriations for the work. The work will probably be started the first week in September and will continue throughout the winter, it was said. Most of the work will be in the rocky sections during the winter months.

Aged Editor Dies—Ill Since Democratic Convention

RICHMOND, Va., Aug. 18.—Colonel Charles E. Hasbrook, 73, editor and manager of the Richmond Times-Dispatch for the last six years, died at his residence late today of heart failure. He had been in ill health since his return from the Democratic national convention at San Francisco. Except for a few years service as collector of internal revenue in Missouri, Col. Hasbrook devoted most of his time to newspaper work, commencing under Melville E. Stone, then city editor of the Chicago Inter-Ocean. In later years Colonel Hasbrook was city editor, managing editor and finally part owner of the

YOUTH SHOT ACCIDENTALLY BY FRIEND WHEN HUNTING

MILTON, Or., Aug. 18.—Melvin Olinger, 12, was shot and killed accidentally by Mansford Brittain, another boy, while the two were hunting in the Blue mountains last Saturday, according to word brought here today. A rifle was accidentally discharged while the Brittain boy was loading it and the bullet penetrated the Olinger boy's heart.

Big Forest Fire Found in Clackamas County

PORTLAND, Ore., Aug. 18.—A forest fire covering an area of some 400 acres near Clackamas Lake, on the border between Clackamas and Washington counties, was reported to the forestry headquarters here today. A large fire which developed yesterday on the south fork of the Santiam river, in the Albany district, was being fought today. Several smaller fires also were reported in the Santiam forest. A fire which had covered 1,400 acres in the Siskiyou forest was reported under control. Several fires were burning in the Coos Bay district.

More Japanese Picture Brides Are on Way Over

SAN FRANCISCO, Aug. 18.—The United States immigration bureau here was advised today that a party of Japanese picture brides that left Kobe August 6 on the Siberia Maru, will arrive at this port August 26.

The Japanese government last December announced an embargo on "picture brides" but stated that women to whom passports had already been granted would be permitted to come to this country.

OREGON FISH LAWS ASSAILED

PORTLAND, Or., Aug. 18.—Nine fishermen of the state of Washington attacked in an action filed in the federal court here today, the Oregon law which forbids the marketing or packing in Oregon of salmon caught outside the three-mile limit at sea in the closed season. The suit is asked to declare the law void and pending decision to enjoin officers of Oregon from enforcing it. Hearing was ordered for next Monday. The law assailed was enacted by the last legislature. There is no similar law in Washington and it is alleged that fish packers of that state are given an advantage over those of Oregon because of it.

Aquatic Meet Planned at Grants Pass Friday

GRANTS PASS, Or., Aug. 17.—A program of swimming contests similar to those of last season will be staged at the city bathhouse in Riverside park, Friday evening. The program will include swimming, diving and canoe competitions. The merchants of the city have offered some valuable prizes for the various events.

The water is in the finest condition and the large flood light illumination of the river makes evening swimming very popular. The usual concert by the city band will precede the sports events.

TWO MEN HOLD UP TRAIN

ST. LOUIS, Aug. 18.—Two men held up the Missouri Pacific passenger train No. 5 from St. Louis for Little Rock on the outskirts of this city tonight and escaped with four pouches believed to have contained registered mail.

DRUNKENNESS INCREASES

BUTTE, Mont., Aug. 18.—Figures in the police court show that there were more convictions for drunkenness in that tribunal during July than in any month since Montana went dry, 20 months ago. Just 112 men and women were convicted of inebriety during that period.

PINE CONES COLLECTED

MISSOULA, Mont., Aug. 18.—Six thousand bushels of white pine cones will be collected in the Bitter Root district and several hundred bushels each of Douglas fir, spruce and larch will be gathered in the Lolo forests by officials of the forest service nursery at Stevens near Haugen, Mont., to be used in reforestation work. The forest service has its own extraction mills which will take the seeds from the cones.

"TOURIST CROP" PAYS

VANCOUVER, B. C., Aug. 18.—Twenty million dollars is the estimated value of the "tourist crop" in British Columbia this year, according to calculations made by J. Reginald Davison, publicity commissioner for the city. He said calculations are figured on a very conservative basis.

At least a third of this sum is figured as having come to the city of Vancouver so that it is doubtful if any industry in the city, not excluding lumber and shipbuilding, puts as much money into circulation in the city as the tourist "industry," according to Mr. Davison.

SHIPPING FINISHED PRODUCT

BANDON, Or., Aug. 17.—Short lengths of white cedar ready to ship direct to Japan are to be turned out by a small sawmill to be established here by the Pacific Exports company. Finished lumber will mean a considerable saving in freight rates to the Orient.

BUILD NEW WAREHOUSE

PORTLAND, Aug. 17.—Work has begun on the \$110,000 warehouse to be erected here for the Chevrolet Motor company. This plant will be the largest distributing headquarters for the cars.

WILL PREPARE CHART

PORTLAND, Aug. 17.—Charting of wood-using industries of the United States is to be one of the first steps to be taken in the educational campaign to increase the market for northwestern lumber and its products. The report, which will be of great value in this state, will be completed in 90 days.

APPLE OUTLOOK BRIGHT

HOOD RIVER, Aug. 17.—Estimates on the apple crop for this year have taken another jump in the last two weeks and it is now thought the harvest will be 65 per cent of the one in 1919. Fruit of unusually good quality is being looked forward to and preparations are being made for heavy export business.

FIND NEW GOLD VEIN

GOLD HILL, Or., Aug. 17.—Deep down in the diggings of the old Sylvanite mines a hitherto untouched body of rich gold ore has been uncovered in such quantity that the future stability of the group is assured. The precious mineral was found at a depth of over 500 feet, and yields from \$20 to \$50 to the ton.

EXPORT RECORDS BROKEN

PORTLAND, Or., Aug. 18.—All export records in the history of this city were broken last month when the total valuation of commodities sent to foreign ports during July reached \$8,023,999 or a gain of 296 per cent over the same period last year. Wheat, flour and lumber accounted for the greater share of this.

HARRISBURG HAS GOOD CROP

HARRISBURG, Aug. 18.—A crop of small grain yielding 20 per cent better than last year is being looked forward to by farmers in this vicinity. First reports from threshing machines show 50 bushels of fall oats to the acre and 18 bushels of wheat.

TRAFFIC OFFICE OPENED

PORTLAND, Aug. 16.—With a view to greater trade expansion for Oregon the joint traffic bureau of the port of Portland and commission of public docks has opened a permanent office in New York. The port also has a traffic representative touring the far east and is soon to appoint another to cover the North China field.

AERO CLUBS AMALGAMATE

NEW YORK, Aug. 16.—Amalgamation of the Aero Club of America and the American Flying club, was agreed on tonight at separate meetings of the organizations. It will be known as the Aero Club of America.
