

NIGHT SESSION NECESSARY FOR TARIFF DEBATE

Rule Limits Amendments on Floor to Hides, Oil, Cotton, Asphalt and Dyes—Vote Set for July 21.

DEMOCRATS FIGHT TO CURTAIL ACT

Attack on Measure is Led By Representatives Garnett and Cochran

WASHINGTON, July 12.—After putting through a rule calling for a final vote on the tariff bill on July 21 and limiting amendments from the floor to hides, oil, cotton, asphalt and dyes, the house held its first night session tonight in order to accommodate the multitude of members eager to discuss it.

The rule was adopted 222 to 100, by almost a straight party vote, five Republicans from Wisconsin opposing it and three Democrats from Louisiana voting for its adoption. Republican leaders, on the face of the vote, declared the bill would be passed by substantially the same majority.

Sharp Attack Made.

Democrats made a sharp attack against the rule, declaring that by it the house would surrender its powers to the ways and means committee. Representative Garnett of Tennessee, acting Democratic whip, and Representative Bourke Cochran of New York took charge of the fight, the latter asserting that by "the gag rule method of legislation," the house had "sunk into a condition almost beneath contempt," and that it no longer was regarded by the country as a serious legislative body.

Harding Sends Letter.

A letter understood to deal with the proposed duties on oil which the president sent to Chairman Fordney became the basis of discussion today among members. Mr. Fordney admitted he had lately received a "personal letter" from the president, but declined to discuss it or reveal its purport. It was reported, however, that Mr. Harding expressed the hope that if the house saw fit to place a duty on oil, a proviso would be attached similar to that on certain kinds of lumber which would permit reciprocal agreements to be negotiated by the executive.

Three-Hour Talk Heard.

Representative Longworth of Ohio headed the Republican speakers today and talked for almost three hours on four phases of the bill: dye control, American valuation, wool and the bargaining clauses. His schemes frequently brought fire from the Democratic side.

Mr. Longworth defended the entire bill, but concentrated on an explanation of the woolen, American valuation, dye control and bargaining clauses which have been objected to by Democrats in nearly every speech thus far.

Success Predicted.

He said he believed a trial of the measure would demonstrate it to be the best tariff measure ever laid before the house and described the new wool schedule, supplanting the old schedule K, as a future asset for the country. The American valuation policy, he added, was one which should have been adopted years ago, and he was convinced it could never be more sorely needed than at present.

Reporters Not Cupids For Jack Dempsey, Pug

California Asks Harding To Revise Fruit Rates

SACRAMENTO, July 12.—A telegram sent to President Warren G. Harding by Governor W. D. Stephens appealing for a revision of transcontinental freight rates to assist California fruit and vegetable growers was made public at the office of the governor here today.

Inability of the California growers to place their products in the eastern markets, the telegram said, was causing the vegetable industry to be "slowly but surely strangled to death."

SHE HUNTS FOR LOST VESSELS



MISS LULU WARNELL, daughter of W. B. Warnell, captain of the schooner Carol A. Deering, one of twenty vessels lost at sea with their crews. It was through Miss Warnell that the Government started on an investigation into the mystery of the disappearance of these ships. The vessels literally have been wiped off the high seas and no clues left behind as to the cause of the disaster which beset the vessels.

CHURCHILL MAY BE OFFERED POST AS HEAD OF STATE NORMAL SCHOOL

It is rumored that the board of regents of Oregon Normal school will offer to J. A. Churchill, state superintendent of schools, the position of president of the normal school to succeed the late President J. H. Ackerman.

Whether Mr. Churchill would accept the position is problematical. The salaries are the same—\$4,000 a year. Mr. Churchill has for years shown a strong interest in the training work of teachers. Mr. Churchill is now in the east attending the convention of the National Education association at Des Moines. It is known that he has received offers of educational positions carrying higher salaries than he now receives as head of the Oregon schools and has rejected them because of his interest in the schools of Oregon.

ATTORNEY FOR FORD COMPANY IN EUROPE VISITS IN SALEM

To drive a Ford filver and locate Ford factories and assembling plants and agencies practically all over Europe, Palestine, Syria, Egypt, to speak to the people in Russian, Spanish, French, Italian, German and English languages, and a dozen or a score of the hinterland dialects where the sign alphabet is better than any spoken tongue, is the experience of C. A. Robertson, formerly of West Salem, promoter of Kingswood park on the west bank of the Willamette, and now home for a quiet visit.

Mr. Robertson left Salem some years ago, making the World was his sole business from the day America rose at the fight. He was assigned to headquarters service in Paris, because of his linguistic talent, and served through the end, first as an enlisted man and later with a commission. He was transferred to the Italian front early in the war, where he had the privilege of seeing the inside of the war from the Italian point of view.

Italians Are Praised.

"I honor those Italian soldiers who almost all soldiers of the whole war," he said.

The way some of those southern Italian soldiers, men reared in the rocky southland, took up their military service in the high Alps, where every inch of ground was like a dagger in their hearts, and the way they fought their way to destroy the Austrian army, almost single-handed, is one of the finest chapters in all military history. They took up the war in a fine spirit of humanitarianism. They fought it through like the demigods of legend; and then, when it was over, they said: Let us have peace; we are all brothers, and humanity is our duty from now on." Why, they brought

POSTPONING OF BONUS BILL IS SLATED TODAY

Wide Margin of Votes In Favor of Deferring Action Predicted After Speech By President.

SERIOUS CONDITION OF TREASURY SHOWN

Prolonged Attack of Program is Made by Democrat Members

WASHINGTON, July 12.—Pledges of a wide majority of votes to lay aside the soldier bonus bill were claimed by Republican leaders and conceded by opponents after President Harding, in an address to the senate today, had made formal request for temporary postponement of consideration of the measure. In making his request the president called attention to the condition of the treasury, saying that enactment of the legislation at this time would "greatly imperil the financial stability of our country."

Future Action Promised.

President Harding delivered his address before a distinguished audience. Reiterating his recognition of the obligations to care for disabled and dependent war veterans, the president said "general compensation" should be ordered upon at a time when it would be consistently possible.

"Overburdening the treasury now means positive disaster in the years immediately before us," the president declared. "Merest prudence calls out in warning."

Tax Decrease Disappoints

The president at the same time urged action on tariff and tax legislation for which the extra session was especially called. There was, he said, "confessed disappointment that so little progress has been made on readjustment and reduction of the war-time taxes." He also urged early passage of the bill to reorganize war risk and vocational training to aid former service men.

The president was applauded for almost a minute when he entered the senate chamber and again when he concluded, but the galleries and lobbies outside were crowded. In the executive's private gallery were Mrs. Harding and a party of friends and friends of General Sawyer, the president's personal physician. On the senate floor were virtually all senators in the city, scores of house members, including Representative Mondell, Republican floor leader and Attorney General Daugherty, postmaster General Hays and Secretary Davis.

Democrats Start Fight

Immediately upon the president's departure, Senator Penrose offered the Republican motion for recommittal of the bill with a promise of "further careful consideration."

Democrats rose at once in opposition. Senator Robinson, Pennsylvania, declared the motion meant "obsequies" for the bill. It would become "dead" for some years," he predicted, declaring the recommittal motion was a "shell" for senators' pledge previously to support the measure.

Two-Hour Talk Made

Another opponent of the Bonrose motion, Senator Jones, Democrat, New Mexico, speaking for two hours, declared the president's action unpardonable. No other executive, he said, had ever appeared before congress to oppose legislation, but only to advocate it.

Defense of the president was made by Senator McKim, Democrat, Utah, who said the executive's course was "proper and courageous."

The Motion was Under Uninterrupted Debate, but a Vote Tomorrow was Expected.

The message, which was also signed by R. G. Simmons, commander of the conference, followed: "Ex-service men and women of your attitude of opposition to adjustment compensation for the past years, we had to preserve for you and all America our heritage. We urge you to seriously reconsider your position and carry out America's pledge of fair play to her service men and women in the passage of the adjusted compensation bill."

Kansas Protesters

TOPEKA, Kansas, July 12.—A telegram of protest against President Harding's opposition to the readjusted compensation bill was sent to the chief executive today by Thomas A. Lee, Kansas American legion department commander and chairman of the Mississippi Valley conference of legion executives.

STENOGRAPHER FINDS LARGE CHECK BY ACCIDENT

Money Sent University of Oregon for Medical College Building at Portland

EUGENE, Or., July 12.—A check for \$113,269.50 payable to the University of Oregon, was found in the stenographer's mail by his stenographer today while running through the routine correspondence of the day.

It was from the general education board, founded by John D. Rockefeller in 1902, in full payment of the board's gift to the University of Oregon, medical school for the erection and equipment of a new building at Portland.

"As a result of the receipt of the money a like sum becomes available immediately from the state and it is possible for the board of regents to go ahead at once and let contracts for the construction of the new medical school building."

PROHIBITION ACT IS UNDER ATTACK

Elimination of Alcohol in Sickness Assailed by Lodge and Others

WASHINGTON, July 12.—Limitation by "doctor congress" of use of alcohol in sickness by physicians was assailed in the senate today by Senator Wadsworth, Republican, New York, when the Willis-Campbell measure was given another hour of debate. The senator recalled the influenza epidemic and said physicians then appealed to friends for whiskey for patients, and said:

"This is fanaticism run riot. We cannot go on in this way and retain respect for the law or the constitution."

Senator Lodge, Republican leader, characterized the legislation as "an unwarranted attack" on the medical profession and said it would imply that "every reputable doctor was a potential boot-logger."

"Such drastic legislation," he continued, "will not help enforcement, but will encourage violations."

Senator Williams, Democrat, Mississippi, said the bill, in dealing with prescription of liquor for medical purposes went beyond the 18th amendment, and Senator Knox, Republican, Pennsylvania, declared it would inject into the amendment "constructions never dreamed of" by Senator Walsh, Democrat, Montana, who defended the measure. The supreme court, he said, plainly had held that regulation of liquor prescriptions was proper.

Ingomar, Mont., Wiped Out by Fire at Night

MILES CITY, Mont., July 12.—Practically the entire business section of Ingomar was wiped out by a fire last night, which is reported to have originated in a restaurant on Main street. The damage is estimated at \$150,000, with about 50 per cent covered by insurance. Only two business buildings remain standing.

Seven Hundred Men Fight Seven California Fires

SANTA BARBARA, Cal., July 12.—Approximately 700 men were engaged tonight in combating seven forest and brush fires, burning on various parts of San Luis Obispo county, according to advices from San Luis Obispo and officials of the Santa Barbara national forest.

A few fires to estimates from San Luis Obispo, the fires, some of which have been burning since last week, had covered an area of approximately 100,000 acres, nearly all outside the national forest lands.

A few isolated farm homes and mountain cabins were said to have been destroyed but little other damage was said to have been done.

Carpentier is Offered \$35,000 to Fight Burke

NEW ORLEANS, July 12.—A New Orleans Light promoter today wired an offer of \$35,000 to Manager Descombes for Georges Carpentier to meet Martin Burke of this city, in a bout to be staged here.

What compensation should be given for a one and one-half hour sojourn in the Silverton city jail and dismissed action for alleged speeding? This is the question asked of a jury drawn yesterday in Department No. 1, circuit court.

Sam Lorenzen, Silverton garage man, is of the opinion that \$4520 will be just about the right payment for indignities which he alleges were inflicted upon him by Chief of Police Lafayette Yates and Night Patrolman Grover Yates. According to Lorenzen's complaint, he was rudely taken into custody on the night of March 8, 1921, and lodged in the Silverton "hoosegow" on a charge of unseemly conduct, the Silverton officers affirming that some of John Barleycorn's product had been absorbed by Mr. Lorenzen.

Later, the plaintiff asserts, the first charge was dismissed and then he was again arrested on a charge of exceeding the Silverton ordinances relative to auto driving in the Silverton city limits. This charge was also dismissed, according to records.

LONDON, July 12.—Harry G. Hawker, the first aviator to essay a flight across the Atlantic in an airplane, met a terrible death today while flying over Hendon field. The machine was seen descending in flames and Hawker's body was found 200 yards from the spot where the airplane fell. It was badly mutilated both by fire and the fall. One foot was severed and both legs were broken.

HARDING BID WORLD TOPIC OF DIPLOMATS

Next Armistice Day Possible Date for Gathering At Washington to Discuss Disarming of Powers.

INVITATION ACCEPTED BY ALL THE NATIONS

Whether Germany and Russia Will Sit in is Interesting Speculation

LONDON, July 12.—The disarmament conference continues to be the most prominent topic of discussion, dividing honors with the Irish peace conference. No doubt is felt in London that all the nations invited will accept, and as the French premier, M. Briand, seems already to have decided to go to Washington, it is considered all the more likely that the British prime minister will also go, always provided that the state of affairs at home at that time will permit his absence and that his health will permit him to make the trip, as there has been talk of the premier's taking a long rest in Switzerland by advice of his physicians.

Premier's Attendance Urged.

The belief prevails among the members of his entourage, however, that the premier is strongly inclined to visit America, and that Sir Auckland Geddes, the British ambassador at Washington, is pressing him to go. It is assumed that certainly that A. J. Balfour, lord president of the council, will go a delegate and probably also Admiral Lord Beatty, lord of the admiralty and Sir Leaming Worthington Evans, secretary of war.

Much interest is shown in the question as to whether Germany and Russia will be invited to send delegates and in the press comment, increasing attention is bestowed on the fact that the invitations are not confined to those powers especially interested in Pacific problems, but go also to France and Italy, which, it is hoped, will introduce the more complex problem of general disarmament, military as well as naval.

Plan Pleases Lloyd George.

The premier's statement in the house of commons yesterday welcoming President Harding's suggestion for a conference to discuss the limitation of armaments probably will be the only announcement of the attitude of Great Britain on the subject until Washington has indicated the exact nature of the proceedings for organization of the conference and other details through the customary diplomatic channels.

Pending conclusion of these arrangements, Downing street officials declared today that it was (Continued on page 3)
