40 PER CENT OF STUDENTS MEN

Registration at Willamette University So Far Shows Total of 390

Forty per cent of registrations for the fall term of Willamette university are men, according to the records of registration compiled at the close of the second day.

On Monday, the first day of registration, 108 men registered and 174 women. On Tuesday the registration was 63 women and 45 men. This gives the total 237 women and 153 men who have registered in the two days, or a total of 390.

With this total registration for the first two days much larger than any former year, it is now thought that the estimate of a total enrollment of 500 for the fall and winter terms will be fulfilled.

A number of students registered from other states than the northwest. From Liberty, Mont., and several from Idaho. Miss Minna L. Harding, dean of Lausanne hall, reports that all accommodations are reserved with the exception of one. That was at the close of the registration yesterday.

Although regular instruction will begin tomorrow, registration will be attended to as usual in Waller hall.

Standard Oil Offers Reward for Murderer

A reward of \$1000 is being offered by the Standard Oil company of California for information leading to the arrest and conviction of the unknown assassin who shot and killed C. W. Upton, a station salesman of the company, stationed at Turlock, Cal., on September 3.

Upton was killed while returning home from his station about 10 o'clock at night in the company of his wife and another woman. The murderer sprang from concealment and opened fire from the side of the state highway near Turlock.

Loan Applications Come At Rate of 400 Every Day

Applications from ex-service men who want to take advantage of the bonus law are coming in at the rate of from 400 to 500 a day, according to Captain H. C. Brumbaugh, secretary of the World war veterans' state aid commission.

Up to last week they were received at the rate of about 350 a day.

Those wanting to take advantage of farm or home loans are still in the majority, as the total up to last night was 2,794 applications of which 1,834 applied for cash and 1,960 for farm or home loans.

Those asking for cash will have their applications sent to the secretary of state in order that should they have received state educational aid, the amount paid them will be deducted from the amount due.

Ex-service men who have applied for loans on real estate will receive special real estate loan blanks in about three weeks, Captain Brumbaugh said.
