Body of Baby is Found at Edge of River

BOYS FIND REMAINS WRAPPED IN PAPER NEAR COUNTY BRIDGE

The age-old story of shame that is stronger than love or even than life, is the basis of a pitiful little tragedy that came to light Thursday afternoon.

Two boys fishing at the foot of the inter-county bridge, sent word to the police department that they had found the body of a tiny infant there at the river bank. The police hurried to the place, to find an infant, not mature, that the boys had brought to the shelving bank of the river. The tiny creature would not have seen the light of day, in a normal way, for possibly 10 weeks.

The tiny body had been wrapped, apparently, in a newspaper, and in all probability thrown from the bridge overhead. It was just below the sewer, and could possibly have come from there, though it was not considered likely.

There is no clue to the identity of those who brought the little body to the place.

JOE FUREY REALLY DEAD; BODY DUG UP FOR IDENTIFICATION

SAN FRANCISCO, Aug. 10.—Doubt as to whether Joe Furey, nationally known swindler, actually died in the penitentiary at Fort Worth, Texas, and was interred here, when the body in question was exhumed and found to answer minutely Furey's description.

Furey's finger prints, in the possession of the police, tallied with those of the dead man, the police said.

On account of Furey's faculty for posing as dead in the past, only to appear and bother the police at some distance from the point of his faked demise, District Attorney Woolwine of Los Angeles, where certain charges are pending against the swindler, wanted to make sure and asked that the body here be exhumed.

Three police detectives, newspapermen and others attended the exhuming today. Exhaustive identification records of authority tallied exactly with those of the dead man.

CHICAGO, Aug. 10.—(By The Associated Press)—Edward Schillo, widely known automobile race driver and Roy J. Keller, former service and automobile man were killed tonight when an airplane piloted by Keller plunged into the streets of Naperville, about 30 miles from Chicago.

DALLAS MAN IS INJURED IN TUMBLE

J. M. Farley Thrown From Runningboard of Truck and Head Hits Hard Road

DALLAS, Ore., Aug. 10. (Special to The Statesman)—J. M. Farley, a prominent prune grower of this city, was quite badly injured late yesterday afternoon when he fell from the running board of an automobile truck, striking the back of his head on the hard road.

The injured man was assisting in repairing a rural telephone near his prune orchard west of town when the accident happened. He was brought to this city, where his injuries were treated.

At first it was thought his skull was fractured, but later reports are to the effect that he was only badly shaken up. He is much improved today and is expected to be about again within a few days.

CAMP GRANT IS ON FIRE

Blaze Threatens Destruction of All Buildings; Starts At Hospital

ROCKFORD, Ill., Aug. 10.—A fire which threatened complete destruction of all buildings in the heart of Camp Grant broke out in the old base hospital area about 9 o'clock tonight and is spreading rapidly.

All Camp Grant fire companies and half the Rockford city department is fighting the blaze. Several men have received minor injuries and burns.

Six buildings of the hospital are now consumed and the fire is spreading.

SPOKANE, Wash., Aug. 10.—Declaring himself in favor of the Columbia basin project and a soldier's adjusted compensation, Fred Schane, Spokane realty man, today announced he had forwarded to the secretary of state at Olympia his declaration of candidacy for the Democratic nomination as congressman from the fifth district.

Mr. Schane also announced himself as in favor of a government controlled merchant marine, retention of the Volstead act, and protection for organized labor.

Alleged Woman Burglar Will be Tried in Eugene

EUGENE, Ore., Aug. 10.—Kathryn Estelle Emmons, who was arrested in Los Angeles Wednesday, will be brought to Eugene to be tried on a charge of burglary, according to an announcement today by Sheriff Fred Stickle.

Mrs. Emmons is accused of complicity in a number of burglaries committed in Eugene a year ago, also in the theft of two automobiles.

Two youths implicated in the crimes pleaded guilty and are now serving time in the Oregon penitentiary.

NO SURRENDER IS POLICY OF ROAD LEADERS

Western and Southern Railway Executives Do Not Take Kindly to Proposal of President Harding.

UNION DISINTEGRATING IS BELIEF EXPRESSED

Pacific Coast Representatives Not to Reach Washington Until Late

NEW YORK, Aug. 10.—(By the Associated Press.)—As western and southern transportation managers began to arrive for the session tomorrow of the Association of Railway Executives to pass on President Harding's new rail peace plan, indications were that the "no surrender" policy voiced by L. F. Tore, chairman of the eastern conference, was fast gaining momentum.

A concerted effort of the eastern men to strengthen their position was seen in informal conferences at which the newly arriving officials were guests of local executives.

Chiefs Secretly Closeted

The first conference was held at the Association of Railway Executives' board rooms where 25 rail chiefs were secretly closeted for several hours. Those who attended the meetings asserted they were held merely to talk over the president's latest plan and to enable recognized leaders to canvass conditions on roads which had resulted from the first seven weeks of the shop crafts strike.

Officials of southern and western roads were the first to arrive of the 200 representatives of class 1 roads which are expected to be represented when tomorrow's conference, termed the most momentous in transportation history—is called at the Grand Central terminal.

Coast Men Are Late

Each train brings others from states farther distant. The last of the delegates, coming from Pacific coast states, may not reach New York until tomorrow.

The subterranean drifting of sentiment against acceptance of President Harding's proposal, which until today seemed to be confined to a few of the more belligerent eastern roads, now appears to dominate among the executives here for the conference.

Operators Think Strike Lost

Their attitude is that the shop craftsmen already have lost the strike and that, by accepting the strike leaders' challenge to "a fight to the finish" their shop forces soon will be recruited to normal strength and the power of the union disintegrated.

Southern and western roads, however, are not faring so well. It is frankly admitted, because most of their shops are situated far from the big centers where non-union forces are most easily recruited to replace the strikers. Their representatives came here prepared to vote for acceptance of Mr. Harding's plan, it was understood.

Terrific Explosion

ASHEVILLE, N. C., Aug. 10.—A terrific explosion occurred tonight near the shanty cars at the Southern railway depot here, which have housed railway employees since the shopmen's strike. The extent of the damage could not be ascertained immediately after the explosion.

Later an explosion was reported in the Southern railway yards here.

Warning Note Sounded

A note of warning against defiance of the law was sounded by George W. Wickersham, former United States attorney general, in an address at a luncheon attended by Mr. Taft, Mr. Coolidge and other notables here for the bar convention.

People Not Informed

MORE POWER FOR JUDGES TAFT'S PLEA

Former President Tells American Bar Association of Method to Avoid Failures of Justice.

REFORMING LEGAL PROCEDURE URGED

Vice President Coolidge is Speaker Before Session in San Francisco

SAN FRANCISCO, Aug. 10.—More power given to federal judges will prevent many failures of justice, Chief Justice Taft told the American Bar association convention today, while other speakers declared that justice cannot prevail unless the people rely on the courts.

Mr. Taft's recommendation that plans for reforming legal procedure be worked out through a committee composed of two judges, each of the federal supreme, circuit and district courts and three leading American practitioners of law, was accepted in a resolution of endorsement.

Law Respect Urged

The convention also went on record in favor of the creation of a bureau to promote understanding and respect for American ideals and for the constitution, as recommended by a committee on American ideals.

Vice President Calvin Coolidge was a speaker before the night session of the convention, declaring that the time had come to supplement the appeal to the law which he said must be a limited one, with an appeal to the spirit of the people which he declared to be unlimited.

National Character Sound

"No reliance upon the national character ever has been betrayed," said the vice president, "but our countrymen must remember that they have and can have no independence save themselves. Our institutions are their institutions, our government their government, our laws are their laws."

Both the committee on American ideals and Mr. Coolidge denounced the proposal to give congress power to make valid by enactment a law declared unconstitutional by the supreme court, saying it would deprive the people of the protection of the constitution and subject them to the will of two-thirds of a legislative body, endangering freedom of speech and action.

HYDRO-ELECTRIC PLANT PROJECTED

Fleishacker Announces Outlay of \$4,000,000 in Portland

PORTLAND, Aug. 10.—Expenditure of approximately \$4,000,000 in the construction of giant hydro-electric plant to serve the Northwestern Electric company, was announced today by Herbert Fleishacker, president of the company.

Within 60 or 90 days the definite location of the plant will be decided upon and work will commence shortly afterward, according to the San Francisco capitalist, banker and lumberman, who arrived in Portland today.

Three sites are under consideration, Fleishacker said. He added that he was not at liberty to name them, but that engineers of the company were making a thorough and exhaustive study of the situation and would reach a decision within two or three months.
