EYERLY WINS IN MEDFORD EVENT

Major Andrae's Car Goes Through Fence, Knocking Down Water Tank

Lee Eyerly returned late Tuesday night from Medford where he had come to enter in the Jackson county fair auto races.

He had two cars, the Ross Special, owned by Eyerly and Hoyer, and the Watt Special, owned by Major Andrae of Salem. The Watt car was making a great run, under the pilotage of a driver from California when a break in the steering mechanism sent it through the fence, to crash into a water tank—the only obstruction anywhere around the mile and one-eighth track—and the falling of the tank with its load of spectators, came near filling the hospitals with human wrecks.

The Ross car, driven by Eyerly, won the big professional event, Eyerly driving the 50 laps of 5 1/4 miles, in 53 minutes, on a dirt track. Eyerly estimates that the track is fully one-eighth faster than the Salem dirt track. The turns are heavily banked, and safe for a speed that would be suicidal at the state fair grounds. The Andrae car was not seriously damaged, Eyerly driving it as far as Albany on Tuesday, and stopping there only because it was stripped down for racing and had no lights to make it legal to drive after dark.

Billy Gardeau Offered Place on Milkaukie Card

Billy Gardeau, who is set Jack Davis as a top-flier in the Salem boxing show, Sept. 28, was offered a place in the semi-final in the Milwaukee show, next Tuesday night, with Eddie Richards, who beat Fred Hall in Salem, last spring. He wanted to take it on, for the Milwaukee shows have been showing high class. He phoned to Salem to ask what the company's box manager thought about it, and they objected, so the Boise battler does not appear on the Milwaukee program.

Gardeau will be in Salem, Monday, to finish his training, and give the local fans a chance to look him over again.

Kid Byers and Oliver Martin, and lefty Wharton and Sid Newton, of Independence, are expected to put on two good preliminaries. The Wharton-Newton bout especially should be good. Wharton is a south-paw with a puzzling style, and Newton has been getting "em regularly wherever he appears. He is rated as a fast, game lad.

The program is set for Portland night during the state fair, and the biggest crowd ever known for any similar event in Salem, is confidently expected by the promoters.

National Rifle Matches Will Be Started Today

CAMP PERAZ, O., Sept. 20.—The National Rifle association matches closed today with all events completed on schedule time. The national matches will be started tomorrow with the national individual rifle match as the first event. The national matches will continue until September 28.

The infantry team match, final rifle event on the National Rifle association matches program, was won by the United States infantry team with a total score of 14,638.

STAYTON TO GET Y CONVENTION

Annual Hi-Y Conference to Be Held at Silverton Some Time in October

With representative present from Corvallis, Woodburn, Stayton, Hubbard, Turner and Salem, the county committee of the Marion county Y. M. C. A. set its machinery in motion for another year's activities at a meeting in the Salem "Y" Wednesday night.

Reports on the work of the past year and prospects for the year ahead were presented from the various communities in which the county organization is now operating and a summary of conditions affecting the "Y" work throughout Oregon and the nation was presented by John H. Rudd, state secretary for country work and for nearly a year executive secretary in charge of the work in Marion county.

An invitation presented by O. V. White to hold the annual county convention at Stayton this year was unanimously accepted by the county committee. The convention will be held some time in October, the exact date and the program details being left in the hands of the local committee.

It was also decided to hold the annual Hi-Y conference at Silverton this year, the date being fixed at some time in October with the definite time to be decided by the local committee.

Those present from outside of Salem were John H. Rudd of Portland; L. L. Hierschberger, Lee Byers and O. W. Payne of Hubbard; A. E. Austin of Woodburn; F. J. Dietrich, A. M. Byrd and Alton Byrd of Gervais; and O. V. White and W. A. Weddel of Stayton.

A luncheon in the dining room of the "Y" preceded the regular business session of the committee which was presided over by L. J. Chapin.

It is remarked in French circles that the participation of Japan insures another vote for British policy in any issue which may arise in the conference. M. Poincare is consenting to the presence of Japan, demanded also the presence of Rumania and Jugoslavia.

Would Welcome U. S.

While the United States was not included among the eight countries to participate, it is regarded as certain that a mere ultimatum from the American government that it desires to attend, even as an observer, will be followed by an instant invitation from the allies.

Lord Curzon, M. Poincare and Count Sforza were in complete accord that there should be no war in the Near East, but Lord Curzon asserted that Great Britain felt that the presence of a strong fleet in the straits was necessary to maintain freedom of passage.

While insisting on what they term their legitimate claims to eastern Thrace, Adrianople and Constantinople, the Turks are understood to have informed M. Poincare that they would consent to remain masters of Asia Minor until the conference had given consideration to these other claims.

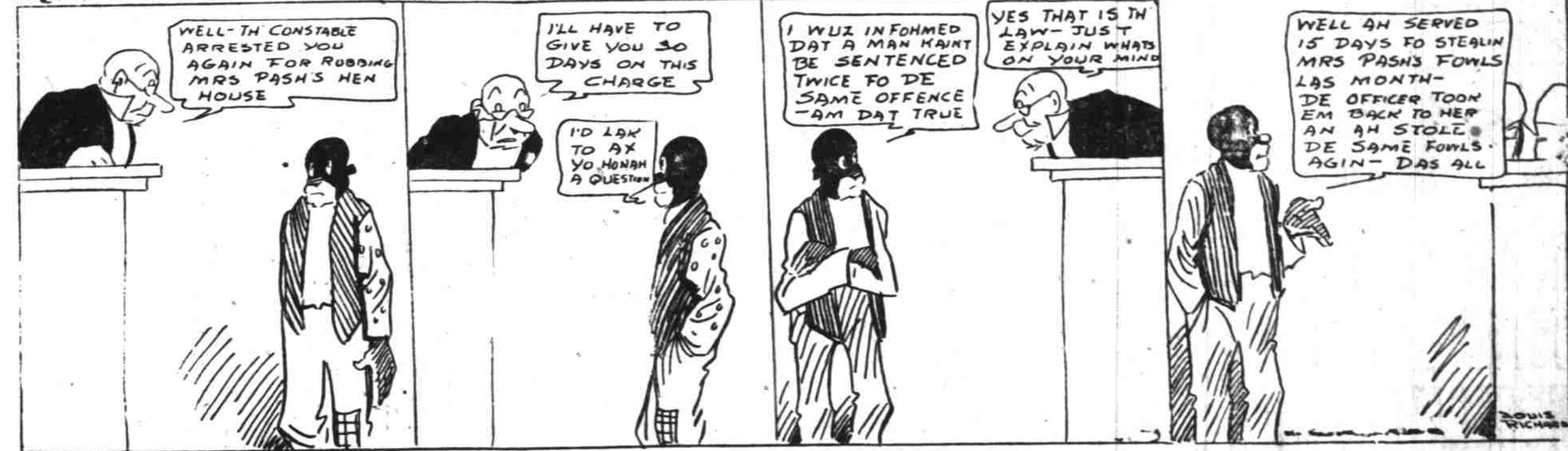
French officials are confident tonight of a complete agreement with Great Britain when the allied meeting resumes on Friday, and it is freely predicted that the British troops will retire.

On the other hand, late tonight, in reply to a question, it was authoritatively stated in British quarters that the British troops were not in danger at Chanak, which gave rise to the report that they might remain there with the tacit approval of the Turks.

Italy, on the advisability of convening a peace conference, little has become known of today's developments in the Near East crisis. The sudden and unexpected call for a ministerial conference in London this afternoon which led to a formal council, caused renewed alarms concerning possible critical developments, but these were allayed later, when although no official communication was issued throwing light on the origin of the sudden conference, it was intimated that the situation instead of having undergone a change for the worse might be considered much easier.

The assumption is that the council considered the projected peace conference and M. Poincare's explicit statements that under no circumstances would French soldiers be employed against the Kemalists.

Expect Invasion

Evidence that the British government has apprehensions that Kemal Pasha may attempt to invade the neutral zone is found in the anxiety the government displays to make clear that the Greeks at no time have been within the Chanak neutral zone.

This statement reveals the desire to prove that Kemal has no valid excuse to violate the neutral zone. That this anxiety is not misplaced is indicated in new dispatches from the Associated Press correspondent today that a government hand in the present crisis and the report current in Constantinople that the Kemalists are preparing for an attempt on the straits before the end of the present week and before Great Britain is able to get up reinforcements.

Defense in Injunction Hearing Ends Testimony

CHICAGO, Sept. 20.—(By the Associated Press.)—The government's suit for a nation-wide injunction against the striking railroad shop crafts will be decided by tomorrow night, a few hours before the temporary restraining order now in force expires. This became evident today when the defense closed its case and opening arguments were begun.

The government has quite completed the draft of the injunction which it will ask Judge H. Wilkerson to sign, but there are indications that some of the drastic clauses of the restraining order will be modified.

A nation-wide strike, by the sheer power of its extent, is in itself a conspiracy against interstate traffic, Mr. Esterline contended in his opening statement.

Harding Requests Aid. WASHINGTON, Sept. 20.—An emergency appropriation of \$200,000 for relief of American refugees in the Near East was recommended to the senate today by President Harding after receipt of an official estimate from the state department that 1,000 Americans were in pressing need of assistance.

COUNTY NURSE PLAN GIVEN SUPPORT OF NORTH SALEM IMPROVEMENT ASSOCIATION

Oregon Statesman: I note that the county nurse question is up again, hence I am enclosing resolutions adopted by the North Salem Improvement association at the time the subject was under discussion before, as they still seem pertinent.

Whereas the Oregon Tuberculosis association has paid all expenses of a public health nurse in Marion county for six months in order to demonstrate the value of this service, now established in 15 other counties and

Whereas, in the Highland school and community we have had concrete evidence of the real value of this service, and

Whereas, this nurse has in six months examined 7917 children for communicable diseases, and given 136 school talks and organized 91 health crusades similar to that in Highland, and has examined physically 1563 children, and has found 248 defects requiring attention, including 501 cases of bad teeth, 503 with throat troubles, 232 with eye diseases and a long list of other defects that slowly but surely undermine health and working efficiency and in the ripe results of time collect their certain toll of premature death and great loss to the community; and

Whereas, scientific preventive medicine and hygiene through public health service is incomparably less costly to the taxpayers of the community than the enormous totals of cash individually paid to physicians, trained nurses, hospitals and patent medicine concerns by panic stricken sick people or their relatives trying to have cured what should have been prevented, perhaps far back in their childhood; and

Whereas, the prevention of a single serious school epidemic of measles, or scarlet fever, typhoid fever or diphtheria will usually save the community affected more than the entire cost of the public health nurse for the year, at the present rate of \$127 per month for salary and about \$75 for traveling expenses.

Therefore, be it resolved that the county court be requested to use every effort to maintain the service established by the Tuberculosis association, not necessarily by increase of taxes, but by diversion of funds or readjusting salaries, or some such sound business method of avoiding the sacrifice of an essential and vital community service for other service of less importance.

Be it further resolved that copies of these resolutions be submitted to the Salem Commercial club with a request to reconsider their action in this matter, and to all other civic organizations of the city, and to the federated community clubs of the county.

TURKISH WOMEN DRAW DRESS LINE

Movement to Compel Women to Wear Uniform Dress Causes Much Hostility

CONSTANTINOPLE, Sept. 20. (By mail.)—Some optimistic and determined Turks are attempting to persuade the women of the land to adopt a standard form of dress. Optimistic, because Turkish women seem no more inclined to wear a uniform than would their sisters of London, Paris, and New York, and determined because the committee de la mode is thinking of calling upon the police for help in carrying out its plans.

"Where are the women who would consent to have imposed upon them an antique and strange costume found today only in museums?" is one of the questions hurled at the reformers. "Where is the woman who would recommend such a costume to another?
